Law Related to why State and hence Federal Government has No Sovereign Delegation of Authority, that means our consent:

The unanimous Declaration of the thirteen united States of America [No consent = no just powers]

“--That to secure these rights, Governments are instituted among Men, deriving their just powers from the consent of the governed, --”

Cruden v. Neale 2 N.C. 338 (N.C. Super. 1796) [Sovereign delegation of authority = consent]

“...every man is independent of all laws, except those prescribed by nature. He is not (339) bound by any institutions formed by his fellowmen without his consent.”

Chisholm v. Georgia, 2 Dall. 419, 471 (1793) [Sovereigns bound State governments]

“... "We the people of the United States, do ordain and establish this Constitution." Here we see the people acting as sovereigns of the whole country, and, in the language of sovereignty, establishing a Constitution by which it was their will that the State overnments should be bound, ...”

Constitution for The United States of America, Article VI, Cl. 2 [Judges in every State are bound]

“This Constitution, and the Laws of the United States which shall be made in Pursuance thereof; ... shall be the supreme Law of the Land; and the Judges in every State shall be bound thereby, any Thing in the Constitution or Laws of any state to the Contrary notwithstanding.”

Constitution of The United States of America, Article I § 10, Cl. 1 [no State gold and silver coin = no just powers or consent]

“No State shall ... make any Thing but gold and silver Coin a Tender in Payment of Debts; ...”

Cohens v. Virginia, 6 Wheat. 264, 404 (1821) [to usurp = treason to the Constitution]

“We [Judges] have no more right to decline the exercise of jurisdiction which is given than to usurp that which is not given. The one or the other would be treason to the Constitution.”

Norton v. Shelby County, 118 U.S. 425, 449 (1886) [No office exists without Delegation of Authority]

“Where no office legally exists, the pretended officer is merely a usurper, to whose acts no validity can be attached, ...”

Twining v. New Jersey, 211 U.S. 78, 98 (1908) [US citizens are not Sovereigns and not We the People]

“The right of trial by jury in civil cases, guaranteed by the 7th Amendment, and the right to bear arms, guaranteed by the 2d Amendment, have been distinctly held not to be privileges and immunities of citizens of the United States, guaranteed by the 14th Amendment against abridgment by the states, and in effect the same decision was made in respect of the guaranty against prosecution, except by indictment of a grand jury, contained in the 5th Amendment (99) and in respect of the right to be confronted with witnesses, contained in the 6th Amendment..., and the trial by jury, guaranteed by the 6th Amendment, were not privileges and immunities of citizens of the United States, as those words were used in the 14th Amendment.”

United States v. Throckmorton, 98 U.S. 61, 64 (1878) [Fraud voids EVERYTHING]

“There is no question of the general doctrine that fraud vitiates the most solemn contracts, documents, and even judgments.”
