
Process for validating a <u>new</u> proposal



Nevada validation process for a new proposal

This validation process will encompass all new decisions being made by The Nevada General Assembly (NGA). This validation process will **not** be associated with the election process for positional seating of American State Citizens (ASC's).

Decisions that need to have the approval of The NGA shall be proposed and supported by a committee. Any such proposal that needs to be validated by The NGA shall be emailed to the members of The Nevada Assembly (TNA) prior to the announcement of said proposal at the following NGA meeting.

The sponsoring committee will announce that information has been sent to each member of TNA for review of a particular item that needs NGA approval.

There will be a seven to ten (7-10) day allotment for review of said proposal by TNA. The first of this 7-10 day allotment will begin on the day after the announcement of said proposal at the NGA meeting. All feedback regarding the proposal from TNA members can be emailed to the sponsoring committee and be received by said committee no later than midnight on the seventh day post announcement of said proposal.

The sponsoring committee will announce the day and time that a public meeting will be held to share and review TNA feedback. The members of TNA will be invited to attend this meeting. This meeting will be held approximately fourteen (14) days after the announcement of said proposal. This allows a seven day review period of TNA feedback.

The proposal is now in a status of general concurrence or in need of modification. If modifications need to be made, a new proposal shall be sent out via email to TNA members for review.

The proposal will now be sent out via email to TNA members asking them to accept or reject said proposal. All TNA members are given the opportunity to respond to this proposal via email and have their voices heard. Email recipients will be given seven (7) days to respond before the validity quantification of said proposal is closed out for the determination.

The greater number of validations cast (yay versus nay) of The NGA validating participants will decide whether to validated or to not validate. E.g.:15 yay's would prevail over 14 nay's.

Agreeing to a proposal that needs validation would be signified by yay.

Disagreeing with a proposal in need of validation would be signified by **nay**.

By casting a validation of **abstain** you signify that you are aware of the proposal yet choose to remain neutral on the topic.

Announcements of proposals needing validation **must** be done at the NGA meetings in addition to email notification being sent out to all TNA members.

A special purpose meeting can be called in order to conduct such business if the matter is time sensitive and urgent.

Each individual can cast their choice via email to the committee chair with a subject line of "Validation of XXX".

All validations shall be entered into the validation log once the final determination (yay/nay/abstain) has been solidified.

Decorum of The Nevada Assembly

We, the people of The Nevada Assembly (TNA), hold these guidelines of Decorum for all of our Assemblies and Committee meetings;

We are capable of accomplishing our priority;

We are discussing the serious future of Nevadans and building The Nevada Assembly to align with our mission;

We, Nevadans, treat each other with respect;

We meet face to face as a community, whether in body or in virtual space, as neighbors, familiar with each other, to one common goal;

We listen to opinions and ideas, in the spirit of free speech, with willingness to consider the merits and comprehend concepts;

We establish an order and mutual manor for the recognition of Assembly members;

All members, when joining online meetings, must have their name appearing on their profile;

All members must raise their hand or state "May i" to be recognized by the Chairman/Coordinator/Moderator/MaA or Committee Chair;

We will approach discussion with proper spirit and language;

We, the people of TNA, cooperate with each other to achieve our ultimate goal, the reconstruction of our lawful government.

Breaking Decorum and Disciplinary Measures

The Nevada Assembly procedure to maintain peace:

Outbursts, rancor or rancor in the 'Chat', that interrupts the business and peace of any meeting within The Nevada Assembly will not be tolerated and will be met with the following procedure:

- 1) The Marshal-At-Arms/Moderator will first mute the participant and warn them of their behavior.
- 2) The Marshal-At-Arms/Moderator will, upon a second occurrence, remove the participant to a 'Breakout' Room or physical room for a discussion. The Marshal-At Arms/Moderator determines if the participant may be returned to The Assembly meeting or if removal is required for the duration of the meeting. If any of us fail to conduct ourselves in a manner consistent with the values of Self-governance, we will be given the opportunity to correct the mistake. In this way, we help each other to both keep the peace, and to uphold the Public Law. To this end, the Ombudsman are here to provide us with assistance and guidance. If needed, the Assembly will provide additional assistance; and where necessary, fair, and just consequences for inappropriate behavior.

- 3) If upon subsequent meetings the Participant cannot control their behavior and follow decorum the Participant may, upon the vote of The Nevada General Assembly, be subject to the following discipline:
 - "the member/participant" shall be allowed to attend upcoming assembly meetings with the stipulation that for the next two (2) meetings he or she shall not be allowed to speak and must remain silent during all meeting proceedings. All voting rights shall remain in effect and shall not be infringed upon.
 - 3 months Censure, meaning they may not speak/comment on any meeting, including Committee Meetings. They also suffer the loss of internal issue vote for said time period. This is to give the man or woman time to attend and listen to the meetings in the hope that they will learn the decorum and comprehend the business/process and resume as a productive participant.
 - -6- months censure may be given for additional breeches of decorum or egregious breeches of decorum, especially in international settings that disrupt the business of The Nevada Assembly or damages the reputation of TNA, its Officials and or Officers.
 - One (1) year and one (1)day suspension may be given for continued breeches and repeated rancorous behaviors that interrupt the business of TNA or damages the reputation of TNA.
 - It is the desire of TNA to keep the peace and maintain a decorum in the spirit of cooperation and mutual respect.
