Criminal Incident Reports

The following criminal incident reports are being filed concerning parties in Nevada that are blocking the state from being stood up, and we must have our four pillars stood up in order to receive funds, that is straight from Anna Von Reitz. Our Claim to our inheritance is to fund ourselves to provide governmental services or manage those we contract with and afford ourselves a lifestyle commensurate to enjoy our natural rights.

- ;demoralizing, antagonistic, and dishonorable deceptive practices,
- ;plagerism, fraud/trespass
- ;racketeering, co-conspiring, funnel building and echo chambers denied right of
- Of meeting in public, and approvals only sanctioned by funnel approval of trespass, fraud
- ;adulterating the voting process in meeting venues, fraud
- ;unauthorized absentia voting and arbitrary voting deadlines, fraud
- ;jurisdictional acts performed out of bounds, with malice and intent to harm-trespass
- ;Dual citizenship- fraud and gross breach of trust
- ;attempt to deny assembly right to produce an income-trespass
- ;Violation of Prudent Man Rule-trespass
- ; Gross negligence and breach of trust with malicious intent to harm
- ; Unlawful use of contract to coerce agreement to be muted in any assembly meeting since no other form is offered, no presentation of chat form public or private messaging and MAA denial of participants both overt and covert, the assembly did not authorize the coordinator to use public meeting time for story hour/training when there is important business to be discussed
- ;False witness under pretense of safety or other excuses is fraud and trespass

State Secret Meeting Monday 3/3/2025-PKTF

Noone in Clark County received a link to the March 4 call with Boyd Adams form State Coordinator, therefore **Sue Hulsebus conducted a secret meeting by denying the right of public meeting with Boyd Adams** on March 3, 2025. By not inviting others.

State Secret Meeting Wednesday 3/5/2025-State Meeting

Many people have had interference getting bumped off calls from the state, being muted, and not being able to speak, including Eric Heyer Nye County Coordinator as evidenced by a private meeting in which Doug & Sue had a secret meeting on the State Call with over 30 witnesses present who were muted and

had entered the call with a preprogrammed message (unconsented and unauthorized tacit agreement from the meeting runner, Doug Hulsebus) posted that stated members are entering a call in which they would remain muted.

This violates all and every tenet of the right to a republican government and denied the Assembly the opportunity to vote on any state business and offer an opportunity to be confronted about The Vote of No Confidence taken in the previous March Clark County meeting regarding the activities of State Coordinator.

Further, the MAA made a move that is a breach of trust of the Assembly by conducting a private meeting then claimed they couldn't hear Eric when in fact they had cut him off.

Further, using story hour as an excuse to deny the assembly the opportunity to conduct business by reading from a manual is also an insult to the assembly members. The newest assembly members who thought they were being helped are actually being harmed

; since State Coordinator cherry picks certain information to make it sound as if The State needs to be stood up first when in fact The County needs to build simultaneously. In the video from Peacekeeping Task Force say at least one county need to be standing with state

; since the State Coordinator choose story hour over accepting motions to be voted on to build the 4 pillars and reconstruct our lawful government,

; since the State Coordinator is a federation coordinator, she believes she is untouchable and by refusing to step down she is fomenting chaos by denying the Assembly to redress her behaviors within the forum of public meeting,

; since the State Coordinator made an illegal offer to contract 2/28/2025 with the Assembly's unanimously approved and voted on Coordinator Rockie Roper and also defamed and slandered the nominated candidate by fraudulently stating on a vetting report full of opinions and wrote that Rockie Roper had criminal violations "**that could not be verified**" is defamation of his character, slander and it is all fraud since Sue Hulsebus cannot even be on the vetting committee and had no right and no business publishing, even to Rockie, that her opinions from an unauthorized vetting did to meet the minimum qualifications of a vetting interview: The vetting report needed to be shown to the people to make a vote on the fact of the vetting report.

-Vetting is required to be done in person or a video call in which vetting committee ask questions of the candidate to clear up any questions on the vetting report.

-That it follows the federation 5 question vetting form (which it did not)

-that the SC questions based on a legitimate report of this Rockie Roper at his address with his age and profile matched was in fact the Rockie Roper who State Coordinator claimed to maybe have a criminal record

-That the authentic William Rockie Roper had a concealed carry permit just 2 years ago and let in expire because it is a de-facto registration and therefore, all their claims are illegitimate since Rockie could not possess such credential - besides the fact it was a lie to discredit him with the Assembly with false claims

Therefore, the consensus of the Clark county Assembly with 27 members present was that their No Vote Confidence is further sustained by all the past 7 days of the SC.

Shallon's Militia State Report

Shallon gave us a background info on his property that he is totally off grid and has a full mechanical repair shop, welding and his father was an engineer. Shallon believes that the most significant and highest priority of the militia is to mentally be prepared for what is coming in a self-reliance community that shores up the mental preparedness to support to all other militia pillars for disaster preparation, family, common defense, emergency services, natural health, sustainability, food storage, training, networking, and support of ourselves to self govern and overcome our challenges.

American Way Homeschool Event will have a quick update and needs volunteers.

Rockie purchased 200 usb drives upon which he will load all the information on our website including peace proclamation documents, flash cards to be determined by committee, coloring pages, meaning of our flag, the AVR book and so forth. Besides the home school event, Denise is designing business cards that will have our QR code on them so people can reach our homeschool materials easily.

Denise reiterated we are not trying to build a whole curriculum at this time, this is an evolution project/program and we have also secured www.AmericanWayHomeschool.com and org

Currently AWH has two outreach vectors in 2 modes. One vector is local and National distribution, the other one is events and online access. Business cards are currently being designed for our event April 19 at Sam's Town containing their own unique QR code –as we roll this out to adults and children it will be our impactful recruiting tool normalizing our rescue mission peace movement to assist all and every living man to reclaim their inheritance, thus supporting our lawful government.

The State has still never created a link to the County and the county will not link the state for the following reasons:

- The State website has not been updated in 4 years except to add a few pictures at the top at Denise's suggestion last October.

- Denise was blocked from making suggestions about the stale State website because the State Coordinator doesn't believe it needed any improvement even though Denise offered to assist with improvements last October, so we prioritized building our County.

- The website is necessary for the elections since a county website is a sanctioned announcement publication for elections which we are hosting very soon and the nominations and posted roles must be advertised for 30-90 days cost thousands in a regular newspaper. We know from the vetting video that websites are absolutely approved to be publishing resources. Denise offered to present the many uses of a website to the State last fall/winter but they did not want to know anything about it, which is so perplexing, but yet just one more reason why TCCNVA decided in the November meeting on 11/10/2024 that a website is necessary and by consensus approved it.

- The current State information isn't actionable and the State Coordinator has taken control of Coordinator@nevadaassembly.org so all newcomers are being funneled to her and then she is indoctrinating them and also denying them right to assemble in their county by withholding the county assembly information.

-Jennifer Polson sent Denise a State sanctioned meme to place on the TCCNVA website from the state sanctioned outreach box of state sanctioned marketing materials but Denise doesn't have any budget for designing this meme at this time and so it will remain in the que.
