Updated Business Meeting Agenda Items

This meeting is called because the people are owed a republican form of government. This is going to be your chance to speak up and determine how your government is getting organized.

- 1. No confidence vote based on evidence and ongoing chaos by Sue Hulsebus, dependant of Doug, creating controls by weaponizing the assembly and all meetings. We have documented that no paperwork showing Sue was vetted by the Federation. The only vetting papers of Sue is from the vetting committee with Shane being the chairman and he was not vetted by anyone. No one signed his vetting approval. Anna Von Reitz in a call Feb 13,2025 told family members creating discord in Nevada to step down and she asked us to tell them that and we did on Feb 16,2025. His Fire Department role was not disclosed in his vetting, and neither was the fact he works for Big Pharma. Also Doug was vetted by now retired firefighter Shane, a non-vetted person. - 3. 
Rockie's Response:
