Those who are employed by the Federal Government or the Federated State of State Government should, generally speaking, be participating in their own District Assembly, and while they are welcome as State Nationals to attend public meetings of the State Assembly and share their opinions about in-State issues, they are not eligible to function as State Citizens and are not eligible to vote on or influence interstate decision-making until they retire or otherwise sever their obligations to the Federal Government.

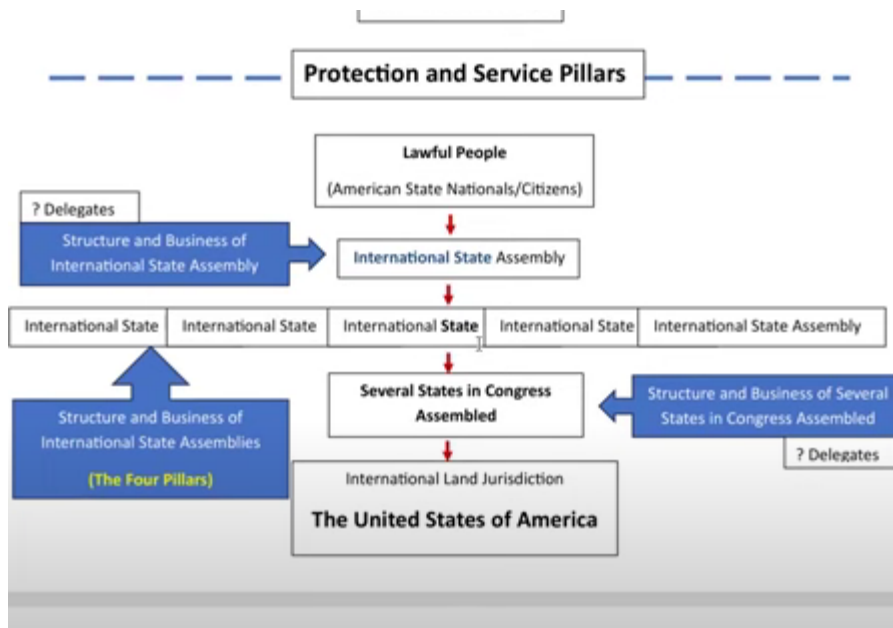
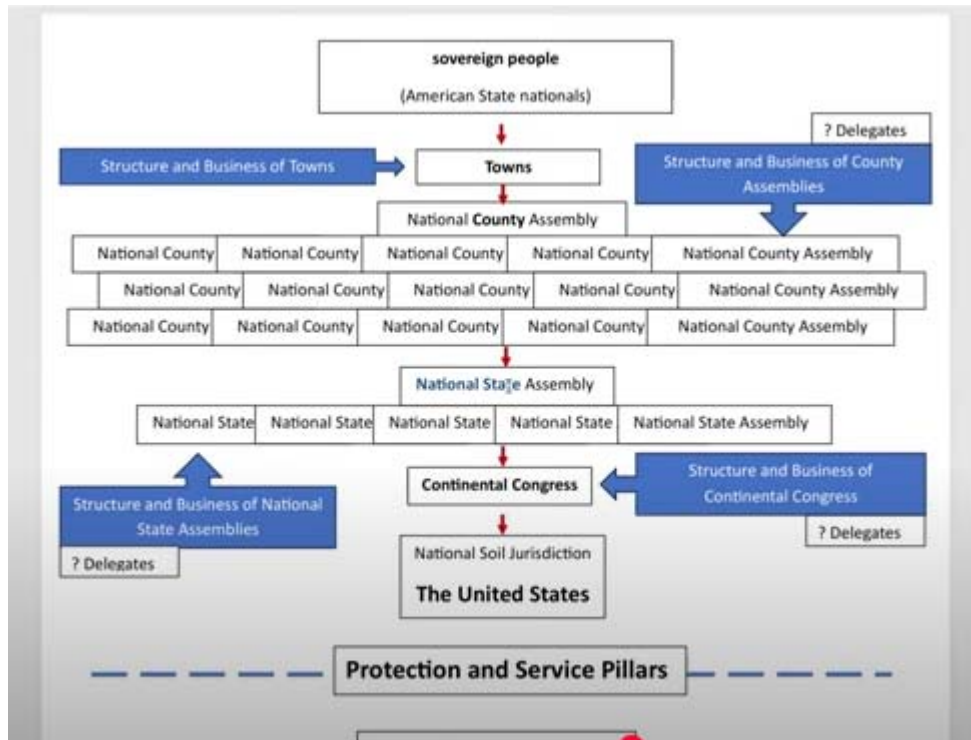

- 1) Seating your County Assembly is important to provide services for our Americans on the County and all the power rests in the People.
- 2) One County will be chosen in each state and one county will be seated with the State. The state Compositions with vetting are changing the coordinator. State officiates/appointees will be on County then also State.
- 3) County Assemblies that have strong positive indicators are the County hitting the milestones of Outreach, Pillar building, events, banking and governmental recognition, such as de-facto recognizing us.
