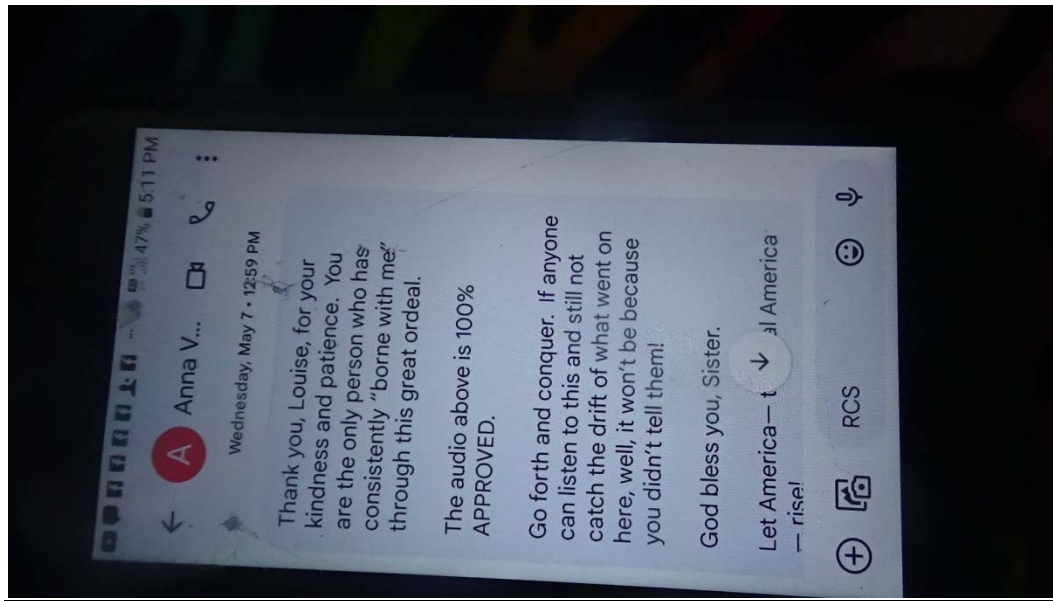
Strategy Task Force Session and Model County Sundays 2pm Sunday 5/18/2025

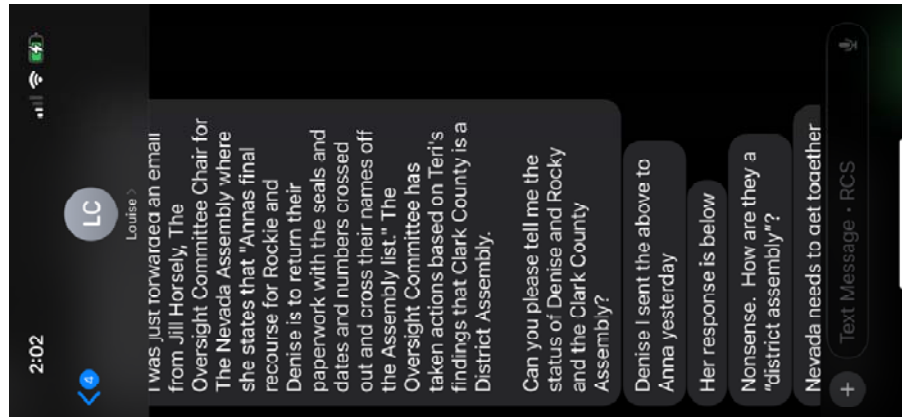

The Nevada Assembly State Oversight Committee run by chairwoman Jill Horsley exceeded her jurisdiction, and committing fraud on all assembly members publishing false information concerning Rockie and Denise which slandered them and the Assembly, confused ASN and undermined their good work and public trust. This is being addressed by PKTF and also the committee members will be receiving notices concerning their conduct, fraud and trespass on The Clark County Assembly,

and Rockie Roper and Denise Mraz.

What's in your Travel Packet? Indemnity Bond Body cam 928s Case Law. The sheriff mentioned showing your passport card if you have one, so you avoid contracting with LEO. You may also give them a copy of your fee schedule. Anything they ask you for, do not consent. Cooperate with showing an ID.
