I have described our relationship with the Federal Subcontractors as a two-lane road. What you are describing is in their lane and they have developed it for their people and their purposes. We don't approve of it and will continue to develop our side of the road and our banking system for our living people to use.

We are not suggesting that we wish to have a monopoly ourselves — just that we are not in favor of the QFS in the role of a coercive monopoly.

The people of this planet deserve safe, simple, private banking options that are not micro-managed by “government” corporations and interfered with by ANY transfer monopoly.

For a sane and healthy world, we need to maintain our ability to freely trade for goods and services and to use our traditional land-based commercial banks to conduct commerce. Not be forced to “switch lanes” and act as British Subjects simply to live and conduct our own business.

QES and QFS may have valid uses in the jurisdictions “on the other side of road”, but we don't like the attempts to monopolize banking services and coerce and cajole participation under conditions that surrender the rights and freedom we are owed.

The banking needs of average people are not the banking needs of corporations. Neither should the trade and commerce functions of living people be subject to the regulations imposed on foreign corporations operating in maritime commerce.

Congress does have a role in regulating “interstate commerce” but the intention of that regulatory authority is to expedite the free flow of such interstate commercial activity and prevent such horrors as tariffs applied by one State of the Union against another State of the Union.

There is nothing in our history to suggest that the framers of the Constitution intended for any Federal Subcontractor to “redefine” Lawful Persons as Legal Persons and use this as a means to regulate the form of commerce we may participate in — resulting in a limitation of the flow of interstate commerce instead of its expansion, artificially subjecting us to the foreign law that

governs “the other lane”, and creating a self-interested monopoly interest in and control over both public and what should be private commercial transactions.

- 6) Please indicate if you would like to participate and that request will be routed to the vetting committee, demonstrate that you meet the eligibility requirements and then you will be placed on the next agenda for consideration

All positions except Coordinator requires a Jural Assembly Member Agreement & 928. No vetting is required for committee members, only committee chairs, vetting only needed for elected roles. All non elected roles are nomination/acceptance by Regular County Assembly. Any man or woman that wants to stand up and help coordinate the state or a county needs to stand up and say so. Coordinators are not elected by the Assembly. You just stand up and say you want to help by being a coordinator. After you complete the vetting you are excepted.
