Global Family Group Business Package- we need volunteers!

This is two projects:

- A) Establish a <u>new Business System</u> which is based on AFD and has a GFG presence.
- B) <u>Existing Business System</u> adds/incorporates AFD and GFG and continues normal operations.
- A) & B) Outreach is formulating a Business Conversion Program that names the business on GFG thru an ASN, Establishes an AFD channel for the business, demonstrates how to deal with the bank, how to handle

employees, and employee benefits, tax advisement, insurance and bonding, licensing, regulatory agencies .

This uses and deploys Prosperity Union funds and uses Prosperity Accounts. This is a natural "come along side" progression of raising awareness.

Precious metals are fluctuating so market pricing based on value will be a valueadded system.

c) <u>Loan to Grant Program</u> – Humanitarian Projects with milestones met and outlined to exceed agreed expectations of loan request participants.
