Key Terms to Understand the Peacekeepers and Law Enforcement Reference Guide

Political Statuses	
U.S. Citizen	The Definitive Treaty of Peace 1783 that ended the Revolutionary War described the "citizens" as "Inhabitants" --British subject, an inhabitant "residing" here, for the purpose of providing essential government services (Article IV) - (a) those born in the District of Columbia, Guam, Puerto Rico or what we consider the "Territories and Possessions"; (b) federal civilian employees; (c)federal military personnel on active duty; (d) federal welfare recipients; (e) elected officers of the federal and federalized "state of state" corporations; (f) political asylum seekers; (g) African Americans who were never accorded their State National status
citizen of the United States	A federal franchise corporation
United States National	All U.S. Citizens are U.S. Nationals, but not all U.S. Nationals are U.S. Citizens. U.S. Nationals also include those born in American Samoa and Swains Island.
American State National	The Definitive Treaty of Peace 1783 that ended the Revolutionary War described state national as the free, sovereign, and independent people of the United States
American State Citizen	An American State National who divested himself of his sovereignty to serve as an elected officer in the American government.
American National	Born in American Samoa and Swains Island
Foreign National	Citizens from other countries residing here in America
Foreign Sovereign	The native-born people on one of the several states of America are free and independent sovereigns and foreign to the U.S. government
Foreign Sovereign Immunities Act	Foreign Sovereign Immunities Act, Sections 1605 and 1607 – foreign states are exempt from jurisdiction of U.S. Courts

The United States	The United States, Unincorporated, established July 4, 1776 by The Unanimous Declaration of Independence
The United States of America	The United States of America, Unincorporated, established September 9, 1776 by The Unanimous Declaration of Independence
the United States	The Roman Municipal government subcontracted by the American Government to provide essential governmental services enumerated in the Constitution of the United States of 1790 who incorporated in 1855, also THE UNITED STATES
the United States of America	The British Territorial U.S. government subcontracted by the American Government to provide essential governmental services enumerated in the Constitution of the United States of America of 1789 who incorporated in 1810, also THE UNITED STATES OF AMERICA

Compact	States of the Union are formed by social compact under a Declaration of sovereign people.??
Constitutions	Constitutions are service contracts to provide governmental services agreed to between American State Citizens as the employers, and their employees, the British Monarch, implementing the concessions agreed to under Treaty of Paris and Roman Papacy, under the Treaty of Westminster and Treaty of Ghent.
Treaties	Treaties are the peace agreements that end wars declared and fought between countries not corporations

Mercenary conflict	conflicts, euphemistically regarded as wars, waged between commercial corporations who hire trained soldiers as mercenaries to battle each over the securing of stolen properties to gain profit margin over the other
