## Project Objectives

1. “Go Public” as The Federation of States of “50-in-full-force,” (a slogan coined for this project to capture the sentiment of our end resolve), and take our place on the world stage as the rightful sovereign American Government.
2. Rescue every American from sea and air jurisdictions and bring them back home to the land and soil jurisdictions by placing their Declarations of Political Status on the public record while educating them along the way.
3. Demand the capitulation of our Territorial and Municipal United States Government Subcontractors to transfer the governance of America back into the control of the Sovereign American Government in full recognition as their Employers.
4. Recoup the skilled American workforce or manpower to run our American government services for the people with competence and retrain them according to the Public Law.
5. Allocate office space in our public government buildings, initially our State Capitol buildings and Court houses, from which to run our American government services.
6. Require performance on a wide, one-fail-swoop list of demands from the United States Territorial and Municipal government officials to align their de facto governance with their respective contracted services as agreed and to implement those “legal” remedies as stipulated in their Statutes and Codes to be provided to us that allowed them to legalize their crimes. This will quickly give the people systemic remedy in masse.
7. Keep the Territorial and Municipal United States Government Subcontractors in place and require them to continue to provide services with zero-sum transactions or they pay the expenses out of their own coffers not ours, until and unless, they peacefully transfer America’s governance back into the hands of Americans.
8. Lawfully end the revolving door of criminal bankruptcy fraud and commercial fraud of corporations on our land and soil via our special concurrent General Jurisdiction over all LAW capacity.
9. Convene a Continental Congress to review the Constitutions, i.e. Contracts, for the consideration of termination or renegotiation and to decide on new leadership involving the election of “The” President of “The” United States of America and/or appointing a Head of State successor.

## Project Background

### **Email Blast Announcement by Think Tank Coordinator, Tammy Healy on June 2, 2024**

VOLUNTEERS NEEDED! Our Nationwide Outreach Think Tank has adopted and is helping to develop a new initiative called **“The 1776 Union Restored” Countrywide/Nationwide Outreach Project**. It was initiated and

developed by an American State National (Louise Campbell-Anthony) who is making a grassroots effort to propel the restoration of our de jure American government forward to full function in a strategic, collaborative and expedient fashion. She also initiated it to rescue our fellow Americans from bonded servitude to the foreign United States government and from their ignorance. She proposes it to be a “Union” effort, meaning from the soil level jurisdiction, to posture our American government to take to the world stage and to engage “we, the people” in our self-governance.

We are inviting all State Assemblies and State Nationals to participate. Below is a description of the Project’s phases. When this Project was initially presented to Anna, Louise asked her if she could do this in the name of the Federation. Anna approved the idea and asked to work with Louise on the Detailed Research to make sure it was up-to-date before launching: <https://rumble.com/v4gj8q8-29-february-2024-countrywide-coordinator-training-with-anna-von-reitz.html> Anna reviewed the Outline and Preface, added to what Louise had written in the Preface but has not been able to get back to it because she has got bigger fish to fry. So, some Nationals stepped up to do edits and fact checking of all the website content to take on some of that burden. We are well on our way to launching this massive Project soon. We would encourage everyone to watch Anna’s latest webinar and hear her urgency to us to get on the world stage and take our place as the only rightful American Government now Restored as the Military attempts their long-planned Federal Republic impersonation scheme. The changing of the Guards is happening right now. We can’t allow the Military to take our rightful place again. We must stand up every State and every County as quickly and as competently as we can. These years are our window of opportunity 2020-2028. Time to Up Our Game.

#### **Notes for presentation delivered at the Think Tank Meeting on June 5, 2024: Louise Campbell-Anthony**

*I want to first share with you my backstory to show you where my inspiration for my Postcard campaign came from.*

*To do that, I want to read a portion of the letter I wrote to Anna to get her authorization before attempting this.*

*February 16, 2024, I wrote: ANNA CAN I GET YOUR AUTHORIZATION FOR THIS:*

*My fight started around about the same time as yours did back in 1996 when I left the Christian Church after having earned my Bachelor’s Degree in Evangelism at Oral Roberts University and applied for pastoral ordination at my humble, community Mennonite Church. Things soon came to a halt when in my self-studies I stumbled upon all the lies I was taught by the one institution who I was supposed to be able to depend on to tell me the truth. Feeling betrayed, I continued my search to find out who is telling the truth and I found myself fighting the government lies with a group of local community activists who knew something was definitely wrong.*

*Now let me give a personal commentary here.*

*It was at this time my husband and I started shedding our skin, sort a speak, of the old paradigms that were not serving us anymore that proved to be lies.*

*We left the Ministry as Pastoral Elders of our Church and left the Christian Church altogether and went on our own spiritual journey, leaving institutional religion behind.*

*We left the public school system, pulling our 2 kids out to homeschool them. And we had a set of twins at home as well 3yrs old. So, I started homeschooling the 4 of them, but my husband remained a public school teacher.*

*We left the “healthy” food indoctrination and joined an organic food coop where food was delivered to us. We were already farming and processing our own meats and vegetables. There was 1 year that I could count on 1 hand the number of times I had visited a grocery store.*

*We left the medical indoctrination, no more hospitals, no more vaccinations for our children, and I committed to breastfeeding all of them and resorting to herbal remedies. We even decided we were going to deliver our next child at home where it was safer and not get a birth certificate for her. So, we did, right there on one summer day on our living room floor having had not 1 prenatal visit for the pregnancy. It was a liberating experience. No doctors probing me. No vaccinations. No birth certificate. Our next pregnancy was a 2<sup>nd</sup> set of twins and marriage was rockier by then with all the fronts we were fighting and relationship in flux, so we didn’t feel so sure of ourselves. So, we opted to just have a birthing plan. I didn’t put my children name on or sign their birth certificates. It was still liberating as well because my doctor sat in the corner of my delivery room and told me to let her know when I need her to step in. And that’s how my 2<sup>nd</sup> twin delivery went.*

*Back to this small group of activists, it was less than 10 of us researching and looking for a way out from under our lying government control. I spent about \$10,000 on books, seminars, court battles and on what we thought were silver bullet processes. We were doing “acceptance for value” back then too, Form 56, Claim of Life, Common Law Liens, UCC 1 Secured Party Liens, but nothing was working like the books said. We learned that they don’t play fair and don’t follow their own rules.*

*One thing this same group of less than 10, did manage to do while fighting our lying government, was to shut down our corrupt Illinois Governor George Ryan and his \$80 million dollar prison development project in our town. 2 years later Ryan was sentenced to 6 yrs. in prison for fraud and racketeering. I will tell you more about that when I explain Phase 3.*

*We were at the brink. One of us proposed to the others that we devise a plan to construct our own government structure and a way to trade using our own money. We observed that you can’t be free if you don’t control your own money. So, for me our Global Family Bank is critical to our Freedom.*

*We got as far as mapping it out, but that was it because the fighting was costing us dearly.*

*Back to my letter to Anna.*

*That cost us dearly. We lost homes, lands, jobs, cars, marriages and lots of money fighting in their courts and purchasing information on processes to try to get favorable results. A couple of us even landed in jail for some years. You know very well how this story goes. I even pulled my land patent from the BLM in 1999 but filed it away not knowing what to do with it since nothing seemed to get the results we were desperately wanting. I had to leave the battlefield scarred in 2002, but now I’m back.*

*A little more commentary...now, right today, one of the members of this less than 10 is facing a 2<sup>nd</sup> jail time for fraudulent tax filing with the IRS. 4 of the them are divorced. My husband and I lost 4 of our*

*properties due to delinquent property taxes. They were our home and 3 land properties. I believe that was a great blow to him. It took the wind out of his sails. I did eventually manage to get our house and 2 properties back but I had to let the 1 go and eventually my husband too after 30 years and 10 children. He became irredeemably abusive toward me and the children, including sexually. That's why I wounded up here in Ohio. Our last child just graduated high school this May so now I can head back home to Illinois come November.*

*Now, back to my letter to Anna.*

*I gave you my back story so you can have an idea of where my inspiration comes from.*

*We ran across your name back then too, Anna, but you hadn't gotten your "land legs" yet, as we now say. You hung in there through all your scars and you and your team have indeed cracked the code! For that, I am eternally grateful and stand in awe of your sacrifice and the progress you've made--although still ongoing and you are surprisingly still alive, and by that I mean, we know what "they" do to people like you.*

*Now back to my inspired ideas which is the main reason for me writing you.*

*That's my backstory. I continued to tell Anna what I wanted to do in this letter. You heard me publicly give Anna my commitment on our last Coordinator Call. I was willing to do that for one reason only – she has convinced me that she is committed to telling the truth. I shed myself of the liars and lying institutions. Even when I was a little girl, my sisters and brothers knew not to do anything around Louise because she will tell. They knew if our parents asked me, I would tell the truth and I would also tell on myself. So, I could lock arms and run posse with anyone who I can trust to tell me the truth. If I find out you lie to me or on me, I will need to put some distance between us.*

*I felt I needed to share that so you can know what type of person I am for those who need to vet me and question my intentions and to let you know frankly I was going to do this with or without anyone because I know what's at stake. By sending out a call for volunteers, I need to know how much committed manpower I have working with me on this Project for me to be able to calculate how high of a sacrifice that I am about to potentially pay. Another reason, I need to share that is because when you Go Public as I am describing that we do, you have to have your dirtiest secret exposed so it can't be used against you.*

*That brings me to the 6 Phase Nationwide/Countrywide Outreach Project (we are still trying to settle on a name) that I have developed and have called for Volunteers to put it into motion. When I hear Anna voicing her frustration, I feel her talking to us – telling us to up our Game and show up. She needs our back up. When the de facto is drilling her and blaming her for the American government being nowhere to be found, where can she point to and say that's them right there. Time is short. I see our window of opportunity being 2020-2028. The Changing of the Guards of World nations has already started. I saw this major shift happen in 2020. We need to rise up now.*

*This Project that I'm calling "The 1776Union Restored" Nationwide Outreach Project, is meant to be a strategic battle plan to get our State and County Assemblies standing and not just standing, but standing strong. I approach it as a grassroots effort because I know that the I hold more power than my government does and it's up to me to set the tracks down that I want them to follow.*

*Let me first give a Caveat. These are my inspirations. Phases 1 and 2 are the ones I shared with Anna in that email. Phases 3,4,5 and 6 developed later as the inspiration kept coming. So, if any of you think any*

*of this seems questionable or that it can't be allowed, please voice that at the end when I entertain questions.*

*Also, you may have your own inspirations as well and I want you to feel free sharing them. So I can see if it can be integrated to make this Project better, I want to do that. I want everything to look professional so if you see something that you think you have the skills to polish up, let me know that too.*

*I'm also going to throw this out there. I believe some of us who implement this plan will be targeted. So, consider that honestly within yourself to know what price you are willing to pay. I've included a strategy to minimize those possibilities when we launch. I will talk about that at the end.*

*I humbly and respectfully have to disagree with those who think that the de facto will listen when we have our courts up because then we will have enforcement. That's not the breed of animal they are. If we can't get them to stand down before our Courts are up, they surely not going to stand down just because our Courts are up. We have to remind ourselves that they do not play by the rules, just how many laws and policies they don't follow right now. West Virginia v. EPA and Ex Parte Milligan court cases are no different. If they don't recognize us as Nationals out of their jurisdiction right now, I'm not seeing how a flip of a switch is going to magically make it happen then. I just don't see them as that breed of animal to stand down because some Lonely County Court said so. We have to strategize with that in mind. Anna has mentioned the only one strategy that I believe will work to get the de facto to stand down. She said "public opinion" which I interpret as "public pressure."*

*The use of public pressure is how a group of less than 10 of us took on Illinois Governor George Ryan in 2000 and his State of Illinois \$80 million dollar project. If you google Governor George Ryan and Pembroke Advocates for Truth, that's who we called ourselves back then, and woman's prison, you will find Chicago Tribune articles about a protest against an 1800-bed women prison slotted for Pembroke Township to bring the much-needed economic boost to one of the poorest communities in the State of Illinois. Our town had about 4,000 people, predominantly Black. Within a year, Governor Ryan and his developer pal closed up shop and left our town. It's easier to take down a Governor than it is a President. With that in mind, observe the Military's strategy on how they took down nations. It was called Trump's Capitulation Tour. If we study it and repurpose it, we can use their own strategy against them. The strategy is the same though, it is to use their corruption as our weapon, then no shots have to be fired. That's what Trump did and that's what Pembroke Advocates for Truth did and that's what I'm proposing that we do. But you have to wield that weapon in a strategic way to take them down.*

*That's my frame of thinking in Phase 3. I would love to call it Anna's Capitulation Tour for people to readily know where the authority is coming down from. However, that may not be appropriate.*

*When you read the News articles about Pembroke Advocates for Truth and Governor George Ryan's prison development, they report 200 people protest the prison. To let you all in on the truth and the strategy we used, being less than 10 of us who realized we need more numbers to back us up. We circulated petitions and collected 200 signatures first, so we could truthfully say 200 of us. But none of them was in any of our meetings. It always was less than 10 strategizing. Nationals don't protest. We declare. Hence the reason I'm suggesting a Declaration of Independence 2.0 doc for signors to be posted on the website. So, we can point to the truth of how many it is of us Nationals while only a few of us will be in the cameras. And we can point to how many of them who did stand down by their signatures. We*

*are not interested in collecting “Concerned Citizens” signatures just declared Nationals so the general public will not be allowed to sign until they correct their political status.*

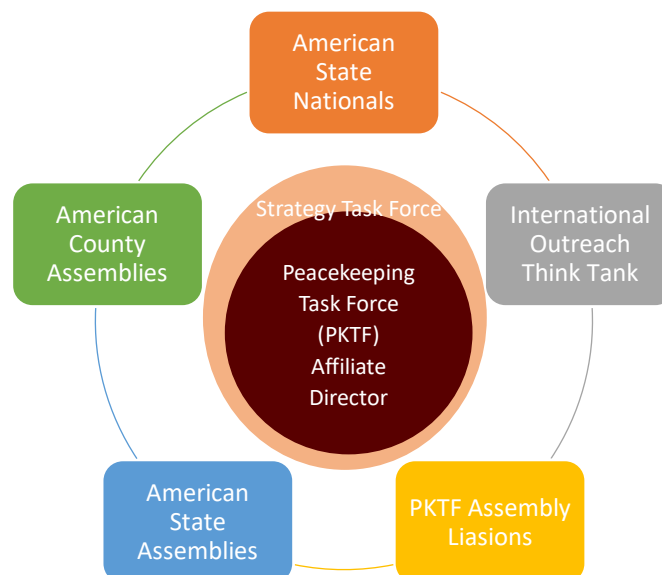
*I want to bring your attention one specific thing that has and will cause a great divide among us but must come to the forefront now. That’s the words I highlighted in yellow under Panel Discussion. It says, “Senior Field Commander.” I believe this to be the reason why Grandma is still alive. I’m going to let that just marinate in your minds to think about for now and we will come back to it when we’re ready to develop this 3-day event. I suggest you go research those people and websites and the circle of people around them to be ready to have an educated conversation when we get to planning this Phase.*

*To preempt any potential attacks on us, I want to make a request of Anna to announce each phase and set the appropriate stage for us to put up our shields when we launch them to minimize possibility of threat. As Senior Field Commander I know she has armies that we can’t see. If you haven’t quite grasped it yet, we are engaged in our 2<sup>nd</sup> revolutionary war fighting again for our Freedom not just from the Brits, but from Evil as she says. We need to realize that and mount an effective offensive and defensive strategy to take our Freedom back for America. Anna has already put us in the offensive position. The soil jurisdiction has to make strategic maneuvers to take down “their” Flag and raise ours, (which is actually ours too as we now know.) I see us as nationals trying to restore rightful government, not as de jure government trying to replace de facto government. We need to get in a grassroots mindset as “we the people” to devise the most effective strategy. We can’t wait til County Assemblies are formed. I have to respectfully and humbly disagree with that position too. We have to utilize our most powerful authority right now, Ourselves as Nationals, then our County Sheriffs, and we already have our Federation in place shielding us and guarding our walls while we do this.*

*Now on to the Project itself.*

## Project Components

### Participating Groups





**American State Nationals** – These are those declared Nationals who volunteer to work on a Think Tank Task Team to put this Project into motion and bring it into fruition. These Nationals do not serve in any capacity on their government Assemblies when participating in the Think Tank. They can come from any State. There is no specific time commitment required. This is all voluntary. They are fluid meaning they can come and go as they please. We just ask that you be a (wo)man of your word and do what you say you are going to do when you commit to a task on the Think Tank.

**International Outreach Think Tank** – The Nationwide Outreach group of declared Nationals coming from multiple State Assemblies created this Think Tank to pool together cross-Assembly resources and ideas for outreach that were working to bring Americans home to the land and soil. This group is a non-governmental organization of “loosely” organized American State nationals, meaning it’s members can come and go as they please. This group invited Louise to present her grassroots Postcard campaign idea at their meeting and, subsequently, they agreed to officially adopt the Project to assist in putting the Project into motion with the anticipation of getting State Assemblies seated in an organized way.

**Federation of States Peacekeeping Task Force (PKTF)** – A Federation of States d.b.a. The United States of America, unincorporated (1776) instrumentality responsible for providing peacekeeping services to the 50 State Assemblies and to participating Countries of the world. Upon reviewing the Project, they agreed to be the official umbrella over the Project if I would direct the Project. They also offered their task force services through their Assembly Liaisons **who will serve as the interface between our American State and County Assemblies and our de facto employees** in Phase 3.

**American State Assemblies** – The 50 American State Assemblies of The Federation of States d.b.a. The United States of America, unincorporated (1776).

**American County Assemblies** – All the soil jurisdiction County Assemblies, yet to be organized, on the 50 nation states d.b.a. The United States, unincorporated **(1776)**.

**Strategy Task Force** – This Task Force will consist of any volunteers experienced in military operations, strategizing, grassroots organizing and community activism formed for analyzing this Project’s results, investigating possible alternative strategies, and solving the issue of our American Government not being recognized by the de facto. Those who are experienced in these areas are invited to join.

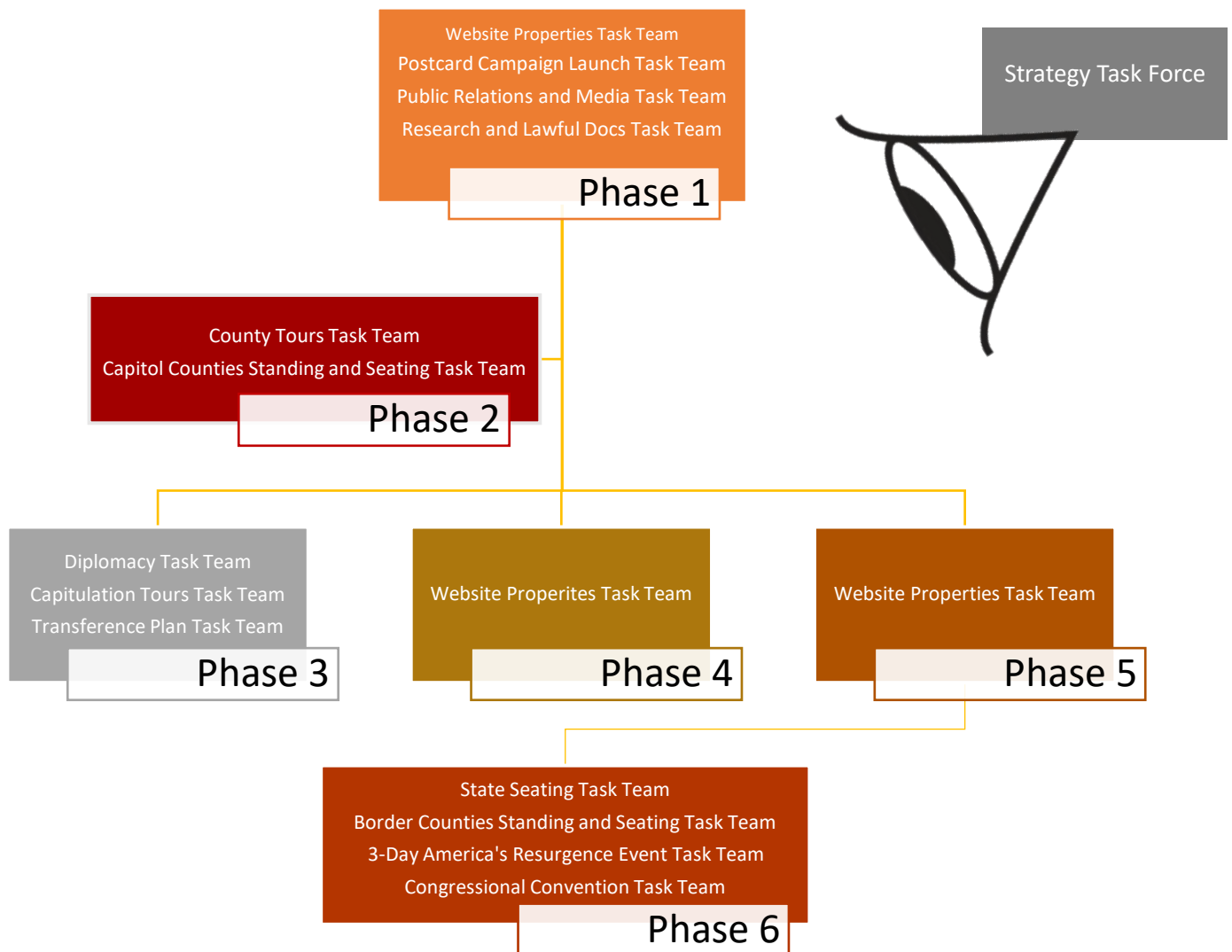

### Services Provided by the Think Tank to the Peacekeeping Task Force (PKTF)

Think Tank volunteers will be partnered up with the PKTF Assembly Liaisons who are servicing the States that are in your Postal Area. The Think Tank volunteer in collaboration with the States, the strategic “Capitol” County Assemblies and the PKTF Assembly Liaisons will provide the 10 documents in Proposal 2 listed above to those States in their assigned Postal area to effectively launch Phase 3.

### Think Tank Task Teams



Each Think Tank Task Team will be tasked with assisting the State Assemblies in implementing each of the 6 Phases of this Project. Each team will focus on particular aspects of the Project to develop it in full. Then it will provide the Think Tank with its finished documentation that we will then compile and provide to the State Assemblies to implement. We will use Reference Maps allocations as provided by the Peace Keeping Task Force to determine what states to focus on and when during Launch. Each Task Team can consist of any number of members. They will schedule regular meetings to work on their tasks outside of the monthly Think Tank meetings and report back during the monthly meeting. The PKTF Affiliate Director will communicate regularly with each Task Team throughout the week as is necessary to meet Project goals and stay within the launch timelines. The PKTF Affiliate Director will meet with the Strategy Task Force regularly to assess the progress **and effectiveness** of the Project.

### Tasks Teams Needed:

1. Website Properties Task Team – This Team will focus on developing and designing 5 websites: **claimyourinheritance.info, the1776union.tv, the1776union.com, ASNU platform and Shop platform** according to Phase 4 and Phase 5 design layouts. These properties will be the ownership of “The Union” whatever that develops to be and in the interim, ownership will be held by The Federation. The costs of this will be provided by donations. This Team will also assist with the development of **State Assembly Land Recording Office websites**. Because we already have County Recorder offices that the de facto controls, we will require they give us access to them to file our Declarations in our one-fail-swoop list of demands. Thus, I do not anticipate needing a separate recording office on the County level. This Team will focus on our Missions #1 and #2:
  1. *“Go Public” as The Federation of States of 50-in-full-force and take our place on the world stage as the rightful sovereign American Government.*
  2. *Rescue every American from sea and air jurisdictions and bring them back home to the land and soil jurisdictions by placing their Declarations of Political Status on the public record while educating them along the way.*
2. “International Public **Notice” Campaign** Launch Task Team – This Team will prepare materials for each of the 50 States with all necessary components to run a successful **Phase 1: International Public Notice Postcard Campaign** according to Phase 1 logistics. They will include: **the postcard designs; email template; public service announcement; recommended budget and printing supplier; targeted location map and population; and campaign strategy and launch schedule** for all participating State Assemblies. This Team will focus on our Missions #1 and #2:
  1. *“Go Public” as The Federation of States of 50-in-full-force and take our place on the world stage as the rightful sovereign American Government.*
  2. *Rescue every American from sea and air jurisdictions and bring them back home to the land and soil jurisdictions by placing their Declarations of Political Status on the public record while educating them along the way.*
3. Public Relations and Media Task Team – This Team will focus on **getting us in the News** – tv, radio, making press releases (use The Mission webpage), social media channels, newspapers, interviews, public speaking engagements, etc. These appearances can be scheduled for any

Federation, State or County Assembly official or Committee(wo)men. This Team will focus on our Missions #1:

1. *“Go Public” as The Federation of States of 50-in-full-force and take our place on the world stage as the rightful sovereign American Government.*
4. State Assembly County Tours Task Team – This Team will focus on preparing materials for each of the 50 States with all necessary components to run a successful **Phase 2**: “Declaring Our Independence 2.0” County Tour public meeting, primarily in the specific 50 strategic “Capitol” Counties, according to Phase 2 logistics. Identify what State Assemblies already have recorded nationals in their County that has the State Capitol building in it. They will include: **brochure, flyer; recommended budget and printing supplier; public meeting presentation; public meeting legal notice; targeted location map and population; and possible meeting locations.** This Team will focus on our Mission #2:
  2. *Rescue every American from sea and air jurisdictions and bring them back home to the land and soil jurisdictions by placing their Declarations of Political Status on the public record while educating them along the way.*
5. State Capitol Counties Standing and Seating Task Team – This Team will focus on the successful Standing Up and Seating of the County where the State Capitol is located. It will draft **2 Reference Guides: “How to Build an Assembly Reference Guide” and “How does ‘Union’ government operate on the Soil in Full Power and Capacity”?** This will be done in collaboration with the State Assembly Seating Task Team; International Public Notice Postcards Task Team; Website Properties Task Team; and State Assembly County Tours Task Team.
6. Research and Lawful Documents and Templates Task Team – This Team will focus on **compiling all the legal and lawful documents** needed to carry out Phase 3: compile all 50 original State Constitutions and subsequent State-of-State Constitutions, the 3 Federal Constitutions, Declaration of Independence 1776, Declaration of Interdependence of The United States 1937, the Municipal Codes and Legal Acts related to and supporting our One-Fail-Swoop Demands; and the Joint Sovereign Letters Patent and Federal partner agreements with the Lakota Sioux and Athabascans. They will also draft the lawful documents needed to implement this Project like the Egress Treaty for the Counties. This Team will also produce **1 Position Paper** covering Goal 1 and provide research for the Transference Plan Task Team covering the listed topics in Goal 2 below. These 2 Goals will be outlined in an official Mission 2028 public announcement that will be drafted by the PKTF Affiliate Director and The Federation Fiduciary, Anna von Reizinger. This Team will also work in collaboration with the PKTF and the State Assemblies.

**Goal 1:** Negotiate Transference of government and the Roll Out of one-fail-swoop Demands for Relief for Americans:

- Every application for government services will be a prepaid – zero sum payment transaction for them to receive that service. We have already paid for these services via Trust funds (water, sewer, electric bills, phone, etc.)

- Bank Loans (student loan, car loan, pay day loan?, home loans) - Every application for bank loans will be a prepaid – zero sum payment transaction for them to pay for these items. All current loans will be zeroed out as prepaid since your credit already paid for it.
- Property Taxes “supposedly” pays for local government services – They were already paid for by Trust funds. Discontinue Title System because our land belongs to us not the Crown and its Citizens can’t own land anyway. If the Crown want to tax his/her Citizen, it won’t be allowed via a Title system. Record your interest in the property with the Bill of Sale.
- Traffic issue – Every Secretary of State will start making Regulation Z plates. We will keep the driver’s proficiency exams services but we will not register cars only register commercial vehicles. Noncommercial car operators will be given Z plates. Prove your interest in the property with a Bill of Sale and prove that you can operate a car by passing the driving proficiency exam.
- Income tax issue - IRS/Courts - People who are jailed for income tax “whatever” get pardoned by Governor and released from prison and released from any liens on property since the IRS tax Amendment was never ratified by States. Cease taxing people’s compensations.
- MOCEE – Mutual Offset Credit Exchange Exemption - All FRNS are backed by the good faith and our credit American people. All of our bills get paid for as long as we have FRN’s and no money. Every bill gets paid to the company by Territorial/Municipal subcontractors when we identify ourselves to that company as American State National. Provide us with a bank routing number so we can provide them ourselves to these companies in lieu of our payment to get our bills paid. We are referring to those routing numbers that you use anyway right now.
- County Recorder office will accept and record our Declarations as they should. County Assemblies don’t need a recording office. They already have one that we paid for in the County Building with our Trust Funds. State Assembly will still need an LRO since there is no central LRO for a State and we are in a transference state and need to keep good records of our Nationals for their protection.
- No more birth registrations in hospitals. The parent will record births at their local County Recorder’s Office, in their Bible and/or in the local newspaper.
- Put “American” in your Databases under the category for “Citizenship” and have the system label us “Exempt” from payment of anything to receive governmental services.

**Goal 2:** Take on the responsibilities of our United States Subcontractors on the domestic and world stages to prove our competence to govern a Country. Anna stated we don’t need them anymore. To ask the Public to accept us as “the only” legitimate Government is inviting them to question our competency to govern a Country. I suggest that our American Government on Federal and State Assembly level demonstrate its competence to run the Government of this Country by developing a position and speak in an educated manner to these points to the American Public and on the world stage: (Maybe ask every Assembly to draft a written Position

paper on these Points and can add other areas where the United States government injects itself questionably onto the world stage)

- “Interregnum” – If Federation have always been operational, how did this usurpation happen? How do we know it won’t happen again?
  - War for Profit – Mercenaries are not protecting Freedom but ravaging the Planet for private corporate interests.
  - Legalized Propaganda – Institutions and Industries are used as propaganda machines to control the Public – public education, religion, science, news and social media, film and music industries (include censorship on the opposite side of spectrum as a form of propaganda)
  - Government Corruption – United States Corporations rule the world via rampant, unchecked legal, criminal rackets acting in Breach of Contract and Breach of Trust.
  - Chattel Slavery – Public Bonded slavery replaced private slavery. Human Trafficking (including US Government Galactic slave trade- Eisenhower, child sex trafficking)
  - Disclosure of Extra Terrestrials – ET colonization seeded our Planet Earth and the Galaxy and are responsible for the civilizations of Planet Earth; the civilizing of Earth inhabitants; and Earth’s current predicament of corrupt government, (include Earth Alliance, Secret Space Programs Worldwide, Disclosure, Galactic Federation of Worlds, the Bible, Ancient artifacts, War in Heaven)
  - Crime – All crime is commercial. Not under American Common law. How will we deal with crime? American Common Law is draconian. Corporations want to profit from it.
  - Money Idolatry – We are the value. The Federal Reserve Note is blood money based on bonded birth registrations; (include Wall Street and Commodity Rigging, two sets of books, real cause of inflation).
  - Companies that promote crime including legal crime recycle after a bankruptcy and the same board members boot up a new company and commit the same crimes. This is the MO of United States government subcontractors.
  - Bioweapons – Deployed and funded by our Military with and without Public Private Partnerships – Transhumanism (MRNA injections, not a vaccine, insurance fraud, social security), Wide Body Area Network (WBAN); chemtrails, fluoridated water, 5G, nanomaterials, direct energy weapons, weather modification – All attacks on life.
  - Global Trust Funds – D’Avila and St. Germain Trusts plus more - All government across the globe including the United States government have been paid to do their job so there is no need for taxes. So, what are you taxing the people for? Prosperity Accounts for all Americans. Global Trade policy.
7. Capitulation Tours Task Team - This Team will do the research on each Governor to identity the positive and/or negative pressure ammunition on that Governor and provide findings on the **Governor Worksheet** for Phase 3. This Team will work with the Transference Plan Task Team.

This Team will also work with the PKTF Assembly Liaisons and County Sheriffs in implementing Phase 3 as needed. This Team will focus on our Mission #3:

3. *Demand Capitulation of Territorial/Municipal US Government Subcontractors as service providers and transference governance to Sovereign American Government and Nationals for all non-contracted services in full recognition as their Employers.*
8. Diplomacy Task Team – This Team is will focus on assisting PKTF in implementing Phase 3 as needed. This Team will focus on our Mission #3:
3. *Demand Capitulation of Territorial/Municipal US Government Subcontractors as service providers and transference governance to Sovereign American Government and Nationals for all non-contracted services in full recognition as their Employers.*
9. Transference Plan Task Team: This Team will devise a plan to transfer the State of State Government to County Assembly Government Control. This Team will work with PKTF and the State Assemblies in developing a written **“Capitulation of Government and Transference” Plan** in collaboration with the Research and Lawful Docs Task Team covering the topics in Goal 2 above. This Team will focus on our Missions #4, #5, #6, #7 and #8:
4. *Recoup the skilled American Workforce/Manpower to run our American government services for the people with competence and retrain them according to the Public Law.*
  5. *Allocate office space in our public government buildings (Capitol building and Court houses) from which to run our American government services.*
  6. *Require performance on a wide, one-fail-swoop list of demands from the US Territorial/Municipal officials to align their de facto governance to their respective Contracted services as agreed and to implement those “legal” remedies as stipulated in their Statutes and Codes to be provided to us that allowed them to legalize their crimes. This will quickly give the people remedy in masse.*
  7. *Keep the Territorial/Municipal US Government Subcontractors in place and require them to continue to provide services with zero-sum transactions or they pay the expenses out of their own coffers not ours until and unless they peacefully transference America’s governance back into the hands of Americans.*

International Public Notice Postcards Task Team; Website Properties Task Team; and State Assembly County Tours Task Team.

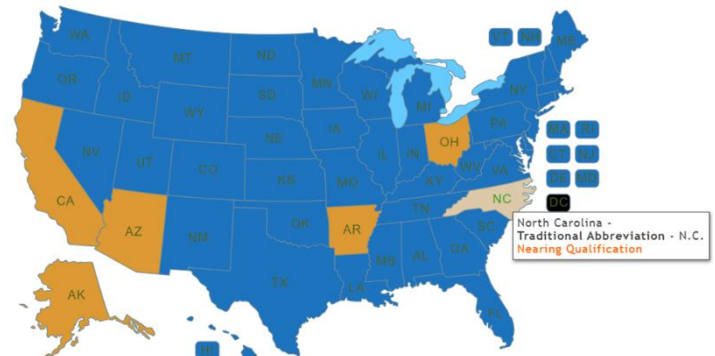

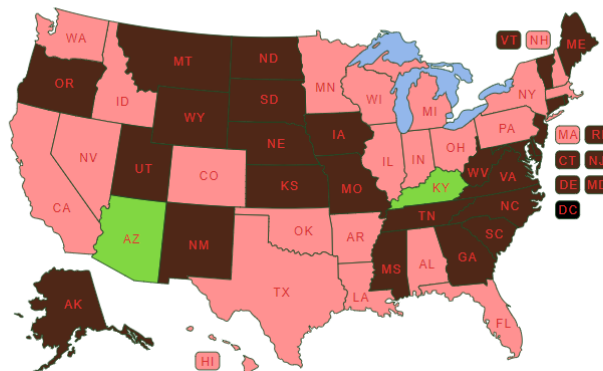

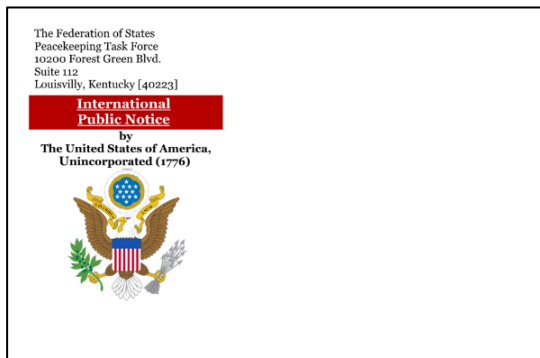

This video provides the summary of the Detailed Research and leads them to take the actions to read the Detailed Research and to contact their local State Assembly. Both links are cited in the video and both tabs are posted in the website's Menu bar.
3. The Detailed Research is divided by Reference Topics that educates them on what their predicament is and why they need to declare their birthright political status in order to claim their inheritance.
4. The 50 State Assembly's website links listed underneath the video on [claimyourinheritance.info](https://claimyourinheritance.info) will get them in touch with real people too to validate this is real and who will invite them to a County Tour public meeting event to meet their State Assembly.
5. Meanwhile up until the County event, at the TV platform, the people can become informed, get educated and vet our legitimacy.
6. Meanwhile up until the County event, at the News Blog website, the people can become informed, get educated and vet our legitimacy.
7. The State Assembly or State National will organize and hold a County Tour public meeting event to introduce our American Government to its public, in person; witness and

record declarations for people to claim their inheritance: and hand out “What Does ‘Political Status’ Mean?” and “Why Do I Need to Correct My Political Status?” brochures at the event or it can be emailed to the people upon first contact.

### Phase 1: Steps to a Mass International Public Notice Postcard Campaign

These steps can be taken by any individual American State National or by an Assembly:

**Step 1: Pick a County where you want to launch your postcard campaign. The first Zip Codes strategically would be in the County that has your Governor office and State Capitol building in it.**

For an individual American State national, you might target the County you live in. For an Assembly, you might otherwise target any County for which your Assembly have already elected a County Sheriff.

**Step 2: Do an online search and write down all the Zip Codes in that County.**

For example, in Ohio our State Capitol is in Franklin County. We will focus on its Zip Codes first.

The Ohio Assembly would then identify if we have any ASN’s already declared in that County. See if they would volunteer to be Franklin County Coordinator. Identify if they already have a Sheriff in that County. Proceed from there with deciding on the most strategic Zip Codes to target. I propose that when we get access to our State Trust funds that postcard campaigns be instituted as a staple government outreach initiative to responsibly notify Americans via their mailboxes. Until we have such funds to continue this, we will leverage the news media to notify the public, and for now, target their top official, the Governor.

**Step 3: Find a printing company who can print and/or mail your postcards to these Zip Codes at this link using the post offices’ EDDM® service:** <https://www.usps.com/business/every-door-direct-mail.htm>

<https://printerdirectory.usps.com/listing/#/>. Not all Post Offices offer EDDM® service so find one that does in your area, if you plan to do your own mailing. No permits are required. You can mail up to 5000 postcards per day.

These links will take you to the post office website where you can search their database for a local printing company or you can find one yourself in your neighborhood who does EDDM® mailing. A local printer will most likely be able to use either the 4x6 or 6.25x9 size postcards for campaigns that are not utilizing EDDM® which most likely are the individual American State Nationals campaigns. The USPS EDDM® website printers will use only the 6.25x9 size postcards.

You also have the option to have the postcard printed and shipped to you then follow the USPS EDDM® Retail process to have your local post office mail them out for you: <https://www.usps.com/business/every-door-direct-mail.htm>. Minimum mailing pieces is 200 and maximum 5000, 6.25x9 postcards. You will need to calculate if this will be cost effective for you. You will also need to find a post office in your area that offers EDDM® Retail mailing services and you will need to create an USPS online account.

**Step 4: Obtain the Postcard templates from the Nationwide Outreach Think Tank by emailing: [tammy-annhealy@proton.me](mailto:tammy-annhealy@proton.me) or the Peacekeeping Task Force by emailing: [ancestralbeauty@sbcglobal.net](mailto:ancestralbeauty@sbcglobal.net) and decide on a distribution method – EDDM© full service, EDDM© Retail, or do-it-yourself.**

If the American State National or the State or County Assembly want to use EDDM© or EDDM© Retail option, you will need to use the 6.25x9 postcards to run the campaign. These campaigns must range between 200-5000 postcards per day in your campaign. Use the 4x6 postcards if not utilizing any EDDM© service and opting for a complete do-it-yourself campaign. With this option, you will be purchasing and affixing your own postage stamps and addresses or find a local printer who provide this service utilizing a mailing list that you will also have to purchase.

**Note:** You also have the option to create your own custom mailing list that you can provide to your printer to run a postcard campaign with it. If you select EDDM© Retail service, you will need to create an online account per below instructions. Follow the links at the website below to read the specific requirements to run an EDDM© campaign.

**Step 5: Decide on a date, place your order with your printer and launch your International Public Notice Postcard campaign.**

**Step 6: Rinse and Repeat per Zip Code(s).**

This can be costly for any Assembly so strategy is key. As your funds are now limited, determine wisely which additional Zip Codes would be strategic for you to target next after the state capitol County Zip Code. I propose that when we get access to our State Trust funds that postcard campaigns be instituted as a staple government outreach initiative to responsibly notify every American via their mailboxes. Until we have such funds to continue this, we will leverage the news media to notify the public. We will place Public Meeting Notices in the Legal Notices section of the newspaper and run public service announcements on the radio. Assemblies also may consider bulk emailing as a alternative option as well.



### 3. Design & Print Your Mailpiece

Follow direct mail design best practices to create effective EDDM advertising pieces. Sending actionable mail with a clear offer and call to action will help generate customer responses.

#### EDDM Retail Flats

Use the Mailpiece Size Checker, located at the top right of the [EDDM Online Tool](#), to make sure your flyer or postcard meets the requirements for marketing mail.

#### Formatting Addresses & Postage

Mailpieces are simply addressed to "Postal Customer" and your mail will be delivered to every address on your selected routes.

#### Postage Indicia

Use the EDDM Retail Indicia, which is a postage payment mark that takes the place of a regular postage stamp or meter stamp.

- Every EDDM mailpiece must include the EDDM Retail Indicia above and to the right of the address block.
- The EDDM Retail Indicia does not have a specific size requirement but must be larger than 0.5" x 0.5".
- The type font must be in all caps and at least a 4 point size.
- It should fit in the area 1.625" from the right edge and 1.375" from top edge.

**Step 2:** Plan and organize your Public Meeting event to introduce your State Assembly to its public and to get peoples’ Declarations witnessed and recorded.

**Step 3:** Inform your postcard recipients and the community of the upcoming public meeting event. Assemblies will be able to follow up on the contact form submissions they receive at their websites to communicate this to postcard recipients. 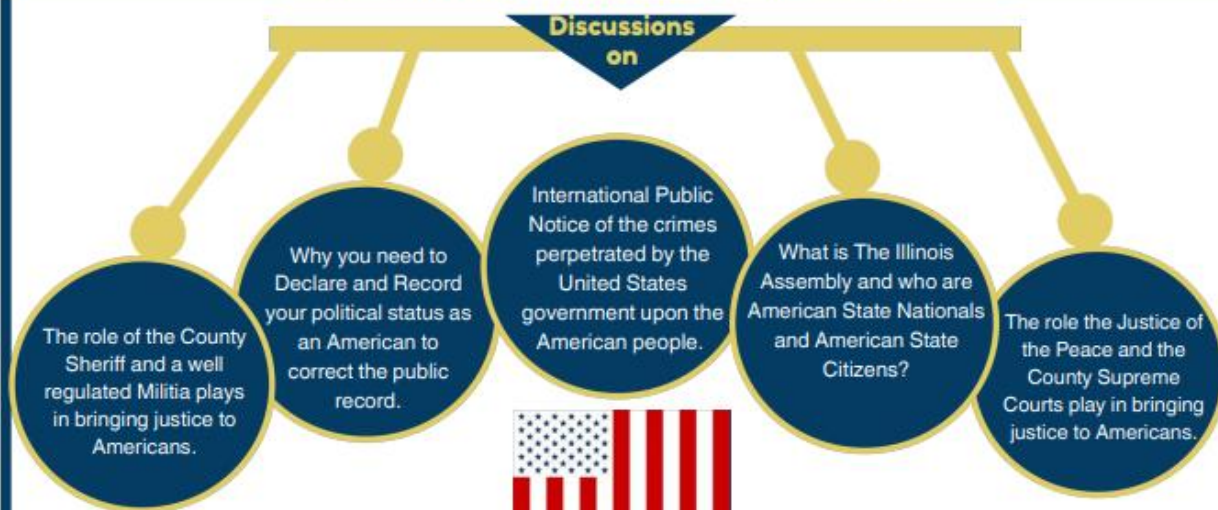

## Corporations Are Not Governments! (Part 1)

During the 1990s, alert financial analysts working for the Department of Defense discovered an odd thing. Numbers weren't adding up. A vast amount of public money was being embezzled. As the members of what came to be known as **"The Paradigm Project"** dug deeper, something even more astonishing appeared. Almost all of the governments on Earth were being run as private, for-profit governmental services corporations chartered under the auspices of the UNITED STATES, INC.

All these franchise operations of the US, INC. and USA, Inc. which are named things like: France (Inc.) and FRANCE (INC.) and USA, Inc. and UNITED STATES OF AMERICA and US CORP, and United States Government, Inc. --- are like franchises of Dairy Queen, Inc. ## What Does "Political Status" Mean?

Political status is determined by virtue of your consent to be governed by a specific body politic—a group of people with laws and customs.

The two types of governing body politics in America are the sovereign, unincorporated American government and the foreign, incorporated subcontractors of the British Monarchy d.b.a. the United States of America (USA), Inc. and the Roman Papacy d.b.a. the UNITED STATES, INC. who provide America with essential governmental services.

1. American State Nationals
  2. American State Citizen
  3. United States National
  4. U.S. Citizen
  5. MUNICIPAL CITIZEN

The American government operates under The Unanimous Declaration of Independence of 1776. The foreign United States government operates under two (2) service contracts, The Constitution of the United States of America (British Territorial Contract) and The Constitution of the United States (Papist Municipal Contract). These contracts were made with the American Federation of States d.b.a. The United States of America, Unincorporated, in 1789 and 1790, respectively. They delegate limited powers to these subcontractors authorizing them to perform the essential governmental services enumerated in their respective contracts.

## Your Political Status Can Be as a National or as a Citizen

Nationality is inherited as a birthright. It happens automatically the day you are born. In America, we inherit our nationality from our State. We are New Yorkers, Wisconsinites, Californians, and so on. Thus, our natural birthright political status is an American State National.

American State Nationals can become Citizens either by contract or by serving in a public office for our American Government. Both are voluntary.

Definitions for Citizen include employee, officer, subject, slave and indentured servant.

## America is NOT the United States, INC.

America is comprised of 50 sovereign, republican States referred to as the several States of the Union d.b.a. "The United States," unincorporated (1776).

The Territorial United States is comprised of 57 incorporated inchoate states: 50 "State of" States (State of New Jersey, State of Ohio, State of Wisconsin, etc.) AND 7 Insular States (District of Columbia, Puerto Rico, Guam, Virgin Islands, Northern Mariana Islands, American Samoa, and Wake Island); plus numerous, incorporated British Territorial governmental services franchises: United States Congress, Internal Revenue Service, Department of Defense, etc.

The MUNICIPAL UNITED STATES is comprised of approximately 10,000 INCORPORATED franchises operating as Municipal Oligarchies: "STATE OF ...," "COUNTY OF ...," "TOWNSHIP OF ...," "CITY OF ...," "BOROUGH OF ...," "VILLAGE OF ...," "UNITED STATES CONGRESS," "UNITED STATES DISTRICT COURT," "IRS," "DOD," etc.

## Each Political Status Comes with Inherent Rights



**Natural and Unalienable Rights** of American State Nationals/Citizens are given to us, in the words of Thomas Jefferson, by "Nature and Nature's God." Nobody gave us the "right" to walk, talk, think, move from place to place, or exercise our will. We cannot divest ourselves of these rights and the responsibilities that go with them.



**Civil Rights** are granted by Congress in the Civil Rights Act of 1866, then upgraded by Congressional legislation in 1968 to "equal" civil rights. This made them equal to the unalienable rights of American State Nationals/Citizens. Civil rights are not---strictly speaking---rights, but are instead privileges conferred on Territorial and Municipal citizens by the US Congress.



**The Universal Declaration of Human Rights** enacted by the United Nations in 1946 grants rights to "hue-mans." In law, that's not a man or woman, but a "color of man" meaning a kind of person that's created -- a mask of man. They're declaring the rights of all these "humans/persons" that are being created and attached to you for commercial purposes. Human "rights" are the privileges granted to United States Nationals and those who accept the status of "hue-man." Any Citizen or National may choose to lay aside their inherent rights for "human rights."



## Corporations Are Not Governments! (Part 2)

Now, stripping the onion another layer, the **Paradigm Project** discovered that not only had nearly all the traditional governments on earth been reduced to mere governmental services corporations owned and operated by the UNITED STATES, INC., but the states and people being served by these new corporations had been similarly unlawfully converted into corporate franchises. For example, Wisconsin had been reduced to a State of Wisconsin and then to a STATE OF WISCONSIN belonging to the UNITED STATES, INC.

Fourth Shock: your entire earthly ESTATE is up for grabs as chattel backing the debts of the UNITED STATES, a for-profit governmental services corporation operated under the authority of the Washington DC Municipal Government run by the members of Congress.

Fifth Shock: you don't know anything about this, because if you did, you would naturally object and that would spoil all their plans to steal your portion of everything and hand it over to their Secondary Creditors.

You are the Paramount Security Interest Holder in your name and estate. You are the Priority Creditor of the UNITED STATES and all its franchises, but they have purposefully misidentified you as a "missing person" and "ward" dependent on the UNITED STATES, so as to lay claim to your property as collateral backing their own debts.

Sixth Shock: corporations cannot and do not function as sovereign governments. If you are not operating your lawful unincorporated government, you have no government and no "state" to speak for you or save your bacon in international jurisdiction.

From all the foregoing, it is apparent that after the Second World War, the world governments colluded and/or were forced into agreements to operate in this fashion. It is also obvious that most of the people on Earth are in fact "stateless" until and unless they act to restore their own lawful government on the land jurisdiction, most of which have been inactive since the 1930's. ## Why Do You Need to Correct Your Political Status?

### U.S. Citizen/ United States National

An employee of the British Territorial U.S. government and their dependents; people born in Guam, Puerto Rico or the U.S. Virgin Islands; and enfranchised humans/persons named after you on the first "Birth Certificate" (long form).

These U.S. Citizens can only reside (as in "resident") in the States on a temporary basis per the Residence Act. They are foreign British Territorial Citizens historically referred to as Tories. They need to register as Foreign Agents under the FARA Act. U.S. Citizens cannot own land in America. They merely own a "title" to the land and have to pay taxes on the land. They are not owed any protections under the Constitutions. They are subject to the Constitutions when on the land and soil of the States—(that's why it's called "The Law of the Land")—meaning that they have to obey and respect the Constitutional Guarantees owed to American State Nationals and American State Citizens, but they have no such protections themselves. All U.S. Citizens have the status of "indentured servants."

- Federal employees and their dependents
- U.S. Military (active, reserve and discharged)
- British Territorial U.S. Citizen named on the first registered, long form "Birth Certificate"
- Licensed Medical Personnel
- BAR Attorneys



All U.S. Citizens are United States Nationals; also, those born on American Samoa and Swains Island; or any other legal entity which is organized under the laws of the United States, or of any State, the District of Columbia, or any commonwealth, territory, or possession of the United States, and which has its principal place of business in the United States. Strictly for Passport purposes, American State Nationals are regarded as United States Nationals because we are born on American soil and are not U.S. Citizens.



### American State National or American State Citizen

In 1776, the Sovereign Head of State for The United States of America, Unincorporated, William Belcher, conferred the status of "sovereign in your own right" upon every man and woman who were, and who will be, born on American soil. This birthright as a Sovereign is our natural political status referred to as an American State National.

American State Nationals hold Sole Survivorship interest in all the Estates, Trusts, and Legacies of this country. In relationship to the U.S. government corporations and their franchises, we are Foreign Sovereigns as described in FSIA. We are outside of their jurisdiction being free men and women who are owed our Natural and Unalienable Rights, the Constitutional Guarantees and the Law of Peace.

As sovereigns, American State Nationals have no duty or obligation to serve any government. We can, however, choose to temporarily lay aside our sovereignty to serve as an officer in our American government as an American State Citizen. Also, we can choose to contract to act as a foreign U.S. or MUNICIPAL Citizen holding a dual status for a specified timeframe and return back to our natural birthright political status, exclusively.

### Reclaim Your Birthright Inheritance

#### International Public Notice

Immediately following birth, every man and woman's natural birthright status is converted to a foreign citizen status, first to a U.S. Citizen and later to a MUNICIPAL CITIZEN. This happened, unwittingly and unknowingly, when your mother registered your birth. You are issued two birth certificates as confirmation of your new contracted citizenship statuses and the forfeiture of your American State National birthright status. To return back to your birthright political status, the public record must be corrected by recording and publishing a Declaration of Political Status and a Declaration of Naturalization to attest that you are changing your status back.

### MUNICIPAL CITIZEN/ citizen of the United States

A federal civil service employee or officer of the Papist Municipal Corporation in Washington, D.C. or its franchises, agencies or subcontractors and their dependents; people born in the District of Columbia; and any franchise corporation created by Congress via the 14th Amendment citizen status that is named after you on the second "BIRTH CERTIFICATE" (short form).



Approximately seven years after the first (long form) birth certificate is issued, the enfranchised human/person (British Territorial U.S. Citizen) named on it is declared dead and a second (short form) "BIRTH

CERTIFICATE" is registered under a similar name in all caps as a MUNICIPAL CITIZEN/citizen of the United States. All MUNICIPAL CITIZENS (US citizens) have the status of "slave" and serve as public chattel property.


