Introduction of Phase 3 to the Project

Phase 3 was first introduced to the Project at the Think Tank meeting – presentation delivered on June 5, 2024 by Louise Campbell-Anthony

We need a Capitulation Tour like Trump did. Call it Anna's Capitulation Tour (?).

The purpose of the Capitulation Tour is twofold: one, to proclaim to the people that "We Are at Peace!" and two, demand that the de facto "Stand Down!" Of course, we educate while doing this and extend to them the opportunity to correct their status. So, we will be claiming back American manpower and America's property at the same time.

What is Anna's Capitulation Tour? It is a Tour made throughout the Counties by County Sheriffs meeting with Public Officials who are running the public institutions in their County – institutions that our Trust funds paid for, (not no tax dollars). We use Anna's name because the world stage knows Anna's authority like they know Trump's (unless we can come up with a better strategy). These Tours serve as our "Stand Down" strategy.

We must help the people understand where all this World War III threat is coming from. How can we do this? We can organize a Capitulation Tour for Anna like the one Trump did, but Anna does not have to leave her home. She will send her PKTF to stand in for her. Our highest government authority is our County Sheriffs. Our highest authority in America above them all is the individual Sovereign National. We see the Territorial and Municipal are fighting each other on the world stage, but neither one is going to win. They both will come out even more weakened and decrepit. Once the dust settles, the American people will be looking for the stronger one to come out on top. Who will they find standing? It will be us. The American Government will stand up out of the dust – unengaged in their mercenary conflict yet as the unopposed victor. We are the Old Guardians and the New Guardians of America all wrapped up into one. This will mark America's Resurgence! in the annals of history.

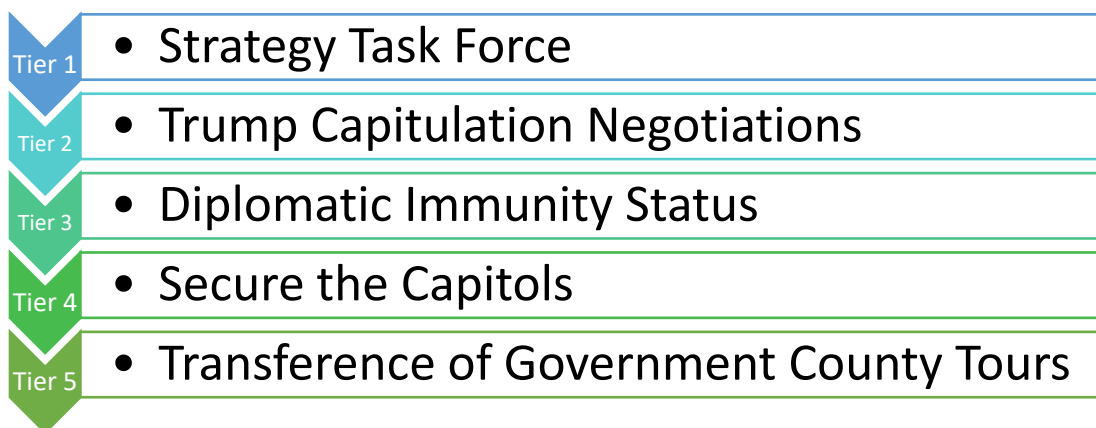

We are not touting the Constitutions. We are touting our Unanimous Declaration of Independence and treason against that. Notice that the de facto does not and cannot tout our Unanimous Declaration of Independence. That is because they are not party to it. They only have delegated powers under the Constitutions. We need to comprehend the significance of raising the Declaration of Independence as our banner when we Go Public. Let the People see what officials are not upholding Our Declaration of Independence and the freedom it stands for. Our objective is to shift the Public's attention to comprehend that the Constitutions are mere contracts and onto Our Unanimous Declaration of Independence being the ultimate document to revere.

"Transference of Government" 5-Tiered Strategic Plan Overview

A 5-Tiered Approach to Phase 3



Tier 1: Strategy Task Force Sessions – In order to accomplish a smooth and peaceful transference of government from our federal United States government services providers and their State and County franchises back to us, their Employers, we as a Federation of 50 united States need to properly, professionally and peacefully negotiate and direct this transference. This requires that the 50 States, or at least the majority of the States, first meet and debate amongst ourselves to agree and write out our plan of execution. In this plan, we will outline how we will address and direct our Employees on the what's and the how's this transference will happen; and how we will address and deal with their crimes. The States will need to coordinate and launch this plan with unified action as a Federation in full force for it to be most effective at achieving our desired result, which is "recognition." This Strategy Task Force will host and facilitate these sessions and invite all State Assemblies to participate and help develop and plan out the execution of each component to our Transference of Government Strategic Plan. The actions of our Head of State and Fiduciary and the International Public Notices will be used as our guide and our position of authority.

Tier 2: Trump Capitulation Negotiations – A Transference Plan will be drafted in collaboration between the Strategy Task Force, the Nationwide Outreach Think Tank, and the State Assemblies. It will be designed to give remedies to the Public via a one-fell-swoop list of demands; to install our de jure government's presence in our public buildings; to acquire the custody of the State Trusts; and to require that they implement specific features into their U.S. government's policies and databases that will enable American State Nationals to access our rights, remedies and exemptions when interfacing with their corporations. The complete execution of this Transference Plan will take years, of course, but will begin with a one-fell-swoop list of demands, with each demand accompanied by an Autographed Directive by our Fiduciary and any other necessary officers, which we will require to take place immediately. These negotiations to formulate a timeline and deadlines for this role out of these Directives will be initiated by Fiduciary, PKTF Directorate, Chief Continental Marshalls and Chair of each of the 50 State Assemblies with President and Commander-in-Chief Donald J. Trump and the U.S. Military, our Federal Subcontractors. ~~follow-up meetings after the Tier 2: Secure the Capitols interactions.~~

Tier 3: Diplomatic Immunity Status – Establish Recognition on Federation-to-Federal level first. The Federation need to be clear about our employee/employer relationship. Establish the fact that there is one Employee which is one Federal Franchise conglomerate (Federal, State, County, City governments). Be clear that as we address US, we are addressing all of them 1. The Federation (Fiduciary, PKTF Directorate, Chief Continental Marshal, etc.?) will have a sit down with the US Attorney General. Address the fact of a contract is in place, (Constitution), confirm that we are the employing party to that Contract, establish the process to enforce the terms of payment (debt-credit system), establish process for handling the criminal conduct of "their" employees and subcontractors, etc. 2. Correct the Error on their Public Record – Federal, State and Local agencies are required to maintain correct public records according to their laws. US Department of State is responsible for "citizenship" matters. The Federation (Fiduciary, PKTF Directors, Chief Continental Marshal, etc.?) will have a sit down with the US Department of State. Address to US Department of State as their Employers to inform/notice them that they maintain errors on their public records regarding the political status of American State Nationals. We are "non-citizen Nationals" born on the several states not in a U.S. outlying possession. Provide them the public records of American State Nationals recorded on each State Assembly and require them to correct "citizenship" records in their files. Inform Americans what they will need to submit to US Department of State (2 witness Statements and Credential Card, NO birth certificates, driver licenses and social security numbers and correct way to fill out application) to correct the error or to establish on their (US Department of State) public record the correct diplomatic immunity "citizenship" status to coincide with the public record we provided them on your behalf. American State Nationals will acquire diplomatic immunity recognition as an American State National at the Federal level that can be provided to and recognized by any employees of Federal, State and County de facto governments as notice to them to leave you alone. These passports will serve as "government-issued" ID's for their purposes in lieu of driver licenses and we will use our credential cards as our government-issued ID's for our purposes.

Tier 4: Secure the Capitols – We want to strategically establish control over “their” Capitols which in actuality, is our Capitols; and we will give particular, specific attention to our Nation’s capital, Philadelphia, Pennsylvania. To do this, we will elect and train County Sheriffs in the Counties where the State Capitol is located. Also, possibly elect State Coroners in their respective States since they have power over Governors.

PKTF Liaisons prepares the way by establishing the legitimacy of our Employee and Employer relationship. Delivers informational package and/or discusses its contents with County Sheriffs, the Governor, and the State’s Secretary of State. Package would include the contractual agreements, Constitutions, and Historical Background Information proving the American government subcontracted with British Territorials and Roman Municipal; the Federal British Territorial Principals and Municipal Principals colluded in contracts against American government; British Territorials subcontracted with State of State Franchises to provide services in false state of emergency. Disarm the Sovereign Citizen tactic/pejorative by identifying us as the Sovereigns who employed them.

Based on our Fiduciary’s recent Declaration of Land Law and change in the de facto County Sheriff’s capacity, we will solicit, enlist and offer to train the County Sheriffs of the de facto to assist in their constitutional capacities in our transference of government plan in accordance with our Fiduciary’s directives.

The County Sheriff’s, their State Assembly Militia, their State Continental Marshal and their PKTF Liaison will inform and notice these corporate head executives, the County Sheriffs, the Governor, and the State’s Secretary of State, of the treason of their Principal’s on the Federal level and other crimes they may be complicit with if they fail to cooperate and/or capitulate to our peaceful transference of government directives. We will provide the Directives via a Criminal Information and Notice of Treason presentment. Two specific demands will be made at this time: 1. provide the de Facto with a Peace flag and require them to raise it above Old Glory on the capitol building; and 2. require them to erect a billboard in the courtyard of the Capitol’s lawn that directs the Public to correct their political status. The first Counties that we will initiate our first contact across the nation will be the County that has the State Capitol building located in it. We will utilize both positive and negative public pressure to get capitulation from the Governors and Secretaries of State to cause them to issue orders from higher-up the chain of command to their subordinates to comply. The County Sheriffs, both de facto and de jure, have been empowered to arrest and charge for Treason, Misprison of Treason and other crimes of those who war against the Declaration of Independence by their act of refusal.

Tier 5: Transference of Government County Tours – After the Transition of Government Strategic Plan is finalized, the combined forces of the County Sheriff’s, their State Assembly Militia, their State Continental Marshal and their PKTF Liaison will plan respective follow-up meetings with the Governor and the State’s Secretary of State to require their cooperation and/or capitulation to our Directives and one-fell-swoop list of remedies. Subsequently, the State Assemblies will organize a tour of every County across their State to execute the Transference of Government Plan. Corporate Officers who refuse can be arrested and charged with Treason, Misprison of Treason, etc. by County Sheriffs for warring against the Declaration of Independence by their act of refusal.

Phase 3 Perspectives

We have a systemic, Federal franchise incursion predicament that the County cannot correct by simply standing up their County Courts, if first, the Federal incursion of these franchises onto our soil jurisdiction is not addressed on the Federal level. This can only be done by the partnership of the Federal and County parties being brought to the same table and getting on the same page.

We will leverage the authority of our highest office, the County Sheriff, to reign in the entire State-of-State franchise control over our States.

We must know that war and guns are an inappropriate response to our attempt at reestablishing the Terms of our Contracts, i.e. the Constitutions. We do not have a Sovereign-to-Sovereign relationship with our Employees. It is an Employer-to-Employee relationship between the parties involved. A Civil War can potentially be instigated among the Public by the U.S.A or US provocateur's undermining our authority if they agitate those of the public who refuses to accept the American Government as legitimate and/or competent.

We must not only demonstrate that we are the only legitimate American government, but also, that we are a competent government to the Public and to the world. To ask the Public to recognize their American government without demonstrating that we are competent to lead them has potential for push back and civil war. The public will fight to keep the U.S. Government in place instead of us if we appear incompetent. They would rather keep criminal incompetence because they are brainwashed.

We will have to emulate the competence of the De facto Government while exposing its criminality for the people to view us as both legitimate and competent. Doing this will create familiarity for people to relate to and to minimize potential for civil war or push back from them. The purpose is to facilitate in their acceptance of us as we replace the de facto in their everyday lives. Using terms that Trump uses will help, like Capitulation Tour, Think Tank, Task Force, Mission, Stand down, COG with means Continuity of Government, but in our case, means Capitulation of Government; for them, it's Transition of Government, but in our case, it's Transference of Government, etc.

Trump is our Bridge to taking our place on the world stage as The American Government. Why do I say this? Because the world is behind him and if you listen to him and study the military operation he was hired for, he has invited our sovereign American government to take the helm based on his 2016 inaugural speech, at least that is how I'm choosing to interpret his invitation. He states and I quote: "transferring power from Washington, DC and giving it back to you, the people." This is why I use the phrase, "transference of government." Let's call him to the carpet on this. We are the only government of the people, by the people and for the people. Points to Keep in Mind and Operate From

1. The Nationals organized as a State Assembly cannot function as a County Assembly; but Nationals organized as a County Assembly can function in a second capacity as a State Assembly.
2. Nationals who form a County Assembly can change hats and form their State Assembly as well.
3. Our Supreme Courts are at the County level not the State level. What benefits does that afford us in our Court processes and our special concurrent general jurisdiction over the Laws in our State?
4. No American State National is required to serve our Government. So, our objective need to be to rescue as many as possible and educate them to self-govern. This goes for those who choose to hold a dual political status as well.
5. All States have a General Assembly standing right now. What authority do they carry?
6. We are a Government not simply an organization and we hold a duty and responsibility to not only the American public but also to the world to govern this Country competently.
7. US/State/Local officials and employees can declare their political status as an American and hold dual political status.
8. We ultimately want to fire our United States federal subcontractors and bring all Americans home and do these jobs ourselves.
9. To get capitulation from these officials will take multiple meetings and additional strategies (i.e. a threat of loss of their prosperity benefits, public pressure, etc.). There is no State sovereignty **or State immunity**. State, County and City governments are mere franchises of the Federal government and must be directed by their parent Federal corporation.
10. When communicating with our Employees, silence is not acceptable or even a reasonable response when you are an Employer. This is not about legal vs lawful processes or living vs dead, at this level. We need to think in terms of the “Federal Contract” when engaging with them. Shift our attention and our approach from focusing on the Courts/Law to focusing on the Contract.

The people don't even know that the Constitution was a Contract that we made and paid for already for their performance of services.

11. Our weapon is not our Courts. It is the people. However, they are a weapon that has potential to be wielded for us or against us. The people need to be properly educated that they are Americans and what that really means.
12. When you "Go Public", you must air your own dirty laundry up front, so it can't be used against you later. America's Government must speak the true American History to the Public about:
 - Colonial Expansion against the original Treaties with the natives
 - Genocide of Natives
 - Slavery – White Slavery, Native American Slavery, Transatlantic African Slavery

We need to document everything on camera and in writing as many of these interactions as possible to be used in our documentary productions for our platform, the1776Union.tv.

7 Goals to Work Toward

1. Present ourselves as "The" legitimate Government AND a "competent" Government to the Public.
2. Not just get State and County Assemblies standing, but get State and County Assemblies standing strong. That means we will need to see a constant flow of Americans coming home to the land and soil. By the time we host our 3-Day event in 2028, we want to:
 - Have 50 State Assemblies standing strong. They are already standing but not strong.
 - Get 50 County Assemblies Standing and Seated where the Governor's office and State Capitol building are located.
 - Get 34 State Assemblies Seated or whatever the required quorum needed to convene a Continental Congress.
 - Get 50 County Jural Assembly pillars to stand up 50 American County Supreme Courts.
3. Take on the responsibilities of our United States Subcontractors on the domestic and world stages to prove our competence to govern a Country. Anna stated we don't need them anymore. To ask the Public to accept us as "the only" legitimate Government is inviting them to question our competency to govern a Country. I suggest that our American Government on all levels – Federal, State and County Assembly levels – demonstrate its competence to run the Government of this Country by developing a position and speak in an educated manner to these points below to the American Public and on the world stage. I would encourage every Assembly to draft a written Position paper on these Points and invite them to add other topics where the United States government injects itself questionably onto the world stage.
 - "Interregnum" – If the Federation have always been operational, how did this usurpation happen? How do we know it won't happen again?
 - War for Profit – Mercenaries are not protecting freedom but ravaging the planet for private corporate interests.

- Legalized Propaganda – Institutions and Industries are used as propaganda machines to control the Public – public education, religion, science, news and social media, film and music industries (include censorship on the opposite side of spectrum as a form of propaganda).
 - Government Corruption – United States Corporations rule the world via rampant, unchecked legal, criminal rackets acting in Breach of Contract and Breach of Trust.
 - Chattel Slavery – Public bonded slavery replaced private slavery through birth registrations; Human Trafficking (including the US Government’s Galactic slave trade during Eisenhower, child sex trafficking, ritual sacrifices, adrenochrome, etc.).
 - Disclosure of Extra Terrestrials – ET colonization seeded our Planet Earth and the Galaxy and are responsible for the civilizing of Earth inhabitants and Earth’s current predicament of corrupt government, (include the Earth Alliance, Secret Space Programs Worldwide, UFO Disclosure, Galactic Federation of Worlds, the Bible, Ancient artifacts, War in Heaven).
 - Crime – All crime is commercial but not under American Common law. How will we deal with crime? American Common Law is draconian. Corporations want to profit from it.
 - Money Idolatry – We are the value. The Federal Reserve Note is blood money based on bonded birth registrations (include Wall Street and Commodity Rigging, two sets of books, the real cause of inflation).
 - Corporatocracy – Companies that promote crime including legal crime recycle after a bankruptcy and the same board members boot up a new company and commit the same crimes. This is the MO of the United States government subcontractors. We have 50 State Assemblies with 4 Pillars each, unincorporated vs over 10,000+ franchise corporations.
 - Bioweapons – Deployed and funded by our Military, with and without Public Private Partnerships; Transhumanism; MRNA injections not vaccines; insurance and social security fraud linked to depopulation; Wide Body Area Network (WBAN); chemtrails, fluoridated water, 5G, nanomaterials (smart dust), direct energy weapons, weather modification - All attacks on life.
 - Global Trust Funds – D’Avila and St. Germain Trusts plus more - All government across the globe including the United States government have been paid to do their job so there is no need for taxes. So, what are you taxing the people for? Prosperity Accounts for all Americans. What will be our American Government’s Global Trade policy?
4. Make Wise Use of Our Fiduciary’s time
- We need her to get “How to Build an Assembly” Handbook completed.
 - We need her to get a 2nd Handbook completed covering “How does “Union” government operate on the soil in full power and capacity?”
 - We need her priority focus on “The American Governments Resurgence” Project: I need regular meetings with Anna to discuss this Project. I need Anna’s reviewal on all the documents that I’ve produced for this Project as we prepare for launching Phases 1 and 2 by September 2024. I need them reviewed in this order:
 - a. postcard
 - b. video
 - c. 2 Brochures
 - d. Our Recommitment to The Unanimous Declaration of Independence of 1776 pdf
 - e. Mission 2028: Your American Government Speaks pdf
 - f. Detailed Research

- I suggest we relieve Anna of her two responsibilities to the United States of America Podcast and the Weekly Coordinator Training. She says she is “moon lighting” to do these things. Put those responsible for these things in charge of them. “Who’s in charge? We are!” So, who is raising their hand for this? I would suggest Nitti, Michelle and Lisa do 1 Podcast to cover these 2 subject matters and make it 2 hours long. I suggest Anna focus her time on Webinars and Articles; complete the 2 Handbooks; and be open to public appearances as we Go Public. For the Coordinators-in-Training to get trained, I would suggest they be invited to the Coordinator meetings and to become an apprentice to one of the Coordinators to learn what Coordinators do. If an issue comes up that needs attention, someone will reach out to Anna.
- 5. Convene a Continental Congress to review the Contracts, i.e. Constitutions, for consideration of termination or renegotiation and to elect a President and/or assign a Head of State successor.
- 6. Require without compromise one-fell-swoop remedies for all Americans at once to get the remedies we have been fighting for single handedly for years trying to exercise our rights.
- 7. I’m following the model we used to take down Illinois Governor George Ryan in our small community. Our initial engagement with the Public should focus on gaining public support and preventing civil war which can only be made possible due to their continued ignorance. Based on that model, our public engagement efforts need to include this:
 - Inform Public Opinion: Get the Public educated so they can develop an informed, educated opinion; use positive and negative public pressure to expose the Governors; implement “The American Government’s Resurgence” Project; each Assembly draft a Position Paper on the above topics and speak articulately about them in the public including at their County Tour public meetings and in the news media.
 - Build Bridges: Show support for groups who fight the US government on the “Government Competency” Points I listed above, so we can borrow their reach of power to strengthen ours. We don’t have the expertise in these subject matters, so we need to extend a bridge to cross over into areas we know little about.

Tier 1: Strategy Task Force Sessions

I’m thinking that putting together a Strategy Task Force is needed. We will have one primary focus:

We will strategize on how to bring forth the Directives that our Fiduciary has made of our Federal Employees, their State of State franchises, the Government Corporations and Agencies and the Banks as the Employers. We will formalize a plan of action to get full cooperation and/or capitulation to transfer the governance of each State into the hands of the State Assembly and into the hands of each County Assembly. The County where the State Capitol is located will be the physical location where the Strategy Task Force will execute this Strategic Plan initially. The remaining Counties will be facilitated by their respective State Assembly.

I invite particular skilled people to volunteer to serve on this Task Force. I would invite County Sheriffs; Liaisons; Continental Marshalls; Justices; Militia Commanders; Coroners; Court Clerks; ASN’s experienced in grassroots activism and community organizing; and ASN’s who are familiar with military operations and tactics.

I also invite all State Assemblies to attend these Sessions to assist in the development and execution of this Transference of Government Plan of Action.

The objective is the same at every level, the Federal, State and County level initiatives, which is to get capitulation to our terms of engagement and our one-fell-swoop list of remedies by sending down orders from the top-down from the Federal level to the State level Governor's office, to the County level and

the City level. We need to make clear to them that silence from our Employees is not appropriate and cannot continue in this way. We must also keep our fingers on the emotional pulse of the public to preempt civil war and unrest. ~~See 2-Tours Approach below regarding County Sheriff "Capitulation" Tours.~~ The best way that I think we can do that is by empowering the American public with just cause to question the elected officials as to why they don't have the remedies and unalienable rights that were guaranteed under the Constitution. Do this in a way where we bring all Americans together under this one cause, dismantling the division created by fraudulent lines drawn by unlawful conversion of our political status.

Administrative Tasks

- How to get Assembly participation?
- List of County Sheriff, State Continental Marshall, State Militia Commander, State Coroner
- Map out the "Capitol Counties" and monitor the progress and results of the "Sit-downs"
- Identify which States have already communicated "Directives" to the de facto on their official letterhead and request a copy of these documents for our review and analyze their responses.
- Identify which States have already declared Ex Parte Milligan. Ask for a report of the Ex Parte Milligan Court cases on their State and the results from their enforcement.
- Ask for a report from the State Assemblies of a survey of the types of court cases that ASN's are currently engaged in on their State with the de facto.
- With this information, we will be able to assess our position as the Employer with subordinate employees who we can't fire just yet. We will get a clear picture of the truth about how effective standing up our Courts has been at fixing our issues with the de facto. When we get clear on where our weaknesses are, we will be in a better position to find where the real problems lie and can devise appropriate strategies to correct them.
- Identify which State already have a County Sheriff elected in the County that has the State Capitol and Governor's office located there.
- Incorporate the knowledge of when the de facto's yearly training manual is being completed to align with our time we make directives to them to make changes so we can have a concrete analysis and assessment procedure to identify if our directives are being adhered to.
- Analyze the responses received from the Federal level negotiations and use that to inform us on our choice of tactics at the State level.

MOST EFFECTIVE ~~PHASE 3~~ STRATEGY

Yes, bring all 3 jurisdictions into the conversation and to the table – International Sea, International Land and National Soil AND involve the American public.

Lead out with issuing an International Public Notice to the American Public.

Why?

As our American government make our debut onto the public stage as the Federation of States to earn the recognition as such, it is important and most strategic that we lead the conversation with the most pertinent issue: the Crime. My The postcard succinctly informs them:

1. A crime has been perpetrated against you
2. Who committed the crime
3. Who we are that is reporting this fact to you
4. What we are doing about it
5. What you need to do about it to get your remedy

Earning recognition, trust and respect from the American public is equally as critical to our success as is earning recognition, trust and respect from our Employees. Without the American Public aware of who we are and who they are and what the crimes are that are being perpetrated against them daily, we will continue to push upstream without a paddle in our efforts as an individual American State National who is trying to exercise his/her rights and as a Government who is trying to uphold our Declaration of Independence.

The language of the postcard is consistent with our claim that the only reason for government is to protect the people and their assets. That is the primary message that our actions should project to the American public. Providing them with education is secondary and supplementary. If we can't demonstrate our credentials and authority as "The American Government," it renders our educational material and the individual American State National's actions dismissible and deserving of the label "sovereign citizen."

Their strategy is to just not recognize us as the American Government and claim they are the only government, then they can get away with claiming we are "stateless sovereign citizens." What they mean by "sovereign citizen" is that the individual American State National's claims have no credence because "they" are America's only government. So, the individual is and can be regarded and treated as "stateless" and as their other descriptors (terrorists, etc.). This gives the label credence in the eyes of their employees and in the eyes of the American public regardless of what the term literally means.

If the Federation of States is not recognized as the ONLY legit government then it makes sense and should be expected that no State Assembly (or County Assembly) is recognized either being members of the Federation. This is how I interpret our predicament and the reason why I think our issue must be handled at the federal level **first** to get a meeting of the minds **first** that there is a Service Contract (Constitution) that establishes that we have an Employer/Employee relationship with them which makes us the ONLY government.

Apply Public Pressure.

Arm the American public with evidence of the crimes. Empower the public with a solid evidentiary case to place them in the offensive position as we encourage them to state their claims of being victimized. Enlist the public as an army of whistleblowers of the crimes that their "Government" is and has perpetrated against them.

To do this, I suggest a one-fell-swoop list of remedies be drafted listing the remedies that they should have had, but don't. Put this list in the hands of every American and bring this list into their awareness

via the Media. Get them to ask themselves the question, “Do I want these things?” and to ask their “Government” the question, “Why don’t I have these things?”

Provide the American Public with an Autographed Declaration for each Remedy on the list (or some type of doc but must have autographs on them to give them credibility) that proves the claim that it is a crime and what is the penalty if and when they present it to their “Government” officials or employees to demand their remedy but it is not granted. Provide them a template and instruct them on how to present their Criminal Information and Affidavit of the crimes that they have been and is being victims of to the appropriate “Government” official and cc their American State Assembly and/or Assembly County Sheriff.

We need our own volunteer reporters and journalists to report the true news of what we are doing and what is happening at the Public Meetings our Assemblies are holding and at the meetings (or attempts to meet) with our Employees. We will feed these reports to the Media to increase the chances of it being reported correctly and to provide the public with something to compare the Media’s message to when they go to do their own research and fact checking.

Indicators that Due Recognition as Employers has been achieved.

The State Assembly can call the Governor or any de facto elected Officer on the phone and they will accept the call and receive our direction and execute it. The State Assembly can send a Directive via mail and the Governor or any de facto elected Officer and they will respond in writing accepting our direction and explaining how they will execute it. Directives/Declarations need to be crafted and used differently than a “Notice.” They are not the same. We must admit this is not how business is conducted between an Employee and Employer and seek primarily to establish a legitimate, business relationship and apply consequences when they are subordinate. We don’t need to argue our laws against their laws or create new ones. We need their codes that are already on their books and in the court decisions to be adhered to. We need the Declaration of Independence to stand as law --- period, point blank.

The American Public recognizes there is an American Government and “sovereign citizens” is an oxymoron. We need to get the message across to the American Public that we can’t restore their sovereign government without them claiming their sovereignty back.

Imagine if our Federation, The United States of America, Unincorporated is recognized as the ONLY government, how easily our State and County Assemblies could get all franchises to fall in line and not get the silent treatment. How different will our everyday lives as American State Nationals and even U.S. British and Municipal citizens’ lives be as we interact with these government service providers?

Tier 2: Trump Capitulation Negotiations

Based on Trumps 2016 inaugural speech, at least that is how I’m choosing to interpret his invitation. He states he states and I quote: “transferring power from Washington, DC and giving it back to you, the people.” This is why I use the phrase, “transference of government.” Let’s call him to the carpet on this. We are the only government of the people, by the people and for the people. They speak of government reforms. Well, let’s outline the specific reforms we require of our Subcontractors, their agencies and their employees and bring them to the negotiation table and in full public view to observe as these conversations take place.

We want the parent corporations to issue orders to require that the State Governors send out official letters of our Relief demands regarding the roll out of our remedies and their administrative changes to appropriate agencies and departments and require them to immediately implement. We don't want Americans to have to wait til they fix their computer systems to catch up with our demands. Let's make our expectation of this transference rollout simple and be clear to the American public of how they can access their remedies.

These negotiations to formulate a timeline and deadlines for this roll out of these Directives will be initiated by Fiduciary, PKTF Directorate, Chief Continental Marshalls and Chair of each of the 50 State Assemblies with President and Commander-in-Chief Donald J. Trump and the U.S. Military, our Federal Subcontractors. Also invite our own news reporters.

These negotiations will cover two categories of topics: 1. One-fell-swoop list of remedies and 2. Government Reform in respect to the administrative changes we require them to make.

Volunteers are needed. We need Public Relations people to do Press Releases to news, radio, and social media; Camera/Video Producers to attend and document these meetings; journalist to attend and report on these meetings so the facts will be reported accurately. Announce these meetings to the media, so they can attend as well.

Negotiate a One-Fell-Swoop list of Remedies

Negotiate the roll out of a one-fell-swoop list of Demands for remedies for Americans. Align this list with the remedies listed in the "Resource Documents to Refer to for Direction" above on page 12.

- Every application for **government services** will be a prepaid – zero sum payment transaction for them to receive that service. We have already paid for these services via Trust funds (water, sewer, electric bills, phone, etc.)
- **Bank Loans** (student loan, car loan, pay day loan?, home loans) – Every application for bank loans will be a prepaid – zero sum payment transaction for them to pay for these items. All current loans will be zeroed out as prepaid since your credit already paid for it.
- **Property Taxes** "supposedly" pays for local government services – They were already paid for by Trust funds. Discontinue Title System because our land belongs to us not the Crown and its Citizens can't own land anyway. If the Crown want to tax his/her Citizen, it won't be allowed via a Title system. Record your interest in the property with the Bill of Sale.
- **Traffic issue** – Every Secretary of State will start making Regulation Z plates. We will keep the driver's proficiency exams services but we will not register cars only register commercial vehicles. Noncommercial car operators will be given Z plates. Prove your interest in the property with a Bill of Sale and prove that you can operate a car by passing the driving proficiency exam.
- **Income tax issue** – IRS/Courts – People who are jailed for income tax "whatever" gets pardoned by Governor and released from prison and released from any liens on property since the IRS tax Amendment was never ratified by States and most are not federally employed. Cease taxing people's compensations.

- **MOCEE** – Mutual Offset Credit Exchange Exemption - All FRNS are backed by the good faith and our credit American people. All of our bills get paid for as long as we have FRN's and no money. Every bill gets paid to the company by Territorial/Municipal subcontractors when we identify ourselves to that company as American State National. Provide us with a bank routing number so we can provide them ourselves to these companies in lieu of our payment to get our bills paid. We are referring to those routing numbers that you use anyway right now.
- **County Recorder office** will accept and record our Declarations as they should. County Assemblies don't need a recording office. They already have one that we paid for in the County Building with our Trust Funds. State Assembly will still need an LRO since there is no central LRO for a State and we are in a transition state and need to keep good records of our Nationals for their protection.
- **No more birth registrations** in hospitals. The parent will record births at their local County Recorder's Office, in their Bible and/or in the local newspaper.
- Put "American" in your **Databases** under the category for "Citizenship" and have the system label us "Exempt" from payment of anything to receive governmental services.
- **Release our children** from Government child protective services. Return them to their rightful mother and father.
- **Put "American State National" in your Databases** under the category for "Citizenship" and have the system label us "Exempt" from payment of anything to receive governmental services.
- **Release our children** from Government child protective services. Return them to their rightful mother and father.
- **Raise Peace Flag**
- Erect Correct Your Political status **billboards/Road signs**
- **Insurance agencies (what is an appropriate request for relief?)**
- **Selective service** – Americans cannot be drafted. Selective service is for recruiting mercenaries. Hiring assassins for the British U.S. Military cannot be allowed on American soil.
- **Postal service** deliver mail to our Rural Route – People are domiciled on the land. Redistricting our land into municipal zip code districts is a form of encroachment and cannot be allowed to continue.

Government Reform in Respect to Administrative Changes We (Employers) Require

Articulate how the Territorial and Municipal officers and employees (and state and local franchise governments), as well as Commercial bank personnel who choose to remain in dual status, will commit to these government reform actions that are needed to accomplish our transfer of governance:

- Parent corporations issue orders to require that the State Governors to send out official letters respective to our one-fell-swoop list of remedies we are making of the Territorial and Municipal subcontractors to their appropriate agencies and departments and require them to immediately implement. Require an answer in writing from them of how they intend to carry it out.
- Americans don't have to wait til they fix their computer systems to catch up with our demands for relief. Make it simple
- Put "American State National" in your Databases under the category for "Citizenship" and have the system label us "Exempt" from payment of anything to receive governmental or public services.
- Stop broadly misaddressing Americans as any type of U.S./US Citizen. When an American show you their credential card, you know your municipal or corporate codes don't apply to him/her.

- There are 3 “citizenship” categories for your databases: U.S. Citizenship by fully disclosed contract under an employment or a license agreement; an American State National or Citizen status; and 14th Amendment citizens by birth registrations do not exist, only if born in Washington, DC. and Municipal citizens employed under the US Constitution are also an acceptable status for citizenship.
- All County Recording offices will record American State Nationals Declarations and any other paperwork.
- Once an “American” identifies him/herself as such, your Office will provide him with terms of full disclosure identifying his/her relationship to your office such that he is not prejudicing his right to contract.
- All dual status employees will understand that they are required to abide by their corporations’ terms of employment policies regarding corporate citizenship and upholding the Bill of Rights protected under the Constitution for American State Nationals.
- Require our mail to be delivered to a rural route address outside of the military zip code districts
- Allocate office space in our public government buildings (Capitol building and Court houses) from which to run our American government services. Does the State Assembly need to draft some type of agreement for this?

Tier 3: Diplomatic Immunity Status

Tier 2: Diplomatic Immunity Status – Establish Recognition on Federation-to-Federal level first. The Federation need to be clear about our employee/employer relationship. Establish the fact that there is one Employee which is one Federal Franchise conglomerate (Federal, State, County, City governments). Be clear that as we address US, we are addressing all of them 1. The Federation (Fiduciary, PKTF Directorate, Chief Continental Marshal, etc?) will have a s it down with the US Attorney General. Address the fact of a contract is in place, (Constitution) and it was created in the international sea jurisdiction with limitations; confirm that we are the employing party to that Contract, establish the process to enforce the terms of payment (debt-credit system); establish process for handling the criminal conduct of “their” employees and their subcontractors, etc. 2. Correct the Error on their Public Record – Federal, State and Local agencies are required to maintain correct public records according to their laws. US Department of State is responsible for “citizenship” matters. The Federation (Fiduciary, PKTF Directors, Chief Continental Marshal, etc?) will have a s it down with the US Department of State. Address to US Department of State as their Employers to inform/notice them that they maintain errors on their public records regarding the political status of American State Nationals. We are “non-citizen Nationals” born on the several states not in a U.S. outlying possession. Provide them the public records of American State Nationals recorded on each State Assembly and require them to correct “citizenship” records in their files. Inform Americans what they will need to submit to US Department of State (2 witness Statements and Credential Card, NO birth certificates, driver licenses and social security numbers and correct way to fill out application) to correct the error or to establish on their (US Department of State) public record the correct diplomatic immunity “citizenship” status to coincide with the public record we provided them on your behalf. American State Nationals will acquire diplomatic immunity recognition as an American State National at the Federal level that can be provided to and recognized by any employees of Federal, State and

County de facto governments as notice to them to leave you alone. These passports will serve as “government-issued” ID’s for their purposes in lieu of driver licenses and we will use our credential cards as our government-issued ID’s for our purposes.

Non-Citizen National Definition to Include American State National

Everyone born on American soil is an American State National, but they don’t know it. They don’t know that they were born sovereign in their own right. That’s how the American Government established it and that’s the wake-up message we are delivering. By Government, we mean “We, the people,” the living men and women not the corporations. We want to wake them up to the fact that their contract to be a U.S. Citizen and a municipal United States citizen was fraudulent being an undisclosed, constructive fraud perpetrated upon them to get them to divest themselves of their sovereignty.

Our corporate Employees shall be required to recognize us in the capacity of a sovereign possessing the right to contract away that sovereignty if we want to but it must be entered into with full disclosure of the terms of the “citizenship” contract in order for it to be valid.

Continuing to regard Americans as a U.S. Citizen or municipal citizen would be to regard the unlawful conversion of Americans’ political status to a foreign citizen as a valid contract when it wasn’t. It was fraud and fraud vitiates all contracts ab initio.

Anna states: *Those making the False Claims and False Presumptions related to our enslavement are criminals under international law and global commercial law as well as Ecclesiastical Law. We wish for the total discrediting of this system of things and all Legal Presumptions attached to it. We wish for this entire system of registering babies as property belonging to Municipal Corporation franchises to be dismantled and for all claims against the property interests of the living people who naturally belong to the General Populace of each country to be disallowed. Anyone caught using or soliciting, seeking to subject, entrap, ensnare, or otherwise encumber American babies or adults via this foreign Legal Scheme without full disclosure so as to impersonate and denigrate and unlawfully convert the victim’s political status and identity, will be subject to immediate arrest and prosecution under UCMJ, 18 USC 4 (513) (a), both the Hague and Geneva Conventions (as applicable), the Constitutions, and will be 100% commercially and personally liable for their acts.

That goes for the American Government as well as the British Territorial and Municipal governments. So we must demand of the U.S. Secretary of State to include American State National as part of their definition for “non-citizen national” for the passport process in order to gain global recognition as the sovereign American Government and American State Nationals recognized to have full diplomatic immunity.

The Secretary of State's office does not have the legal or constitutional authority to accept your documents, especially if they contain declarations of citizenship status. We also do not have the authority to intervene or accept filing on your interaction with the Spokane County District Court.


We also cannot accept your filing under the provisions of RCW 43.07.032 Section 3, contains information: (a) Regarding allegiance to a government or jurisdiction; (b) Relating to the relinquishment or renunciation of citizenship, sovereignty, military status, or world service authority; or (c) Setting forth or implying for the bearer a claim of immunity from the laws of the jurisdictions of Washington, immunity from the laws of the state of Washington, or immunity from federal law.

The Washington State Secretary of State is the manager of elections, corporate licensing, the State Library and State Archives. Issues of citizenship status are handled by the U.S. Department of State in Washington D.C. We do not have the legal authority to issue, terminate, or receive filings of any type concerning your citizenship status. You should address any issues regarding your citizenship status to:



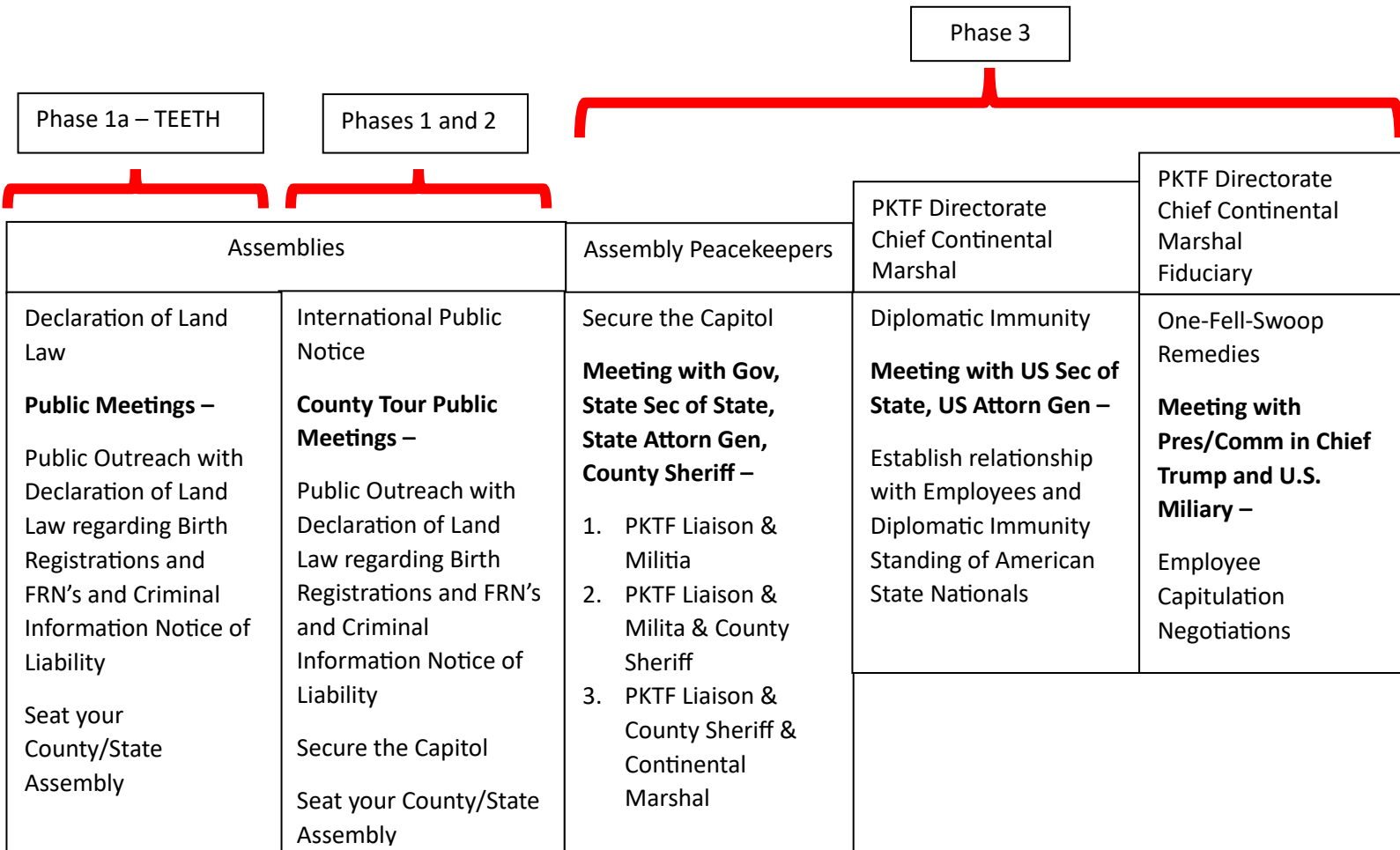

Tier 4: Secure the Capitols

Well, let’s outline the specific reforms we require of our Subcontractors, their agencies and their employee and bring them to the negotiation table and in full public view to observe as these conversations take place.

Draft a plan that outlines the roll out timeline to transfer the Federal Corporate Franchise control of governance operating now on the Land to the rightful County control of the People of the Counties. All Counties can’t possibly get stood up and seated at the same time to receive this responsibility, so we

need a Transference Plan written out and implemented. Handbook 2, “How does “Union” government operate on the soil in full power and capacity?” would help greatly with this.

Articulate how the Territorial and Municipal officers and employees (and state and local franchise governments) as well as Commercial bank personnel who choose to remain in dual status will commit to the government reform actions that are needed to accomplish our transfer of governance:

- Parent corporations issue orders to require that the State Governors to send out official letters respective to our one-fell-swoop list of remedies we are making of the Territorial and Municipal subcontractors to their appropriate agencies and departments and require them to immediately implement. Require an answer in writing from them of how they intend to carry it out.
- Americans don't have to wait til they fix their computer systems to catch up with our demands for relief. Make it simple
- Put “American State National” in your Databases under the category for “Citizenship” and have the system label us “Exempt” from payment of anything to receive governmental or public services.
- Stop broadly misaddressing Americans as any type of U.S./US Citizen. When an American show you their credential card, you know your municipal or corporate codes don't apply to him/her.
- There are 3 “citizenship” categories for your databases: U.S. Citizenship by fully disclosed contract under an employment or a license agreement; an American State National or Citizen status; and 14th Amendment citizens by birth registrations do not exist, only if born in Washington, DC. and Municipal citizens employed under the US Constitution are also an acceptable status for citizenship.
- All County Recording offices will record American State Nationals Declarations and any other paperwork.
- Once an “American” identifies him/herself as such, your Office will provide him with terms of full disclosure identifying his/her relationship to your office such that he is not prejudicing his right to contract.
- All dual status employees will understand that they are required to abide by their corporations' terms of employment policies regarding corporate citizenship and upholding the Bill of Rights protected under the Constitution for American State Nationals.
- Require our mail to be delivered to a rural route address outside of the military zip code districts
- Allocate office space in our public government buildings (Capitol building and Court houses) from which to run our American government services. Does the State Assembly need to draft some type of agreement for this?

~~Can we change the postal mailing to postal union control? Remove zip codes? Until that is universally done, put “In-Care of” on every mailing address to indicate “In-Care of” the municipal postal district until we can transition to our own.~~

Ask for “ReCommitment to Declaration” Signors/Autographs: Do you want your freedom back as a Sovereign American under by the Declaration of Independence or do you want to retain your British-Romano Citizenship under the Constitutions? This will serve to inform State Assembly when it's time to renegotiate the Constitutions as well as can serve to apply public pressure.

Create a Presentation of these demands and their legal codes related to them to demonstrate and inform the Public that these things were to be granted to Americans already. These presentations will be what State Assemblies can present at their public meetings.

Reminder: State sovereignty **and/or State immunity** doesn't apply to State of State franchises. So, don't allow them to use it as an argument. See Public Law Public Law A1010224.
