Louise Campbell-Anthony (00:06)

Peace and blessings. That's what this coordinator told me. What request did I make? I asked to be put on the agenda to speak to the Assembly. That was my request. Okay?

Louise Campbell-Anthony (00:18)

All right? When we respond to people, and that's... and it's conflict. We have to have a professional way of responding to them. To de-escalate the conflict, if we can. But give verifiable, sound information to them, because they have a... they have a concern.

Louise Campbell-Anthony (00:42)

Try to see if you can hear the concern throughout the chatter. But still, try to hear it. And then address what the concern is. So, I want us to practice self-governance and self-mastery at all times.

Louise Campbell-Anthony (00:57)

And find a strategy that you can use that works for you, that you can be professional. You can, uh, be accountable Accountable for your office. If you are a coordinator, you are a recording secretary.

Louise Campbell-Anthony (01:12)

You are a treasurer. You have to be accountable to the people, the American people. You are accountable. I don't... I don't get the... I don't get... for... for a coordinator to tell me I cannot address my... assembly, you're the government! Would you accept that from the de facto? If you wanted to go to your public meeting.

Louise Campbell-Anthony (01:40)

In the township or the village, or whatever public meeting they were having, because this is... General Assembly is your public meeting, that's the government public... If you wanted to go and get on the agenda.

Louise Campbell-Anthony (01:51)

Would you let them tell you that? I wouldn't let them tell me that. Because you work for me, right? So why would you accept that from our American government?

Louise Campbell-Anthony (02:02)

These are things we need to correct, yes. These are things we need to correct. And the model counties. Job, one of your jobs, is to establish the county correctly, solidly.

Louise Campbell-Anthony (02:15)

With the right things at the foundation, so when we start duplicating, we don't duplicate stuff like that. We can't duplicate that! We have to duplicate the right stuff.

Louise Campbell-Anthony (02:26)

That's why I started off Our foundation, and our foundation, let me share my screen again. Okay, let me see. In the foundation, let's talk about the foundation.

Louise Campbell-Anthony (02:48)

In the foundation, uh, you'll see this, this document here in the chat. This one here. In our foundation, our foundational bricks. In the foundational bricks.

Louise Campbell-Anthony (02:59)

Even before we go doing our outreach. Our assembly has to be structured on some solid bricks, foundation. So that when we start talking to the American people. They look at us, and then they'll see that we're competent to be talking to them.

Louise Campbell-Anthony (03:19)

What I mean... what I mean is. We're going to talk to the American people, telling them. Your government is now restored, and uh... this is what has happened, and this is how we're taking care of it.

Louise Campbell-Anthony (03:30)

And this is what you have to do to self-govern. Well, if you're not self-governing yourself. You can't tell them that, and they're gonna see straight through it.

Louise Campbell-Anthony (03:44)

Within our... within our... our little bodies now, we can say, okay, we have to course correct and fix it, we'll fix it as we go. We can say that within ourselves. But when you go... you go out there and talking to the American public.

Louise Campbell-Anthony (04:01)

They're going to be sizing us up. To what they already know, which is the de facto. They're gonna size up our competency with the de facto. When... When we say certain things out there to them.

Louise Campbell-Anthony (04:17)

Uh, or... or present ourselves in a certain way, like, that conversation from that state coordinator. They're not gonna accept that. They're not gonna look at us as legitimate.

Louise Campbell-Anthony (04:28)

As professional, as competent. Like, we know we're doing. So we need to get it, you know, we need to get it right. Now, so that when we go out there, we can be viewed as competent, and they can be... they can want to belong.

Louise Campbell-Anthony (04:45)

Or take... they want to accept us as who... as who we saying we are. We have to earn. That place, as the American government from the American people. I don't know if people... that's my opinion? I don't... I don't... I don't know if people really... get that... The American people, they are the consent... they are the one who gives the consent of the governed.

Louise Campbell-Anthony (05:10)

The people... if the people don't recognize us as the American government, as the... as America's only government. But then we don't get recognition. No matter what it is that we... what paperwork we've done, whatever, yeah, you've done it for yourself, but we're trying to get the recognition from the American people that we are America's government.

Louise Campbell-Anthony (05:34)

We have to earn that. We've been gone for 150 years plus. So, know that we have to earn that. It's

like somebody who... who... who left you. And then coming back into your life, and you just want them to open their arms and take you in. No, you gotta earn that place to come back.

Louise Campbell-Anthony (05:54)

So... in the foundation of what I'm trying to do here with the model counties is to build the foundation right first. In the foundation, part of it is the ombuds oversight committee, conflict resolution.

Louise Campbell-Anthony (06:11)

It has to... it has to be... in place first. We need to know how to conduct our assemblies in a professional way with decorum. We need to be able to hold our officials accountable. With the ombuds service, or the Oversight Committee, we need to be able to say, hey, my coordinator said this.

Louise Campbell-Anthony (06:31)

Hey, Ma, recording secretary is not doing her job, and we need to be able to go to them buds, to the Oversight Committee, and report that they're... is a problem with these officers, and we need it to be taken seriously.

Louise Campbell-Anthony (06:49)

But the other side of that is the ombuds and the oversight committee need to be competent to do their job. I'm hearing that... that... that issue, too. Yes, we have ombuds. Yes, we have oversight committee, but Yes, we have a coordinator.

Louise Campbell-Anthony (07:09)

Yes, we have a chair. But are they competent to do their job? Are they... do they need training? So, just because we have them is not good enough. We need to be competent. To perform the jobs.

Louise Campbell-Anthony (07:25)

So, conflict resolution is part of the foundation of how we're building the model... the model uh, county, the model county initiative. Now, so, here are a list of items, I think, is necessary to have, starting... Um, starting to build from. One is we have to have a county coordinator.

Louise Campbell-Anthony (07:51)

And I've heard, um... I did hear... we had the conversations back and forth of Can we just... have the people elect us. And you don't have to go through the Federation.

Louise Campbell-Anthony (08:05)

My answer to that is The Federation is there to make sure that the American government is reconstructed properly. They have the summoning authority to summon the American government back into session.

Louise Campbell-Anthony (08:21)

Yes, we are sovereign. Yes, we don't answer to the Federation. Well, we don't answer to the Federation. Once we are standing as the American government without our training wheels, I guess that's how Anna says, without our training wheels.

Louise Campbell-Anthony (08:39)

We have to keep that connection, that chain of authority. Connection because, and this is my main

reason why I say Because... when we go out there and tell the American public You're sovereign. Sovereign in your own right.

Louise Campbell-Anthony (08:53)

You're supposed to be keeping an eye on the government. You need to take your place, take back your power. They can, in their own sovereign power. Go and start assembling their own things, and call themselves the government.

Louise Campbell-Anthony (09:11)

That's gonna create chaos. That's the... that's the main reason why I say We have to keep the chain of authority. From the... from who it is who holds that authority. To every little county, town, government that is popped up. So it can have the... place, and the title, and the authority to be the American government, or else we'll have all little pieces Of counties and stuff populating all over everywhere, and there'll be just chaos.

Louise Campbell-Anthony (09:45)

When we get our chaining wheels off. Then we'll be established. Nobody's gonna say, you're not the American government, because, no, they won't, because we already have got that chain of authority established, and everything is established. That's why we can't just... do it on our... do... just go elect whoever we want to elect.

Louise Campbell-Anthony (10:01)

And just call ourselves the government. Now, you might have a difference of opinion, and we can talk about that, but that's how it's established right now, and I agree with how it's established right now.

Louise Campbell-Anthony (10:16)

We want to utilize the ombudsman service that we have available. Uh, some counties don't have an ombuds service. The international outreach service is there, uh, I mean, international ombuds.

Louise Campbell-Anthony (10:31)

Service think tank is available for those counties who don't have them bus. Set up yet, and even if you have issues with your current state assembly ombuds service, you still can utilize the International Ombuds Service to try to see what what... what is within your power that you can do to resolve that conflict?

Louise Campbell-Anthony (10:51)

You want to write down and implement decorum for your assembly meetings. We have to have that on how to address assembly meetings. Now, I'm gonna get into entertaining your questions here in a little bit.

Louise Campbell-Anthony (11:02)

And just so you'll know. Some of you already know, I will mute you. So that we can minimize Conflict! We have to be... and look at your little... look at the little, um, the chart that I gave you, the comparison language chart.

Louise Campbell-Anthony (11:18)

When you want to talk about different situations that you have. And... and you're upset about it. You have to say it a certain way so you don't trigger other people who's listening.

Louise Campbell-Anthony (11:30)

And paint... paint different, uh, the wrong picture. Um, and that type of thing. So... I'm gonna say it right now, that when we start talking, when... and listening to each other.

Louise Campbell-Anthony (11:43)

We might have to... Well, I don't want to... and I'm not muting you to censor you, I'm muting you to say, hey, get professional, if you... say what you want to say professionally.

Louise Campbell-Anthony (11:54)

Okay? But if you can't say it professional, you'll stay muted. Nicely, I'm saying, okay? All right, so... We want to... you want to have that decorum set up in your assemblies.

Louise Campbell-Anthony (12:08)

This is one thing that I'm... this next D, I'm gonna ask Anna for. Create our own Federation vetting Committee for county coordinators. We could... I could see we can do that.

Louise Campbell-Anthony (12:19)

Because what I know of a federation vetting committee is just... it's made up of state coordinators. The one we have now. County coordinators are a federation... uh, offices, so... Can we just take some of the county coordinators who's already been batted and create our own vetting committee?

Louise Campbell-Anthony (12:38)

And let's keep it moving. Uh, so that's... that is what I'm going to ask Anna about. And that would be a critical part for us to actually get moving, because it's kind of bagged up.

Louise Campbell-Anthony (12:49)

Um, we have to have that county coordinator in order for it to be recognized as a assembly. Adopt oversight of assemblies... assembly committees and officers. Now, oversight is one of the things that I mentioned already.

Louise Campbell-Anthony (13:07)

That we have to be able to hold Our assembly officers accountable. How can we do that? So, this assembly of 13 sovereigns language is something that I had brought to the PKTF of an idea of what we could do to try to hold assembly officers and assembly government committees responsible and accountable I thought, well, maybe we can have And I called it 13 Sovereigns because I want to go all the way down to the banner woman, who don't have any office in the assembly at all.

Louise Campbell-Anthony (13:47)

So, some sovereign. Who's not in the government capacity at all. Serving on this assembly... assembly board, or assembly committee, or whatever you want to call it.

Louise Campbell-Anthony (13:59)

We can have 13. Only reason I thought of 13 is because of, um, the amount of, um... I think I called it 11, actually. The amount of... uh, postal areas. I was just trying to... say, one per poster area, there's 10 poster areas, and I think I put... One more, 11, for a tiebreaker, if there was a tie on any decision, things like that.

Louise Campbell-Anthony (14:20)

So, but it could be anything. They thought, well, maybe 33, since it's gotta be two-thirds to go to a

Congress. So, it could be any number, but the idea is to have That rat watch we talk about, that Anna talks about.

Louise Campbell-Anthony (14:33)

Watching our government, we need the same thing for our American government. When I look at our government, I ask myself. Would I allow the de facto to do that?

Louise Campbell-Anthony (14:46)

If I don't allow the de facto to do that... to do that. I don't allow the American government to do that. We should have a higher standard of what what our conduct is, what we're actually uh, what we actually allow.

Louise Campbell-Anthony (15:00)

To happen. And the... the ones who... responsible for that is the sovereign. The sovereign who... consented to have us govern them. And I'm using the Sovereign in this sense because we talk about, uh, in our conversations.

Louise Campbell-Anthony (15:18)

Our emails back and forth. We know and understand that the... The one who's actually in charge is the sovereign. It's not the committees. It's not the coordinators.

Louise Campbell-Anthony (15:31)

There's not any office, government office. The sovereign is who all these government offices answer to. So if we could create some type of oversight committee. Where the sovereigns um, could be the ones who... hold us accountable, review us.

Louise Campbell-Anthony (15:48)

Or have some type of report card. They could review the county assemblies and the state assemblies, like, uh. You have a review every year or something. And they'll look in your documentation to see what you've been doing, you know, what votes your drill assembly had, what boats your... what case is your oversight committee took, and what was their findings, and what was the evidence, and... What is your Melissa militi... Militia commander doing, and how does he network with the other... counties and stuff. Whatever the job description or role description is.

Louise Campbell-Anthony (16:27)

The point is to have some type of oversight committee of sovereigns who's going to rat-watch the American government. I am not naive to think Just because we're the American government, all of us.

Louise Campbell-Anthony (16:44)

Are angels. All of us are peacekeepers, and all of us self-govern. No, we don't, because we already talk about all the conflicts we have. But we need to be able to hold people accountable and hold the committees accountable.

Louise Campbell-Anthony (17:01)

And that was just one of my ideas. Of doing it. Another idea I came up with And I'm spending some time on this because we do have to put something in our foundation for this specific thing.

Louise Campbell-Anthony (17:14)

So, the other thing that I thought about is. Maybe on every county website. Government website, you have a, uh... Are we, uh... Government accountability report portal. Report portal.

Louise Campbell-Anthony (17:30)

Something like that. Call it something like that. What a report portal would be is where people on your county. Who had some conflict, maybe went through your... your ombuds service.

Louise Campbell-Anthony (17:45)

And a finding was paying down, and they was not They thought that... that your ombudsman is incompetent, and that is not correct. What finding they came with. So, you might want to report it.

Louise Campbell-Anthony (18:01)

And you... you would put your, uh, affidavit, I would say an affidavit in the form of a testimony. Because you're going to report it. Under... under penalty of perjury. You're not gonna say... you're not... we're not gonna allow lies to be put there.

Louise Campbell-Anthony (18:17)

And if... if you are lying, and be found out to be lying, then you'll be... held accountable for your lying. So, if anything goes in that portal, it has to be under testimony.

Louise Campbell-Anthony (18:27)

And it would say, hey, this is what happened, this is my evidence, and this was the finding. So, it'll be out there for the public to see. That was an idea that maybe every county web... government county website Our state website can have a portal like that.

Louise Campbell-Anthony (18:47)

What I find here, like, just with the de facto. When it's time for elections. They start these smear campaigns. Some of it may be right, some of it may not.

Louise Campbell-Anthony (18:58)

But I thought about that. I'm like, why you didn't tell us before? Now it's time to elect somebody. It's like... that type of information should be already there. When it happens, report it.

Louise Campbell-Anthony (19:12)

And then the American public knows the record of the particular... office, or officer, or the assembly. So if they want to elect this person again. Or not elect this person again, they'll have They'll have this evidence to review.

Louise Campbell-Anthony (19:29)

I'm thinking we are a government So, just because we have coordinators and recording secretaries, and... sheriffs and whatever, elected. Now, there's, like, elected within the assembly. But what they are supposed to be elected is publicly elected, from the American people.

Louise Campbell-Anthony (19:52)

And yes, we... I don't know how your assemblies do your public elections, or if you have any, uh, have your... if your state have done any yet. But you... you are telling the people it's time to have an election, just like all these other elections you're used to in the de facto.

Louise Campbell-Anthony (20:10)

Here are your candidates. What... where can they go to find out something about the candidates? That would be your portal, where they will find out something about the candidates.

Louise Campbell-Anthony (20:22)

And not only that, the portal can be used for recalls and things like that. Even before elections. But that's an idea. It's just... it's just brewing in my mind right now.

Louise Campbell-Anthony (20:34)

Uh, because we need to have some type of oversight of our American government. From the beginning. The de facto will want to know The American public will want to know how we're... how they're gonna hold us accountable, because they know how they... when they go to the, uh, their local people, their local elected officials.

Louise Campbell-Anthony (20:59)

They have problems with them. They want to know, well, what's gonna make you any different? If I'm gonna be... if you're saying the American government, how am I gonna hold you accountable?

Louise Campbell-Anthony (21:09)

We want to be transparent enough to let them know, hey. We... you have an obligation, you have a duty to hold us accountable, and we're gonna make it easy for you.

Louise Campbell-Anthony (21:20)

That could backfire, though. So, I'm just thinking. Um, I'm just thinking of the possibility of having some type of oversight of our American government.

Louise Campbell-Anthony (21:30)

And having that available for the American public to see. The second, um, F here, Secure Recording Secretary. So I did, uh, put a question out there to, uh, about finding out what the Federation Recording Secretaries list is. That's a conversation that's been going back and forth.

Louise Campbell-Anthony (21:48)

That's to help us get That part moving along. As we're out there trying to... get people recorded, you're gonna need access to recording secretaries, which is a problem with some of the counties right now.

Louise Campbell-Anthony (22:05)

So maybe we can get, uh, some training done. And maybe we can get some more recording secretaries. And then find out what Federation recording secretaries will be available to record, no matter what county.

Louise Campbell-Anthony (22:18)

Uh, needs help. They can help any of it. We'll have to let the treasurer. Uh, because money is going to be involved. When you go... we're going out there doing outreach.

Louise Campbell-Anthony (22:29)

You gotta spend some money, so you need to have somebody responsible for the money, and accountable. Uh, to that responsibility. We talked about the word organizers, now I'm back and forth. Elect county organizers. I'm not sure to call it organizers or coordinators now, because there is a difference.

Louise Campbell-Anthony (22:47)

The coordinators, uh, from the Federation... uh, not from the Federation, but are there temporarily. The organizer would be the one that's elected in, as I'm thinking the chair. I think Rocky, uh, Rocky and Tim was talking about this idea. They'll have to clarify with me if I got this right.

Louise Campbell-Anthony (23:03)

But Court County organizes, as you all were saying, is someone that's elected by the people. Uh, but... and that, in my mind, would be like a chair. The chair of the county assembly, which would be different than what a county coordinator is.

Louise Campbell-Anthony (23:19)

But I think now, the way we use organizer for County Organizer is what we're meaning by county coordinator. So we're gonna have to get that straight. What terms we're gonna use.

Louise Campbell-Anthony (23:31)

But we will need this... this person here who is separate from the coordinator. So, uh, that's one of the... one of the... foundational pieces I think we need.

Louise Campbell-Anthony (23:46)

Develop training modules for county coordinators, recording secretaries, county organizers, and treasurer. Those four offices... definitely, I think, needs training modules, so they can know what they're doing.

Louise Campbell-Anthony (24:01)

What not to do. Where to get help. A place to, uh, um... go with their questions. This, I think, is important to have It's one of those foundational starting points.

Louise Campbell-Anthony (24:14)

Then the last thing is start drafting the handbook. Uh, that outlines these duplicatable steps. Step 1, Step 2, we probably might not call it step one, step two, but... How we're saying that at the foundation, we need to have these things established in your county, so when we start... when we start going out there in our outreach.

Louise Campbell-Anthony (24:33)

And getting counties, um, getting nationals recorded. We'll be able to tell them where to start. Start here. Find these people here. Here's where you go to get that one trained. Here's where you go to get that one vetted. We'll have all that in this handbook.

Louise Campbell-Anthony (24:50)

So this is what I see as the foundational pieces to getting an assembly, a county assembly. Started in the right direction. And what you all, as model counties.

Louise Campbell-Anthony (25:00)

Need to check off, why do I have this? Do I have that? Do I need to check this off to see if you have it available? Uh, in place in your model counties. And as you're looking at this, is there something you think is not really a foundational block?

Louise Campbell-Anthony (25:17)

To standing, um, to establishing your county solidly. Or is there something you think that... Here's a foundational block that you should... that we want to add.

Louise Campbell-Anthony (25:26)

To this list. Okay? All right, so now I'm going to entertain your questions. I see, um, we got Denise here first.

Denise (25:39)

Hi, everybody! Hey, Louise. Great presentation again, as normal. Um, a few things that came up in our state and county meeting last night. Is we have a brand new members. And we had one member, he said he wanted to be a recording secretary.

Denise (25:57)

And the sheriff. And he joined last month. So, uh, we have a lot of this I guess, new people with a lot of energy, and they're very excited to help, but the issue comes that they don't have a lot of knowledge.

Denise (26:16)

Um, I see that your oversight of assembly committees and officers' conduct could be a real potential for people who feel disgruntled, unhappy. Suddenly they're... this is, you know, they kind of gather up, and they're... They use it as, like, an attack platform.

Denise (26:37)

And we've seen that happen already. About a month ago, we received an offer. From a brand new member, that he um, felt that we should have a think tank, and he should be in charge of a lot of things, and he didn't even know who Anna Von Reitz was.

Denise (26:56)

So this is, you know, an issue where you've got Um, I would say that people that have maybe practicing Patriot, you know, they were in LLA, they were in the Oath Keepers, they were in other... groups. They come here, and they're excited.

Denise (27:15)

But they haven't really taken the time to... study. So that's kind of one of those things that it can be great. But then it could go sour so fast, and then now we're the... people trying to get something done on the assembly, and then you're just getting all these drama emails with you know, I don't like this, we're getting together, we're gonna get you removed, and, you know, you just can't get anything done.

Denise (27:43)

Um, causes a lot of static. I love your idea about creating your own federation vetting committee for county coordinators. Um, I would also say that perhaps We could look at that for state.

Denise (27:57)

Um, as long as the people are background checked. And one of the background checks we should definitely be having is that the coordinators and all the people on these committees are actually on the LRO.

Denise (28:14)

I've been doing some checking, and you would not believe the amount of coordinators in the states that are not even on the LRO. Um, it's a lot. Also, Rick, I don't know if you can hear me, Rick, your microphone has been on the whole time. I can hear everything that's going on.

Yes.

Denise (28:34)

Yeah, not a problem, thanks. Thanks so much. Um, the other thing that I saw was that these training modules for coordinator Recording Secretary, county organizers, and treasurers.

Denise (28:46)

Quite a bit of this is in the, um, Annavon Rights. Dot com handbooks. Uh, are there other handbooks you want us looking at? Because we've been developing quite a bit of training material, and we have a portal.

Denise (29:02)

For training materials, so... I also, um, send people to PKTF a lot. And I think that you have some great info there. So if there's something else that we need to be doing.

Denise (29:15)

Just let us know. Um, and that's all I've got right now, so thank you for everything. I will... Great meeting today.

Louise Campbell-Anthony (29:22)

Thank you, Denise. So, your training modules there. If, um... Well, what I would... I would propose is we get one, a training module. Uh, it could be... those training models that you all have, are they, uh, videos, or are they in print?

Denise (29:41)

So, their print and videos. We've taken Ana has a lot of clips.

Louise Campbell-Anthony (29:44)

Okay.

Denise (29:47)

And so we had some stuff from... America, some assembly required. We had some things from Anna's... mop and bucket. We have... her handbooks. And then, of course, I did just some searches, so if you go on on eventrights.com and you put in Recording Secretary.

Denise (30:09)

There's a lot of articles about reporting secretaries, and what I like about it is it gives real-world examples. About what's going on and what to do, what not to do.

Denise (30:21)

But we also found out that there's some... I'll call it... It's... it's a chain where a coordinator has a preferred recording secretary. And then that person was in... improperly recording people.

Denise (30:38)

And then they were not being put on the LRO. And we have quite a few of those people. We actually have to go back and do an audit. Of one whole particular group of people.

Denise (30:52)

But, you know, it's like there's only 8 or 10 people that can even perform this kind of work. On our assembly, and we're still assembling, we're doing outreach and all these other things, so... you know, it's... it's one of those things that Rocky's actually taking a lot of time, and he's going through each And every record.

Denise (31:15)

And make sure that they're even appropriate, or that they're even real people.

Louise Campbell-Anthony (31:20)

Hmm. Did those recording secretaries go through the training y'all have?

Denise (31:26)

Oh, this was not a training issue. This was actually a... Um, it was a deliberate... Mm-hmm. Yeah, so the oversight is just endless, you know?

Louise Campbell-Anthony (31:28)

Oh. Oh. Okay. Okay. Well, I like to, uh, see your training modules, if you can give me access to see that. We can see if we can... we can get one.

Denise (31:41)

Yeah. Yeah. Mm-hmm, I would love that. I did make a note, too, you had the portal of the public notice, so we are adding a public notice to our website. I love the idea.

Louise Campbell-Anthony (31:49)

I mean, just get it put in a hand box. Yeah.

Denise (32:03)

Four notices that I would call them to be national, or maybe international. I'd love to see PKTF have a public notice board, for example, elections. Um, that's a great one. You know, why am I giving thousands of dollars to a newspaper?

Denise (32:20)

Wouldn't it just be better to have our own, um, at least For some things. So, yeah.

Louise Campbell-Anthony (32:29)

Okay, thank you, Denise. Okay, Annette?

Denise (32:29)

Alrighty, mm-hmm, yeah.

Annette (32:34)

Thank you very much, uh, for... hosting this again, and Denise, a lot of great stuff, and I apologize for being late, I was at an art awards ceremony for my daughter, again, uh, which is plus, it's a plus. I attached in the... in the chat A policy and rule list that are marshal at Arms came up with a long time ago.

Annette (32:54)

When we first got a brick and mortar and allowing, or shouldn't say allowing, inviting, uh, volunteers to come in. And so that we had, like a government, I should say, like the government.

Annette (33:07)

We had, uh, we have rules in place about maintaining order, ensuring safety, and ethical behavior, because we're... we're really dealing with a lot of very.

Annette (33:19)

Very sensitive information. That if it were to get out, could alter people's lives, um, similar to hacks, you know, for credit cards or hacks on department stores and this vital information gets out on the black web.

Annette (33:34)

And or somebody nefarious gets their hands on it, and so it's really critical that we do B, government, and that we behave in And, um, the people that are coming in touch with all of that very detailed information. I mean, they have everything about your parents, where they were married, yourself, your kids, there isn't... there is pretty much nothing That isn't touched. And so we feel that our position is even more delicate because we have so much information, and you know, we're trying not to look ragtagged, we're trying to be very professional, so we have behavioral expectations, and I included it there.

Annette (34:11)

Uh, on... in the chat that I thought might be very helpful for anyone that wants to use it. Um, so, you know, we were approaching, um. A lot of stuff with regards to... uh, vetting. I used to be a Chamber of Commerce our chairman for a city, and so I learned a lot of how things operate in business, and how things, you know, should run.

Annette (34:38)

On a county or a city, and so I, you know, I don't do that anymore, but I've brought a lot of that here to the system, and so we found that it's very... it's very good for organizational purposes that Uh, everybody can see how it's supposed to be run. And then making sure that that security is the highest... Uh, the highest thing. So, as you guys have probably already all heard.

Annette (35:03)

Because we found... people that are accessing severely important sensitive documents have felonies. To me, that would be, in my vetting And please correct me if I'm wrong, but we... We do not allow, on this county, and I should use the word allow.

Annette (35:20)

We make sure that... people that are coming in contact with all of our members' personal information are not people that have issues with the previous law, right? So, that was part of our vetting process, is that we make sure that We're holding to a standard the same as the pretty easy as the government, so that everybody takes it very serious.

Annette (35:43)

Um, and so, I thank you for introducing the CMS vetting program. I think that's a really good idea. To teach all of us how to do it properly. Um, in our office, uh, there is a lot of detailed steps to go through for making sure that anyone's touching anyone's sensitive information is properly vetted,

and that they're not I mean, we don't want someone absconding with people's stuff, and... doing horrible, horrible things, right? So, uh, that is a big, a big thing, and it has gotten, uh, Marion County in some trouble.

Annette (36:18)

But, uh, anyways, um, I do thank you for bringing this to the level of properly addressing acting like a government, being a government. Um, I don't know if we're gonna have a process that's similar to Bondable.

Annette (36:31)

Maybe that's something we can talk about, um... you know, anybody that's got fraud or impersonations or serious drug charges and things like that, they really... Shouldn't be touching people's private information because there's an opportunity for them to abscond with it, or do something nefarious, so I just... that's just a suggestion.

Annette (36:51)

I also put a question out this week about We've had 4 more people lose their homes. Uh, and that is getting ever too common, and so we didn't know if there's some kind of uh, uh, you know, in the other world, they do a GoFundMe.

Annette (37:09)

Uh, to just help out, making sure they all have food, making sure they have some clothes, making sure they have stuff. So that we can also project care into the counties and into the states Or not necessarily in the state. For my case, it's in the county that we're showing Uh, we don't have, you know, come and get your check, but we have resources that we can help out.

Annette (37:32)

Men and women to say that we are... we are actually government, because they're so... until we transition, they're so... uh, hooked on government helps them out. Government saves them. We have to teach them to be independent, but in the meantime.

Annette (37:45)

It doesn't hurt for us to have a heart. And help them out with all of that. Um, going back to the notices, so what we did is we do... election notices on the web, on Telegram, and in the newspaper.

Annette (37:58)

Uh, some of them as much as a month ahead, saying what the job is and what they're gonna do. And, uh, just letting the public know. And then we, um, we allowed... we had noticed that there was a meeting, and when the meeting's gonna be.

Annette (38:12)

And, um, and what the positions are, and who's running for those positions. And then we posted it, we did our elections on our meeting, it was all recorded, both in prints and, uh, you know, recording the meeting Virtually. And then we posted it in the paper for a full month.

Annette (38:31)

Uh, the regular papers, so that it indicated to the general public who, what, where, when, and what for, and so that it was really taking on a very professional presentation to the general public. And, um, we got quite a bit of Quite a bit of response from that, and it was really good.

Annette (38:51)

Um, and then my other thing was. When I took this county over, I was told we had 173. So, similar to Denise, I was told we had 173 members. And then, with the help of Angie, we found out we had 32.

Annette (39:05)

Well, actually, we built it to 32. Um, we actually had more like 7 or 8 when we went through them all. So what that was is a ton of stuff in pending, a ton of stuff that maybe an email had come through.

Annette (39:18)

And they had put it into the list of Here's all... who's on your county, and so it was a daunting task to go through that, and very disappointing, to be honest When we got to the bottom of the list, and there was almost no one left.

Annette (39:31)

Um, and so we've had a really big uphill battle of rebuilding, and thank... thank you, Angie, for being our... our... saving star, and she just moved into the county, and as a recorder, it changed everything, and we got... We got to a point that

Louise Campbell-Anthony (39:31)

Yeah. All right. Thanks, Annette.

Annette (39:47)

She's like an angel. She doesn't charge almost anybody for any paperwork or anything. Uh, we've been blessed that we have volunteers that also donate for paper, ink.

Annette (39:58)

Things of that nature, so that it is... also looking similar to a government office, that they're getting services. I hope that's been of help to you.

Louise Campbell-Anthony (40:11)

Um, uh, Rocky? Can't hear you. Now, I cannot hear Rocky, can anybody hear Rocky?

rockie roper on Nevada (40:32)

Okay. Yeah, it wasn't letting me unmute. Okay.

Louise Campbell-Anthony (40:32)

Okay, I can hear you now.

rockie roper on Nevada (40:36)

Um, I just wanted to touch on... what, uh, Denise and Annette talked about on the recordings. What I found out is, I don't know if you remember. Uh, Luis, back in 2021 and 22, We were running on the LRS.

rockie roper on Nevada (40:56)

And LRS got hijacked, and... Federation couldn't get control of it, okay? And when that happened. Basically, we were supposed to move everybody from the LRS You get all their paperwork and put them in the LRO.

rockie roper on Nevada (41:13)

Well, a lot of people wasn't informed, or they wasn't... able to do that, for some reason. Okay? And so, what I found out is there's a lot of people that have their paperwork.

rockie roper on Nevada (41:29)

And it was done in, like, 21 or 22, right? But they was, for some reason. In the LRO, they got messed up somehow. And what I'm doing right now is I'm going through all of those people and trying to correct their paperwork.

rockie roper on Nevada (41:44)

And the corrector... account on the LRO. Okay? So, we do have a lot of these people, but, like. Like what Annetta was saying was that Um, when you go back and look, and you'll see pending, you'll see a lot of stuff on these people.

rockie roper on Nevada (41:58)

And that is why. It's because they wasn't... Because basically what needs to happen is the person needs to get on the LRO, create their account, put in their email address.

rockie roper on Nevada (42:08)

And that email address will get... an email will get sent to you. And then you need to verify that this is you. Right? This is a security issue. And then once it does, then it will create you an account.

rockie roper on Nevada (42:20)

Once the account is created and verified that it's you. Then it will be opened up on the LRO. That at that point, uh, the recording secretary can then get on there and put your paperwork in your account Okay? So these are the things I've been finding out, and I'm trying to correct them for a few people.

rockie roper on Nevada (42:40)

It's just... when you've got 300 people in your state. And you're trying to go through every one of them, it's just... that's a lot of work. But it needs to be done. We need to fix these people and get them back on the land.

rockie roper on Nevada (42:52)

And get things corrected, and... With that, I yield. It's just... It's a work, but we gotta do it. Thank you.

Louise Campbell-Anthony (43:01)

Thanks, Rocky. So it sounds like everybody needs to do it. Need to do an audit of your county. Uh, might have some mistakes in there. Um, Tanya?

Tanya Wilson (43:16)

Hello, everybody. Um, I'm still obviously looking at this as a possible model county here on Madison County in Alabama. Um, after Denise spoke, I did look up some recorder articles by Anna, and I came across something called Question and Answers for Assemblies. It does not have the article number or the date on it, unfortunately.

Tanya Wilson (43:39)

But at the time, this was, uh... was released by Ann, it says, see this article in over 2,700 other articles, so it's been a while, if she only had 2,700.

Tanya Wilson (43:51)

But it says, can a state coordinator also be a county coordinator? It says, there are no county-level coordinators because coordinators work directly for the United States of America and international jurisdiction, and counties have no international interface.

Tanya Wilson (44:06)

So how are we dealing with that issue? Um, and also, I mean, how does that affect recorders? I mean, we don't... you know, how are we addressing that? I yield.

Louise Campbell-Anthony (44:19)

Thank you, um, Tanya. So... it said there are no county coordinators, right?

Tanya Wilson (44:30)

Correct. There are no county-level coordinators. Let me clarify that

Louise Campbell-Anthony (44:30)

Okay. So, that has... Okay, so that has to be, um... something old? Because even in her... in the, uh... How to build an assembly, past county coordinators in there.

Louise Campbell-Anthony (44:51)

And... talking to her? Like... like, a few days ago? Um, there's county coordinators. So, it hasn't been old And I know things have changed over the time... over the... over the course of time.

Louise Campbell-Anthony (45:06)

But that's the best explanation I can give for that one. It has to be old information.

Tanya Wilson (45:13)

Okay, I mean, I can accept that. I'm just trying to put everything in proper perspective. Um, before we, you know, take off on this project, there's a lot of work involved, and people will have to make a lot of commitments.

Tanya Wilson (45:26)

To make this work, I mean, we've been stripped down to really nothing. Um, here in the state of Alabama, and uh... So, I'm just trying to... to determine the best way to move forward. Thank you to the person for the policies and rules list, I like that.

Tanya Wilson (45:46)

I like things that are clean and to the point. Uh, not a lot of verbiage for something that doesn't need to have it. Um. So our... so we're in the process of developing how the counties are going to be built. I mean, I guess my mind, in my mind, I'm questioning Do I go by the America Sun Assembly required videos to take people through this process? What's the next step once they go, yes, we want to do this?

Louise Campbell-Anthony (46:20)

Yeah, so, um... We have some counties here. Uh... Denise, you own a county. And you got your hand up. Let's answer... Tanya's question first. Kenya? Denise, how did y'all go about it?

Tanya Wilson (46:42)

You're muted, Denise.

Denise (46:45)

Thank you, thank you for that. Uh, we were very fortunate. On Clark County, we have a husband-wife team, Michelle and Craig Schmidt. And Craig was a... okay, so this answers your question too, Louise.

Denise (46:59)

Instead of him being a coordinator, he was a county facilitator. Because he was also involved at the state level. And that kind of took care of the fact that he wasn't really a quote-unquote, a county coordinator.

Denise (47:14)

But he was actually never a state coordinator, but he served in the role. I'll say that. And Michelle is on the call, she can... talk more about that. But on the model county, um, PKTF has 3 options.

Denise (47:29)

So you can choose to keep the framework you have now. You can alter it slightly. Or you can go by the way of option 3, which was... what Clark County did.

Denise (47:41)

And since we had Craig and Michelle, and they took us so far, we've almost been stood up 3 times. Um, we had a lot of infrastructure here. So it's not going to take us too much more to get up and running.

Denise (47:56)

Um, but I would say that you're... Your best thing is to grab your website. And then get your seals. And start building out that website, and then do your outreach at the same time.

Denise (48:11)

So, as far as America assembly required and all that, I like those videos for, like. They describe bondsmen. They describe sheriff. There's a lot of great training in those. But there's so much in the handbooks, and if you go on Anna's website. If you just type in any word, uh, recording secretaries is a good one.

Denise (48:37)

You know, there's great information there. So that's... that's what we did, but we had already been doing quite a bit of what this list is. So we don't have too much more to do, because We've already had some elections and things, so I yield at that.

Louise Campbell-Anthony (48:57)

Okay. Rocky? We're gonna see if we get some more answers for you, Tonya.

rockie roper on Nevada (49:05)

Okay, can you hear me? Okay, back... back, uh... Craig and me actually joined at the same time, and 2021, okay? And from there, we actually started building our county, okay? So what we did is, if you take Basically, the two pillars of the four pillars.

Louise Campbell-Anthony (49:07)

I can hear ya.

rockie roper on Nevada (49:24)

Is really county kind of related. On how to build your assembly. So we... started building our juroral assemblies, we got our sheriff, we got our coordinator.

rockie roper on Nevada (49:33)

We started building, you know, the aspect of a government, right? But county-wise. And basically, we got all the positions filled. That you would need in a county to raise the county. You know, your courts.

rockie roper on Nevada (49:47)

Uh, you adjusted the Peace, you're... you know, we basically had all of those in place. And we've been doing that for the last 3 years. You know, building our county. So our county is fully kind of functional.

rockie roper on Nevada (50:01)

Um, the last parts that we need And we needed the state to help us, and that's where we got blocked. Craig got blocked from... Trying to help stand up the other two pillars.

rockie roper on Nevada (50:10)

You know, with the state, because we had basically everything else we needed for the state to run the... to pull up. And that's what I would suggest people do, is Start building your juror assemblies, start building your... get your share.

rockie roper on Nevada (50:24)

Get all the people that you would need in the first two pillars, right? Your General Assembly, you know, start having your meetings. And that will help you build the county portion of the state.

rockie roper on Nevada (50:37)

Because... because the deal is, is if you're building your counties. You're also building your states. Right? And if you're building your states, then you're building your counties, because all the people are in the counties.

rockie roper on Nevada (50:48)

Right? So you have to take it in an approach to... basically get some counties up and running. So that they can actually support the state When the state stands up. And that's our approach, that's what me and Craig came up with to... to try to help get the state up and running, and then have some backing once it's up and running.

rockie roper on Nevada (51:09)

I yielded that.

Louise Campbell-Anthony (51:11)

Rocky had a little strategy there, no? Okay, um, thanks, Rocky. Michelle? Can't hear you.

MICHELLE (51:24)

I'm trying to unmute. I'm sorry, it took me all this time to figure out how to raise my hand. Um, so I want to back up a little bit. With, uh, people that are having problems, uh, finding people on the LRO, you know, because of the LRS problem.

MICHELLE (51:41)

When this all came about. I went through... all of the records in our file. You know, we keep a nice locked filing cabinet. And I... emailed or called each person.

MICHELLE (51:57)

In that file to gain their permission to switch them over from the LRS to the LRO, explaining what was happening with this... happening with the systems.

MICHELLE (52:07)

Now, the problem is... And I don't know how, you know, the rest everyone else is working. We only have the files of the people that we've recorded. So, if other recording secretaries in the state did not contact the people that they had on the LRS, to gain permission and move them to the LRO, that's why we're missing so many people.

MICHELLE (52:35)

So, um, my suggestion is, choose, uh. Even us, choose, like, a lead, uh... Recording secretary, or a place to keep all of the records have each recording secretary send in a report to the lead or the coordinator so that we can have Everyone on the list, and not miss when we want to, um... go over and find out who's where.

MICHELLE (53:07)

I yield.

Louise Campbell-Anthony (53:08)

Thank you, Michelle. Okay. Now, any other questions? We're gonna move into our homework. Homework I done gave y'all. Um. We got... and we have 5 minutes, so... in respect of everybody's time.

Louise Campbell-Anthony (53:27)

I wanted to see if I could... have one of you, one of the model counties, if you have it. Prepared, uh, to see what your homework looks like. Do we have any model counties who did number 6?

Louise Campbell-Anthony (53:45)

Map out your state nationals purse. Uh, recorded in each state, create a baseline. Of your funding. Write your, uh, Assembly comic resolution protocols.

Louise Campbell-Anthony (53:57)

Any model county have this homework assignment? Perform assembly reconstruction vitals check. Do you have your organizer properly elected? We don't even have... oh yeah, that's the organizer, not the... not the... Not the coordinator. Get paperwork properly, did you do... did you have, uh, the vitals check done for your assembly?

Louise Campbell-Anthony (54:20)

And did you discuss which pathway you're gonna take? This is what Denise was talking about. The pathway you take into approach your county, seat-to-seatment. Uh, you can do the International State Assembly, we'll focus on the seatment first, you can do it that way, while you just focus on your outreach.

Louise Campbell-Anthony (54:36)

I can do number 2, focus on seeding your county and your state. At the same time, or you can focus on number 3, Um, seating all your union, um... your union state, so all your counties.

Louise Campbell-Anthony (54:52)

And let... that the, uh, other... the people from your counties trickle over into your international state. That's what she was talking about. You're supposed to speak to your assembly, your county assembly, to see which ones you all wanted to choose, which strategy you wanted to take on.

Louise Campbell-Anthony (55:11)

So if nobody has any homework to show us. So, what I would like, uh, and then these are the instructional videos I wanted you all to take a look at. So what I would like for, between now and the next meeting.

Louise Campbell-Anthony (55:24)

If any of you could get Some of this down on paper and send it to me so I can take a look. So, I can assess where we are, um... where the... each county is at.

Louise Campbell-Anthony (55:36)

That... then I could... Appreciate. And if you have any questions about this. Then just email me, let me know what questions, uh, if you want me to explain anything or anything like that.

Louise Campbell-Anthony (55:51)

Okay? So, continue with this homework, and any of those who are here who want to who's considering being a model county, this is the homework we're working on.

Louise Campbell-Anthony (56:02)

Here. So you can... uh, start working on, uh, well... let's make it official first, because if I need to keep a track of everybody Any other questions? Along with that homework, I also put in the... did I put in the chat? If I didn't put it in the chat, I'll put it with the replay.

Louise Campbell-Anthony (56:24)

There's 3 implementation guides. For this project. And I want everybody to, uh, get them. One is the first implementation guide is the one that covers all six phases of the project.

Louise Campbell-Anthony (56:38)

That the International Outreach Think Tank developed, so that... that has an implementation guide of all the all the projects, then the second implementation guide.

Louise Campbell-Anthony (56:48)

Is for the peacekeepers, the peacekeeping Task Force, for that phase, Phase 3, Where it involves your militia commander, your county sheriffs. Uh, your PKTF liaison. That particular phase has one implementation guide for itself.

Louise Campbell-Anthony (57:06)

And then there's a... Where you see the blue and the yellow is how we... how the strategy task force has been changing everything as we go along. That's what the color codes mean. I'll keep it like this until I finalize them all.

Louise Campbell-Anthony (57:21)

Then the last, uh, the last implementation guide is called the This one is for the American State Assemblies. This basically is talking about the public meetings, getting out there in the public, and what we're going to say.

Louise Campbell-Anthony (57:34)

When we have our public meetings. So, and it's... so this is also what the county assemblies will be saying. So it's the same thing. And I'm actually doing another... A fourth one, because I want to get down to the town. The American town is missing.

Louise Campbell-Anthony (57:53)

And the model counties, and all the counties is going to have the tasks of getting the townspeople organized as a town. As opposed to a township. So, I'm thinking about doing a fourth implementation guide to focus on that aspect.

Louise Campbell-Anthony (58:09)

So, I'm giving you all those three for you to read over. How the project is going to be executed in more detail if you haven't If you haven't downloaded it already from my other video.

Louise Campbell-Anthony (58:20)

Yes, Tanya?

Tanya Wilson (58:21)

Uh, one last question. Um, since we're really... bare bones here in Alabama. Uh, we don't have any sheriffs, we... we do have an MAA at the state level, but he's... not, um... as active as I would like to see him be.

Tanya Wilson (58:43)

Uh, with getting things done that need to be done. I do have people in other counties in the upper part of Alabama, we were kind of calling ourselves the Northern Alabama group, because all of us were up here.

Tanya Wilson (58:58)

Can we have other people from other counties helping us in the beginning? Or do they have to be in Madison County? I yield.

Louise Campbell-Anthony (59:08)

So, this is called a Congress in Training because all the counties need to come together uh... as a union state. So, yes, you can have other counties helping you. Um, so we... because that's working together.

Louise Campbell-Anthony (59:24)

And us practicing, uh, being able to work together to get the common goal achieved. At the same time, we know, you know, you know separately who you are.

Louise Campbell-Anthony (59:36)

Yeah, yeah, that's what the model county's role is going to be.

Tanya Wilson (59:36)

So then they would... they would kind of learn along with us the process, and then take it back to their county. Is that the idea?

Louise Campbell-Anthony (59:48)

Is to get... get the framework put together. And duplicate that in every county in your state, your union state.

Tanya Wilson (59:58)

Okay, I just wanted to make sure and clarify that, because I wanted to send out a... an email for a meeting next week, and I just needed to know who should be on...

Louise Campbell-Anthony (01:00:10)

Mm-hmm. Thank you. Yes, Annette? Oh.

Pauline White (01:00:11)

Luis, this is Pauline. One last question. Um, the American government resurgent Project this year that I'm looking at, was that sent out to everyone?

Louise Campbell-Anthony (01:00:14)

Colin.

Pauline White (01:00:19)

Like, to each clerk account, like, to counties. Is this something that we could have to read later on? Is this something I could get my hands on later?

Louise Campbell-Anthony (01:00:23)

No, it wasn't.

Pauline White (01:00:31)

So I can read later on when I have time.

Louise Campbell-Anthony (01:00:32)

Yes, I'm not sure if I put it in the chat, but if I didn't put it in the chat, I will be sending it out with the replay.

All right, thank you.

You're welcome. Annette?

Annette (01:00:43)

I'll say thank you for that too, please. That was one of my questions. So, I have, um... we have about 6 counties that we've been helping with right now.

Uh, some of them are wanting to get their websites up, because we seem to be getting a lot of interest through the websites. Um, do you... have you had a chance to go through ours? Is there anything that you would tell us to change?

And is it wrong for us to have it live right now?

Louise Campbell-Anthony (01:01:10)

No, it's not wrong to have it live. Um, I think the big question was, Marian, Marion County, right? I'm talking... yeah.

Annette (01:01:18)

Yes. Yes. Yeah. Mm-hmm.

Louise Campbell-Anthony (01:01:20)

We have to get that issue resolved as far as you all being... dissolved. Um, which is now resolved. Um, so yeah, it's not, uh... You can have it live, uh, and I liked... I did give you some input on what I'd seen.

Annette (01:01:30)

Thank you.

Louise Campbell-Anthony (01:01:38)

And... Uh... I mean, I can take a look at it some more, but yeah, you can have it live.

Annette (01:01:44)

Yeah. Okay, yeah, you've been extraordinarily helpful, and um... you know, honestly, I think I can speak for the rest of us if we didn't have you, I think we'd be a loss... A lost pack. It's been an extraordinary journey since you've come on, and you've given us This, uh, momentum again that we were all starting to feel that it was falling apart, so thank you from the bottom of my heart, like, I'm so serious.

Annette (01:02:10)

Yeah, so we're helping with other counties. We're getting ready. We've had discussions with them about doing public venue things, and going out and doing Uh, you know, markets and... all kinds of events that are going on in their counties as well, and so we're just kind of... In a way, saying, when can we get active? So we're all biting at the bit here, waiting to get active, because we don't want to step on anyone's toes.

Louise Campbell-Anthony (01:02:38)

Yes, so outreach should always be happening. The State Assembly should be doing outreach, county assembly should be doing outreach. For this particular project, the American Government's Resurgence Project. Our outreach is... is going to be focused only on public meetings.

Louise Campbell-Anthony (01:02:59)

That's the outreach this project will do, because we are introducing ourselves to the public as the American government. So, the outreach that you all been doing now, keep doing it.

Louise Campbell-Anthony (01:03:09)

Whatever, you haven't barbecues, you haven't picnics. You have been library meetings, whatever you're doing. Do what you know... the reason I picked... certain people, I started out at first, I'm like.

Louise Campbell-Anthony (01:03:21)

I need to find somebody who's doing the work. So I... I actually invited Kalina. I said Kalina, she's out there doing something. Hey, Annette, they're out there doing something. So I asked you all, do you want to be part of this? Because y'all already out there doing it.

Louise Campbell-Anthony (01:03:38)

So, whatever it is you're doing for outreach. Keep doing it. You're gonna pivot a little bit once this gets kicked off, because we're gonna do mainly just public meetings. But you can't do this yet until all the paperwork, the websites, the brochures, and cards, and
