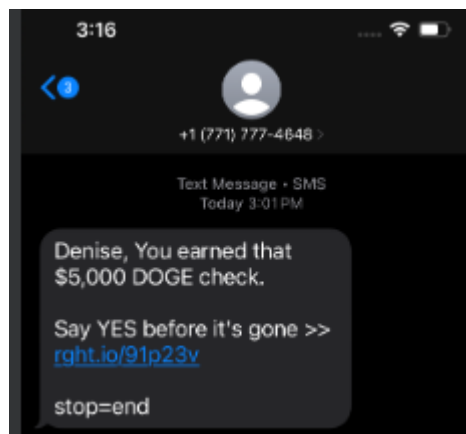
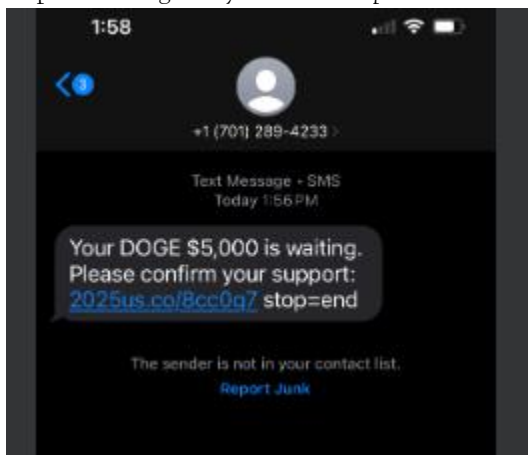

- Ombuds service request email needs to say in subject line: OMBUDS SERVICE REQUEST (all caps).
- You will state in the body of the email (no attachments-the email will be more secure and easier to track if all communication is written in the body of the email) what your conflict is in discreet and self-governing terms.

In the body of the email as “How Do I Resolve This?”

Identify parties and places something like this as an idea:

- Yourself as “I”
- Transgressor 1, Transgressor 2, so on
- Witness 1, Witness 2, so on
- Bystander 1, Bystander 2, so on
- Location 1, Location 2, so on

Describe the conflict as clearly as you can, in a chronological order of events. Do not send any attachments for evidence. As a matter of fact, don’t send any evidence. If you want, you can copy and paste screenshots into the body of the email, but screenshots cannot have any names of people or places or office titles. That kind of identifying information must be redacted. The screenshot needs to show dates and times.

This claim support is the Ombud can assist you with identifying the elements and claims of a crime.

Handwritten Witness Statement with your wet ink signature and testimony states your name, date and.

In this presentation, I am telling the truth and the whole truth to the best of my ability to know the truth, in order to create and provide a video deposition for the use of courts and prosecutors worldwide."

The counties create the Nation State, then send their delegates to Congress.* The International State is an outside world international interface and is called The International State Business Assembly. People is supreme to any Assembly, county or state. The business of the Assembly should never run over its members, especially twice!

When Land is added to a role(officer/appointee) or Assembly, they become international; therefore, there are no living people on a land jurisdiction, only soil contains living people. So any form of International State is comprised of and overseen by electors/delegates from soil to union of soil equivalents (counties made of towns of People). Any International State Assembly is a corporate entity of unincorporated people and they volunteer there in a capacity of lawful persons.

; *County*: The Clark County Nevada Assembly, The United States, Unincorporated (a union nation of towns populated by People) possess all authority and have a public duty to exercise it, this local county government is made of People from towns.

; *Towns* are the soil where People live. The interface of People is the County, comprised of towns.

; *Counties* elect Delegates/Electors to oversee the Federation International State Assembly and all its functions, and any form of subversion of a County and its People is a grievance to redress through due process beginning with private communication.

sponsor Public Elections for your State Legislature and fill the long-vacant Deputy offices to serve in your actual Congress.

We don't need huge numbers of people (though we would like that) who are qualified to speak for their States of the Union. A minimal quorum of thirty to thirty-five qualified Electors is desired, but in a pinch, even one qualified Elector can invoke the power of the entire State under The Last Man Standing Rule. To be a qualified Elector of your State of the Union and of The United States of America (bear in mind, these rules have not changed since 1860 and can't be changed until we convene a Continental Congress to change them) you need to: (1) be able to prove that you had ancestors who were here and either born on the land of a state or fully naturalized State Citizens prior to 1860; (2) that you are a landowner; (3) that you claim your birthright political status; (4) that you are at least 21 years of age; (5) that you are a free man --- not indentured or enslaved -- which was generally assumed for Caucasians; (6) and are male. Our research indicates that contrary to what was believed initially, race was not the controlling issue prior to 1860 with regard to Elector status. Any man could always be an Elector, so long as he was not enslaved and not indentured. His status as a Free Man was the controlling issue. Women were never Electors though they could own land and other property. Until a legitimately formed and styled Continental Congress can make changes, these are the rules, and we need to abide by them.

That doesn't mean that you cannot or should not join your State Assembly if you aren't able to act as a qualified Elector. The Electors need the support and insight and assistance of everyone else to do their jobs. Electors are Fiduciaries for their States and bear a great responsibility. The rest of us can help them by doing research, building the supporting organization, providing transportation and meeting spaces, even cleaning the toilets and fixing lunch.

There are a myriad needs and tasks that need to be fulfilled and there's nobody here but us chickens to do it all. All those Federal and Federated State and incorporated County Employees that are ultimately on our payroll to provide us with "government services" operate in a totally different jurisdiction and literally can't do any of our actual work of self-governance for us. Our initial efforts to organize the States located a minimum of a few men in each of the pre- 1860 States sufficient to make the claim on behalf of the States. This supplements earlier work done to establish the continuity of the evidence of our lawful government from before 1860 to today by the Nation States project and numerous other efforts.

*The author/publisher took the intent of Anna' s recourse as should be applied to a transgressor, but Rockie and Denise are not transgressors, so this would not apply to them.*

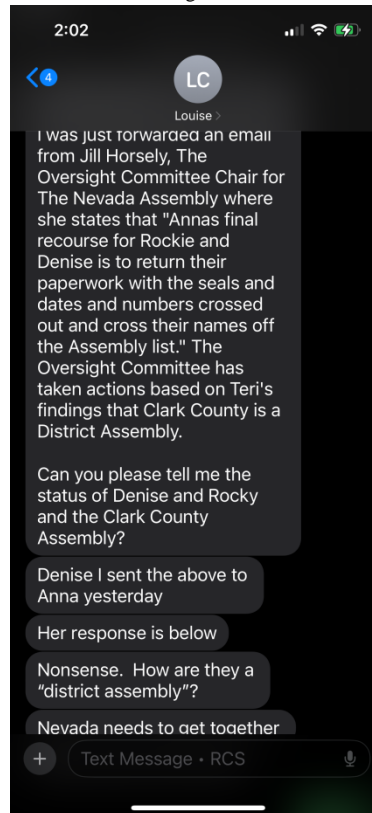

That's not how we do things.	I'm curious how your suggestion might work here.
Why didn't you do that?	Is there a reason that didn't happen yet?
You always mess things up.	I've noticed a pattern that might need attention.
Calm down.	I hear you. Let's take a moment and breathe together.
You need to listen.	May I share something and then hear your thoughts?
This is a waste of time.	I feel we might be off track—can we revisit the goal?
You're being difficult.	It seems like we're not aligned—how can we find common ground?
Nobody agrees with you.	Some may see it differently—would you like to explain more?
That's not my problem.	How can we support each other to move this forward?
