Mission 2028: We propose that we make our public debut as America's only government onto the world stage in a 3-Day Public Event. How much louder and clearer can we get than this? The purpose of the 3-Day Event is to be the culminating event of this 6-phase Project to finally take to the world stage and present ourselves to the world as the Federation of 50 in full force backing our Fiduciary, Anna. To the world, we now tell our story and announce we have taken the control of America's governance back from our Subcontractors. They are guilty of Breach of Contract and Breach of Trust.

As our American Government makes our debut onto the public stage as the Federation of States to earn the recognition as such, it is important and most strategic that we lead the conversation with the most pertinent issue. That is, in my opinion, the Crime. The International Public Notice postcard or email succinctly informs them:

- 1. A crime has been perpetrated against you
- 2. Who committed the crime
- 3. Who we are that is reporting this fact to you
- 4. What we are doing about
- 5. What you need to do about it to get your remedy

Our State Assemblies will focus their approach on the American public by providing the International Public Notice via the campaign funnel and also by holding public meetings throughout their State. The purpose of these Public Meetings is to empower the American public to apply the necessary public pressure on the federal and state corporate heads and elected officials using our Declarations of Land Law regarding Birth Registrations

and Federal Reserve Notes

credit monopoly.

The intended outcome of Federation negotiations is to formulate a timeline and deadlines for the role out of our "onefell-swoop" remedies and the "transference of government" reforms or changes we are requesting. This is the most effective approach – to have the directives to be issued from corporate heads, top down to the subordinates. If we can achieve this at the Federation level, all operations at the State level will fall

more easily into

place.

Commanders, their State Continental Marshals and their PKTF Liaisons will inform and notice these corporate head executives, the County Sheriffs, the Governor, and the State's Secretary of State, of the treason of their Principal's on the Federal level and other crimes they may be complicit with if they fail to cooperate and/or capitulate to our peaceful transference of government directives. The first Counties that we will initiate our first contact across the nation will be the County that has the State Capitol building and Governor's office located in it.

### **Project Goals:**

- 1). Gain the Recognition of America's only government from the American public, our government services Subcontractors, and the world nations; and
- 2). Achieve a systemic solution to get remedy for the American people that will end the criminal fraud perpetrated upon us by our Employees, the Principals and their Subcontractors, who are the British Territorial U.S. parent corporation and the Roman Municipal United States parent corporation and their entire conglomerate of commercial corporations in the business of providing government services.

### ClaimYourInheritance.info Website Funnel

This is how our massive International Public Notice campaign funnel goes:

- 1. Starting with an International Public Notice Campaign, you will target your Counties per Zip Code. You can mail, email or do door-to-door community canvassing. We have 2 types of postcards for that and one of them can be branded to your particular Assembly, if you want to launch your campaigns directly from your own website. The first County will be the County that has the State Capitol in it. The Notices are addressed to the public from the Federation officially.
- 2. The Notice sends them to this website's landing page here: claimyourinheritance.info, that has the International Public Notice video on it.
  - o The International Public Notice video does several things...
    - highlights the fact that every American has an inheritance and what it is;
    - informs them of the fraud that continues to prevent them from accessing that inheritance. And what is that inheritance? your birthright political status and your public and private assets;
    - tells them how to claim their inheritances by contacting their local State Assembly to inquire further;
    - refers them to the Detailed Research also on the website to learn more. The Detailed Research educates them on what our predicament is and why they need to declare their birthright political status in order to claim their inheritance. It's divided into 4 parts We Declared Our Independence in 1776, The Fraud Perpetrated Upon America, The Fraud Perpetrated Upon the American and No Longer Asleep at the Wheel. It's categorized into 13 sections totaling 189+ pages and includes a "search key topics" glossary to guide the reader into a more in-depth education experience. There are actually two versions of this. A team of 4 of us revamped the first version that totaled about 300 pages of a cut and paste of Anna's articles. The Assemblies will be provided with both; and
    - Links to the Detailed Research and the State Assemblies are cited in the video and they both have tabs posted in the website's Menu bar right there on the page too.
- 3. The 50 State Assembly's website links listed underneath the video on <u>claimyourinheritance.info</u> will get them in touch with real people who will validate for them that we are real and the information is true. To reinforce our "realness," I have linked to our State Assembly interviews being conducted by Tammy on New Jersey.
- 4. The last step to this campaign funnel is for the Assemblies to follow-through and schedule a public meeting in that County where the Capitol is located to introduce the people to their American government -- State Citizens, Assembly officers and Committeemen/women, face to face. This is Phase 2 of The Resurgence Project. We will have Notaries and Recording Secretaries to witness autographs on the spot and get people status-corrected. Then the Recording secretaries would collect their papers and follow through with publishing them. People will show up already having been introduced to the knowledge on the website.
  - We coined the phrase "Our Commitment to The Declaration of Independence" County Tours as a title for the Tours throughout the State to capture the essence of what we are doing by having these events and to broadcast this message into the public's psyche.
  - o I created a webpage on this site specifically here <a href="https://claimyourinheritance.info/our-declaration/">https://claimyourinheritance.info/our-declaration/</a> where the American public can be directed to at your public meetings and get engaged by placing their "John Hancock" in the form on the page to symbolize their commitment to the Declaration of Independence and proclaim it to the world. All Assembly members need to go there too and put your John Hancock in the form.

- o I also created two brochures, "What Does Political Status Mean?" and "Why You Need to Correct Your Political Status?," to distribute at these County public meetings and throughout our communities or people can download them right from the site here: <a href="https://claimyourinheritance.info/what-does-political-status-mean/">https://claimyourinheritance.info/what-does-political-status-mean/</a>.
- Then you rinse and repeat for the next County or group of Counties per zip code(s). This is the systematic approach we envisioned. Running your Public Notice campaign first in the County where the State Capitol is located sets the Assembly up for the "Secure the Capitol" outreach mission that will be led by your elected Peacekeepers. I will explain that more in detail later.
- 5. Meanwhile, up until the County public meeting, the website provides other resources that gives legitimacy to us as America's government. We have the Arrest tab with the Situation Updates disclosing the reality of our Employee/Employer relationship and interactions with the U.S. government services corporations. Federation Webinars are also linked here to encourage the American public to listen to our Fiduciary's reports.
- 6. Lastly, is this 1776Union.tv tab. This content is intended to give a preview to the American public of our intent to tell the truth and disclose the truth about any and all topics relevant to the governance of Americans and to point them to where that truth can be found and relied upon.

This is the Mass International Public Notice Campaign Funnel that we built as a systematic outreach system that the Assemblies could adopt as their own to be implemented by their Outreach Committees. They can simply rinse and repeat per County Zip code(s) to achieve our rescue mission in a steady, targeted fashion and stand and seat each County strategically and systematically until all of their Counties are seated, which is our ultimate goal.

Our Desired End Result of these campaigns is to Witness Autographs, Record and Publish Declarations (Birthright Political Status) and get GFG Bank accounts (Birthright Prosperity Account) opened for all Americans.

# "The Teeth" Strategy


Take from them, the British Territorial Government, their TWO main weapons:

  - o We need to brand our url across all our State Assemblies to broadcast the message of a unified Federation of 50 States, and their County Assemblies.
  - We need our url to signify what jurisdiction that our government operates in to be noticeably different from our subcontractors.
  - o We need to layout clearly our American government functions and our government services.
  - Most strategic to embed a "State of the Federation" address delivered by Head of State, James Clinton Belcher and Ivan Talbot on behalf of our Foreign State Assemblies

### Our Weaknesses:

- State Assemblies are not focusing on constructing "The United States" which is our actual seat of government at the County levels; State Assemblies are instrumentalities.
- State Assemblies infrastructure not constructed to ensure self-governance, checks and balances, accountability and protection of the integrity of the body politic and not regarded as a qualification for Seatment.
- State Assemblies and Federation not building networks with other groups that profess self-governance and uphold Constitutional Rights.
- Our American Government is not in the mainstream public's awareness; don't know we exist.
- State Assemblies are operating on a false premise that we need to Seat our Assembly and Courts to get recognition.
- State Assemblies don't act like they are the Federation of 50 Nation States that have the power. Anna is not the Federation. She works as Fiduciary for the Federation which is the 50 Nation States. We need to take actions as a Federation to get recognition as a Federation and move into our rightful place.
- State Assemblies and Federation have no long-term strategic plan to get control and maintain control from our corrupt Subcontractors.
- State Assemblies and Federation are not focused on building a business relationship with their Employees which can't be done with Notice writing.
- State Assemblies don't realize they have all the power they need to accomplish their recognition with just a standing General Assembly. They get no more power by becoming Seated.
- We are not working "smart" enough to retire Anna and Jim before they retire themselves meaning transition this life on to the next.

- A timely launch of the project is decreasing our chance of stopping our Subcontractors end run, due to Fiduciary not able to make yet another thing a priority.
- We need to have regular business meetings to plan for our American Government's long-term projections where both our international and national leaders come to discuss, evaluate, problem solve, project and plan. Government is business.
