In light of the overwhelming opportunities the State of Alaska subcontracting Boroughs, Cities & Courts have been given to recognize and receive awareness of the People/people of the Land and Soil Jurisdiction, it has become blatantly obvious the willingness of the State of Alaska Corporation and Sub Contractors to ignore this reality.

This ignorance is no excuse and clear "cause to know" has been exaltedly proven by presentation.

Cease your unlawful acts of trespass of God Given Rights on the living men and women of The Alaska Assembly, Alaska Land & Soil Jurisdiction.

The State of Alaska's Boroughs overstepping its corporate jurisdiction onto the living people and the damage it continues to cause has reached the necessary point of resolve and possible compensation.

Reference the Updated Fee Schedule accompanied with this Notice as well as the links referencing Recorded notices, particularly notice the "Color of Law" charges that could be implemented if this trespass of God Given Rights is not terminated.

You are required to respond to this Notice of opportunity to resolve within three days.

Resolution required; Release the American civilians of the Land & Soil Jurisdiction. These American civilians of the Land & Soil Jurisdiction can and should be officially handed over to our Land & Soil Jurisdiction Supreme Court to be tried by a jury of their peers. The Alaska Assembly has and will provide the Civilian Court necessary to bring the Americans before a jury of their Civilian peers.

Our Alaska State Supreme Court on the Land and Soil jurisdiction is operational and suited to receive our American civilians to be tried by their "jury of peers". According to all three Constitutions, there is a right, and as an American a guarantee to a "jury of peers". Our Civilian Court does and will provide that for Americans on the Land and Soil jurisdiction. Your Corporations are not equipped to facilitate Americans with a "jury of peers", being American civilians, which are not subject to the Foreign British law of the sea.

Stand down, return these Americans to the proper jurisdiction of which there is a lawful guarantee to be tried by peers.

The American Common Law Supreme Court has invoked Ex Parte Milligan and consequently, your corporate court is required to stand down.

These Americans, non U.S. Citizen, non- citizen of the United States are not subject to any corporation contract you are assuming. The American living men & women have no contract with the State of Alaska, their Municipalities of the Kenai Peninsula Borough, Anchorage Borough or the City of Homer, and are not subject to your Corporation by-laws, Statutes, regulations, rules or policies. A "Statute is not Law:" (Flournoy v. First National Bank of Shreveport, 197 La. 1067, 3 So. 2D 244, 248)
The 1945 International Organization Immunities Act relinquished every public office of the corporate United States to the United Nations. State and Federal agents acting as [FOREIGN] STATUTE MERCHANT DEBT COLLECTORS have no access to sovereign immunity and can exercise no other power or privilege which is not derived from the corporate charter.

Bouvier Dictionary definition of Color of Office: wrong committed under "pretend" authority.

Your court corporations are operating under a Color of Government with "pretend" authority.
All Officers of your Corporate Courts are required to register as Foreigner Corporation employees and they are foreign to Americans/America and its people.
The American people/People are not subject of Corporations without the people's willingness to contract, not a subject of the King/Queen of British Territorial Rule, not subject to the Popes Municipal Church.

Impersonating people as a corporation or unwilling subjects to your corporation are a violation of the peoples God Given Rights and Substantial Law of God. Americans, stand under substantive law, not foreign statutory law.

Prove by evidence a willing contract, bring that substance to light. It is essential that presumption, of which all of your charges are based, be revealed. Produce that contract you claim these American civilians have with your Corporate Court, Corporate City, Borough or State.
