Attached is the most recent Postal Domestic Mailing Manual Publication 223, June 2025 which lists all national Postal Service directives and forms, as well as government forms and documents used by the Postal Service. On page 59 it specifically lists the "Directives Free to the Public" of which the "LABEL 200 Registered Mail" bar code sticker is to be given to the public for free. (See attached)

Hope this helps everyone to be able to send out free registered mail. I also attached the "pre-paid" labels we have been printing out and using in accordance with the Post Manual rules for Non-Domestic Fully Pre-Paid Stat. st Law, Ch. 71, Sec. 23, Federal Offense to collect additional postage under 18 USC 1726 ("without the United States") and UPU RL 114 (2.2).
