Ideal "Transference of Government" Execution

End Goal: Empower and Assist townspeople to lawfully and officially declare themselves an unincorporated American Town and accept duty of governing their own communities (Accomplish this to achieve recognition as America's sovereign government)

<u>Two Public Meetings</u> at one designated location: 1st public meeting - Introduce the reconstructed State and County Assemblies; follow-up 2nd public meeting – County Reeve (Sheriff) and County Assembly direct the reconstruction of the American Towns

The County Assembly will host and post the upcoming public meeting. The County Assembly will present the State Assembly to the public at the 1st public meeting. They together will present the restored American Government to the people – the State Assembly and all County Assemblies that are within a 2-hr drive radius could be present at this public meeting.

Government exists by the consent of the people.

State Assembly Tours

Role: Present the public with International Public Notice - the fraud and usurpation of America's sovereign government but now restored

- Outlawed Birth Registrations –
 no citizenship by birth (14th
 Amendment) and ended birth
 registrations and birth certificate
 bonds are evidence of human
 trafficking
- Outlawed FRN credit theft monopoly – FRN is evidence that your credit is being stolen from you every time it passes from one hand to another. FRN's will be taken out of circulation for its based on chattel slave labor

- Provide the public with Declaration of Land Law re Birth Registrations
- 2. Provide the public with Declaration of Land Law re FRN
- 3. Provide the public with Criminal Information Notice of Liability that notifies the public of the penalty if continue to be complicit with crimes
- 4. Need to establish evidence of status correction on the public record by declaring yourself an American
- Inform them of their inheritance as an American waiting for them to claim by opening their Prosperity Account
- 6. Notify the elected corporate head officials of your correction to the public record and that you did not intend and do not consent to the crimes

County Assembly Tours

Role: Inform the public that the Municipal Corporation is Chapter 7 bankrupt liquidation and all its franchises are in transition to being nationalized.

No more Municipal Cities and Villages.

- 1. Declare yourself an American
- Rescind your consent by removing name from the voter registration rolls of the foreign U.S. British Territorial corporation

- Declare your community (village or city) a self-governing American
 Town Provide Brochure of Steps to take to Self-Govern
- Townspeople prepare to hold an election to elect (not vote – that's for shareholders) your public officials
- Elect your County Assembly officers and City/Village officers – particularly your Sheriff and Deputy Sheriffs



<u>For State Assembly</u> – Outreach Chair, Public Safety Chair, General Assembly Chair, PKTF Liaison, Militia Commander, Recording Secretary, Public Notary

<u>For County Assembly</u> – Outreach Chair, County Reeve (Sheriff), Deputy (Reeve) Sheriff, PKTF Liaison, County Organizer, Recording Secretary

The County Assembly has to "reach out" and it has to "reach in," because its jurisdiction affects both the State Assembly's reconstruction and the American Towns reconstruction.



Peacekeepers "Transference of Government" Tours

With/without utilizing the "Secure the Capitol" Strategy (need an elected County Sheriff)

Role: Peacekeepers maintain the peace and order while the Tours are going on by interfacing with the corporate heads and elected officials requiring their cooperation to assist in this transference taking place in their communities. Send down the orders.

Peacekeepers:

- 1. County Reeve (Sheriff)
- 2. Deputy Reeve (Sheriff)
- 3. PKTF State Assembly Liaison
- 4. PKTF County Assembly Liaison
- 5. State Militia Commander
- 6. Deputy Continental Marshal
- 7. Area Chief Continental Marshal

De Facto Officials and Corporations to visit:

- 1. Secretary of State
- 2. Governor
- 3. Attorney General
- 4. Hospitals (human trafficking)
- 5. Postal Union/Post Offices (mail fraud)
- 6. Municipal Court houses
- 7. City/Village Mayor and Board
- 8. Township Supervisors and Board
- 9. County Board/County Recorder

Peacekeepers must deploy in graduated waves (First line, Second line, Third line) and multiple times to increase potential for cooperation and/or capitulation to transference of government. Clearly convey and empathize with what this means for the livelihood of individual man or woman you are addressing and the real criminal implications if they don't course correct.

- Present the De facto Officials with International Public Notice - the fraud and usurpation of America's sovereign government but now restored
- 2. Provide the De facto Officials with Declaration of Land Law re Birth Registrations
- 3. Provide the De facto Officials with Declaration of Land Law re FRN
- Provide the De facto Officials with Criminal Information Notice of Liability that notifies the public of the penalty if continue to be complicit with crimes
- 5. Need to establish evidence of status correction on the public record by declaring yourself an American
- 6. Inform them of their inheritance as an American waiting for them to claim by opening their Prosperity Account
- 7. Notify the elected corporate head officials that you have contracts (Constitutions) with of your correction to the public record and that you did not intend and do not consent to the crimes

Inform Territorial and Municipal corporate elected officials they need to declare yourself an American to correct the public record and inform corporate heads or they need to register with FARA

Inform de facto officials and employees the Municipal corporation franchises (cities, villages, courts) are bankrupted and being liquidated and nationalized. Allocated space for American government, raise Peace Flag, post Correct Status in publications and on walls on building, post PKTF Reference Guide poster visibly as notice to your employees in the building

Municipal Postal Service complicit in mail fraud – how do we liquidate and nationalize?

State Secretary of State complicit with issuing birth registration of birth certificate bonds – how do we liquidate and nationalize?

Hospitals complicit with issuing birth registration of birth certificate bonds – how do we liquidate and nationalize?

County Government buildings allocate space and resources for County Assemblies to record property claims – how do we liquidate and nationalize?

County Courthouse buildings allocate space and resources for County Assemblies to operate Courts – how do we liquidate and nationalize?

How to prevent Civil Unrest, Civil Protest, Civil War: Critical Role of the County Reeves (Sheriff)

Packaging the Message: What we Americans are witnessing in real-time today is the fall out from one of our federal subcontractors, the Municipal government service provider has filed Chapter 7 Involuntary Bankruptcy and is now defunct as of October 1, 2020. A process that started with the Pope when... – (explain visit back 2008 – Pope issues...). It has taken a series of actions to finally dissolve that subcontractor for breach of trust, breach of contract and fraud. Our second federal subcontractor, the British crown corporation has been partnered with them since 1840 and the most recent contract between them was in 1937 agreement called *The Declaration of Interdependence of the United States Governments*. This mutual agreement places them in the current position of auditing that bankrupted corporation and redistributing the assets and inevitably undergoing its own reconstruction having lost its business partner and our 2nd Subcontractor responsible for providing America's municipal government services.

In this way, the British Crown Subcontractor is assisting the American Government with transferring the power back into the hands of the sovereign people, you. Your current incorporated Cities and Villages and Municipal Courts and Municipal Police Departments that services your communities today are franchises of this Municipal Subcontractor. They must be liquidated and nationalized, and you must take on your responsibility to now self-govern. You townspeople will need to organize and officially declare yourselves as an American Town, unincorporated, to establish your sovereign status and in acceptance of your priority creditor position (need a brochure 9 Steps to Self-govern). To have the proper standing to execute this lawfully, you must first correct your political status on the public record and declare your birthright as an American State National – Illiniosan, Wisconsite, Utahn, etc. – or if you are an immigrant, you would adopt the American State National political status of the State of the Union that you live upon if you are eligible.

Fortunately, we have equipped and poised America to take on our governing responsibilities at every level of government just in time to meet the challenge of this liquidation of our Municipal Subcontractor. Our American Government has been working to reconstruct itself since 1998 and today we have our American Federation in place, our States of the Union, all 50 American State Assemblies are in session, our American County Assemblies are organizing and our American Towns are the final governing body politic in our republican form of government which we were guaranteed would be preserved that needs to be established. This is the reconstruction that was supposed to have happened in the aftermath of what was reported to America as the "American Civil War" in 1863. It was really a mercenary conflict between commercial corporations – the North and the South Confederation of States businesses - who were supposed to have been providing America with good-faith government services but instead perpetrated a hostile take-over. So, the reconstruction of our American government never happened due to this usurpation of our federal Subcontractors in breach of trust, breach of contract and fraud.

To make it the job and role of the County Reeves (Sheriffs), to be the one to deliver this message at the public meetings in our County Tours, I propose, would be the most prudent strategy of our American government's resurgence campaign to minimize potential for civil unrest, civil protest and civil war.
