As you know, Coordinators step forward as ASN volunteers, are trained, and take up their task of helping their State get organized.

But there are actually two States that are being organized -- to one degree or another -- at the same time: the State of the Union, which is what we are concentrating on right now, and the Union State arising from the Counties, which is becoming another focus as counties get organized.

It is my understanding that Rocky stepped forward to assist as a Co-Coordinator, has been vetted, and so, accepted as a Coordinator in Nevada.

That doesn't mean he is the "only" Coordinator in Nevada.

There may have been a confusion as to which "State" he is helping to organize --- the State of the Union or the Union State (at the County level).

I suggested that Nevadans resolve any such confusion by continuing to call the State of the Union Assembly: The Nevada Assembly, and calling the Union State Assembly: The Nevada Union State Assembly.

Please talk to him and iron things out so that everyone knows what is going on. Everyone in Nevada is eligible to participate as part of the population of the Union State at the county level, or the State of the Union level, or both.

As a Coordinator or Treasurer or Banking Committee Member of the Nevada <u>State of the Union</u>, Rocky can serve as the GFG Bank Contact, but, please note that banking is an international activity, so it falls under the purview of the State of the Union, not the Union State.

All GFG wants is a steady, agreed upon contact person that they can entrust with a secured email and phone access to GFG Help Desks.

The idea is that instead of trying to field fifty million calls from individual account holders, there will be one contact person on each assembly whose job will be to act as the go-to person for people to ask for answers to bank questions. The Bank Contact can then use the secure lines to get answers.

Okay? That's the purpose of asking each State Assembly for a Contact Person.

I personally think that it would be suicide for any Coordinator to act as the Bank Contact, but that's me. I am advising each Assembly to look for someone who has a good phone and internet service connection, hopefully someone with the patience of Job, and a sterling character, to serve as Bank Contact. At least initially there will be a ton of questions.

Again, it may not have been clear that it's the State of the Union that is being tasked with this, not the Union State.

Please reconnoiter among yourselves and sort out your differences and understand the different roles and jurisdictions involved.
