4. In response to your email where you stated:

I am not certain where the Resurgence Project and the Model Assemblies effort fits in all this or if it does fit in the PKTF baileywick, but we are all learning day by day. I realize there is a real need for an established weekly meeting time and am trying to find it.

The PKTF's role is to evaluate, educate and coordinate efforts between de jure and de facto government counterparts in the area of peacekeeping according to the Charter. That's a tall order. It has a myriad of interconnections in between to make all of these communication channels effective in achieving our desired end results. That's where The Resurgence project fits. We are going for the systemic solution that you talk about. We are that PKTF that we talked about in our last Directorate meeting with you where you recognized needed to have been there after the Civil War happened when we needed to let the people know our government needed to be reconstructed. That's where The Resurgence Project and Model Assemblies fit in.

Now, we need the State Assemblies to see the role they place in the strategy behind The Resurgence Project. They are so focused on "Seatment" that they have sacrificed "outreach," which is our foundational mission. That is, to rescue Americans. They don't see that they can't reach "Seatment" without "focusing" - yes, focusing - on outreach into the local communities.

We can't restore a government of the "living" people when the "living" people don't show their faces AS THE GOVERNMENT in the local communities and even display their names and faces on their "government" websites. (Yes, they need to have government websites. Most of them don't and think their educational websites are "government" websites.)

We need you as Fiduciary training our Coordinators to promote the project to the State Assemblies so they view the PKTF as providing them this service for the benefit of all the State Assemblies in support of their efforts to reconstruct our government. That's what The Resurgence Project was designed to do. However, every one has to fulfill their role in the project for it to achieve our desired end goal that should have happened 160 years ago.
