RE: Notice of Constitutional Violations and Demand to Vacate Contempt Order Against Eugene Thomas Pang
Matter Concerning Summary Contempt – Request for Immediate Judicial Review and Release

Dear Clerk of Court and Officers of the Court:

This letter is submitted by a next friend regarding the incarceration of the living man Eugene Thomas Pang, reportedly placed into custody under a summary contempt order issued by Judge Eleni Dimitriou Geishauser.

This communication constitutes formal notice of constitutional violations and a demand for immediate remedy, as the record reflects that Eugene Thomas Pang was denied fundamental federal protections before being deprived of his liberty.

I. Violation of Right to Counsel (6th and 14th Amendments)

In *Argersinger v. Hamlin*, 407 U.S. 25 (1972), the U.S. Supreme Court held:

> “No individual may be incarcerated under any charge without the provision of legal counsel unless such right is knowingly and intelligently waived.”

Similarly, *Gideon v. Wainwright*, 372 U.S. 335 (1963) affirms the right to court-appointed counsel in any proceeding where incarceration is a possible outcome. It is our understanding that Eugene Thomas Pang was not provided counsel, nor was such right knowingly waived. This alone renders the contempt order constitutionally void.

II. Due Process and the Right to Be Heard (*Cooke v. U.S.*, 267 U.S. 517 (1925))

In *Cooke*, the Supreme Court made clear:

> “A man cannot be deprived of liberty without an opportunity to be heard.”

Even in cases of direct criminal contempt, where conduct is observed by the judge, summary punishment must still comply with minimal due process, especially when incarceration is involved.

III. Judicial Presence Does Not Eliminate Constitutional Protections (Taylor v. Hayes, 418 U.S. 488 (1974))

Though the contempt occurred in open court, Taylor v. Hayes limits the scope of summary contempt:

> “Summary adjudication... is reserved for exceptional circumstances... but cannot be used to bypass due process when liberty is at stake.”

IV. Right to Confront Accusers (Pointer v. Texas, 380 U.S. 400 (1965))

If any third-party claims or court officer statements were considered by the Court in its contempt finding, Eugene Thomas Pang had a right to confront and cross-examine those individuals under the Sixth Amendment. No record indicates this right was offered or waived.

V. Supremacy Clause – Federal Law Overrides State Law

Although Commonwealth v. Moody, 125 A.3d 1 (Pa. Super. Ct. 2015) allows for summary contempt when behavior is observed in court, it cannot override binding U.S. Supreme Court precedent. The Supremacy Clause (U.S. Const., Art. VI) requires that all Pennsylvania courts follow federal constitutional rulings first.

VI. Demand for Immediate Remedy

In light of the above, the undersigned respectfully demands:

1. Immediate vacatur of the contempt order issued against Eugene Thomas Pang;
2. Immediate release of Eugene Thomas Pang from custody;
3. A written record acknowledging the lack of constitutional compliance;
4. Referral to appropriate judicial authority for review and correction;
5. Entry of this letter and attached authorities into the docket as a formal notice of claim.

VII. Preservation of Rights

All applicable rights are preserved under:

U.S. Constitution: Amendments I, IV, V, VI, VII, IX, X, XIV;

Pennsylvania Constitution: Article I §§ 1, 8, 9, 11, and 13;

UCC 1-308 and UCC 3-402(b)(1);

Case law: Argersinger, Gideon, Cooke, Taylor, Pointer, Bloom v. Illinois, In re Oliver.
