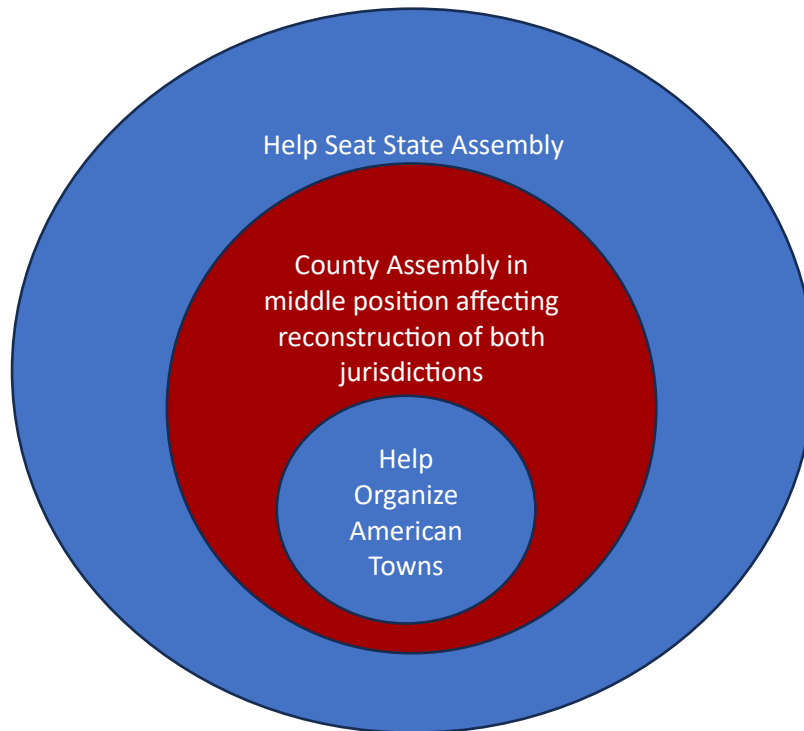

4. Resurgence Coordination Teams are Comprised of these Offices on every County Assembly:
  - a. County Assembly Outreach Chair or County Assembly Organizer/Coordinator
  - b. State Assembly Outreach Chair
  - c. County Reeve (Sheriff)
  - d. PKTF State and/or County Assembly Liaison
  - e. State Assembly Militia Commander
  - f. Deputy Continental Marshal
5. Organize and Deploy
  - Identify Interested County(ies) or County Assembly(ies)
  - Bring together a committed Coordination Team for the Counties or County Assemblies
  - County/County Assembly(ies) plan TWO Public Meetings
  - Hold 1<sup>st</sup> Public Meeting introducing your State and County Assembly governments
  - Hold 2<sup>nd</sup> Public Meeting with your County Assembly officials focused on the American Town reconstruction
  - Rinse and Repeat

6. Teaching/Learning Aides:

7. Resurgence Project Launch:
- a. Phases 1, 1A, & 2: Launched July 1, 2025
  - b. Phase 3 launch date: Varies by Peacekeeper
    - i. When the Peacekeeper is fully affirmed/acknowledged, uniformed, and trained – PSO and Phase 3 Training?
8. Transitioning from Interim Reports to Pulse Reports
9. Close session and set date of next meeting:
- Model Counties: Resurgence Coordination Teams Meeting #2 - Monthly 2<sup>nd</sup> Sundays – September 14, 2025
- Report: Map of State by County and how many declared nationals and indicator if the County has an Assembly in session
