This is the first of many meetings that Joe and I want to have to begin to qualify our model counties, and meaning to make sure that they're capable of doing the responsibilities that model counties are elected, or not elected, selected to do.

or volunteered to do, in you all's case.

And if there's something that we can do to help make it happen for you to carry out those responsibilities, or if something has changed from the time you said yes to the time now that makes it more difficult for you to carry out those responsibilities, we want to know all of that.

And then we want to come up with

So here are the four concerns that I've been

The first one I've heard from Denise, and correct me if I'm wrong, if I'm misinterpreting anything that I've heard or thought I heard, you tell me.

So I heard from Denise that there's two assemblies, two state assemblies going on and a county assembly going on.

There's Sue as a coordinator on one and Rocky as a coordinator on

I don't understand how that works or if that's happening.

So I'll need some feedback on that.

Number 2, when I talked to you, Denise, I thought you were leaving the assembly for your, for the reasons that I thought you, some personal reasons you explained and then all the friction that's going on, which would mean, which would need, which would mean

a vital position in the Clark County Assembly as the model county who's coordinating all the counties in your union estate would need to replace you in that position in order to carry out these responsibilities.

So I wasn't going to invite you to the meeting because I thought you were, you know, you had made a decision to leave.

Third thing, in our chats, in our

I see comments, Denise, from you and other people, but I'm talking to the model county, Clark County right now.

From you, that sounds more like gossiping than constructive.

through the proper channels, through your assembly's ombudsman, through your assembly oversight committee, however that process is, so that you can get those concerns dealt with and not deal with them on the resurgence project.

So there still sounds like there's a lot of things still going on that's unresolved for you, Denise, and it goes

It's more like you all, and it's not just you, but because we're in the model county for Clark County, I'm going to say Denise is saying things in the chat back and forth that sounds more like gossip because it's not coming forward as a constructive criticism that we can kind of face or address.

And it sounds like it needs to go through the proper channels of conflict resolution on your assemblies.

The 4th thing that came across, this one came from Denise, but it's about Rocky.

So this e-mail communication looks like it's from Rocky to Sue that says, thanks, Sue.

We have been trying to limit what Denise is doing.

So this is an indication that there is some conflict going on in you all's leadership that's affecting you being able to effectively do your responsibilities as a model county.

She says I'm a liar.

She hates me.

00:08:42 Speaker 2

She's not going to work with me, whatever.

Okay.

00:08:44 Speaker 2

So for me to try to help build the assembly, I had to keep moving forward.

And I've been doing that.

And, you know, not only in the counties, like all the counties and the state, but also in Clark County, right, which is the model county.

You know, as far as people being in committees, they have bumped out of them.

Now, Tamara is, she is now being a co-coordinator too in Nevada.

And she's been helping trying to get the definitions for the committees and try to get people, see if they're still in the committees enough we can get them back.

You know what I'm saying?

And that's been a process on its own.

So Nevada itself is going through some bad times right now.

and we're trying I'm trying my best to fix it and try to get everybody back together you know it's it's always a struggle when people feel that there's that the state is not doing or that even the counties are not doing what they're supposed to be doing or handling things right so like right now it's like uh Luis when you talked about running things through our own deal um I just we just did a vote right now that's going out right now it's going to end tomorrow

I haven't put her on a timeout or any of that kind of stuff at this point because I believe everybody should be heard and everybody should have the right to speak, right?

So I give her those times when she, you know, needs to talk or whatever.

But that's what this was, is I'm going to limit that time that she can talk, okay?

Because we cannot have a meeting and it go on for hours, you know, because we're going off topic of where we're trying to go, right?

So I have to limit, you know, it's not only just her, I'm limited to everybody to try to keep the meetings in some kind of perspective and

keep them short.

You know what I'm saying?

I'm trying to keep no more than an hour meeting and whatever else we do, we can do offline or whatever, right?

And like I said, like we're doing our oversight, whatever.

Anyway, I just sent an e-mail to Denise, whatever, that all of her concerns and

That's the reason I want this oversight committee done so we can run them through the oversight committee, do like a government's supposed to do.

That's one of the reasons for the voting committee, too, is because we have a lot of people in Nevada, you know that we're 24 hours, okay, that are working or have other issues and they can't be in meetings to vote.

So I created a voting committee so that

giving everybody a week's span to actually vote on whatever we got to do on committees and stuff, and then get those votes in, right?

So what I want to do, what I'm trying to do from now on, because Denise does have concerns and things are going on and we need to solve them peacefully as a government, right?

And also this is going to help us learn how to run our government as far as oversight and budget and that kind of stuff, right?

So when I get, once we get through Friday and I have my oversight committee, then Denise is going to be able to post her or give them her concerns and stuff.

Then they will go through the process of trying to figure out what went wrong and then see if we can solve that.

That's what I'm trying to do.

This is my whole plan, okay, of getting us back into a real government and trying to get us to solve everything in our own government.

it's like I said, I'm inviting her in the meetings and I'm trying to, talk to her about them, but I get no response from her.

So I don't know how we talk about that part.

Go ahead.

00:16:25 Speaker 1

Yeah, Rocky, we have some answers for you, okay?

00:16:28 Speaker 1

And if you've been grappling with trying to find them, we have solid answers and solutions, let's say solutions.

Pretty ironclad, actually.

00:16:37 Speaker 1

So if you, and Luis and I talked about this just the other day,

She wasn't aware, and really the need wasn't pressing until the catastrophic Hurricane Helene along the southeast coast, and five states were impacted North Carolina the most, as you know.

So what the living law firm had suggested to the federation is to insert, insist upon having multiple co-coordinators.

two, one, two, three, 4, 8, I think it was at first because there was a desperate need to really, really, really, really focus on state board of defense and emergency reaction recovery, all of these things.

Well, they got it down to three or four.

00:17:22 Speaker 1

And their only objective at that point was to assemble.

00:17:26 Speaker 1

And again, of course, North Carolina was having issues as well, a faction type

00:17:31 Speaker 1

overwhelming disagreements to where they voted with their feet and they, many of them, no longer participated in the General Assembly.

00:17:40 Speaker 1

But they need a court, they need a recognition from the federation to have essentially another essence of the North Carolina Assembly meeting for one, mainly one purpose, to help people correct their status,

focused on what it is to be part of the jury pool, and then bolster their assembly militia, their militia function.

00:18:02 Speaker 1

That was their segregated effort.

00:18:05 Speaker 1

They were still part of the North Carolina Assembly.

00:18:07 Speaker 1

So it wasn't a county function.

00:18:09 Speaker 1

It was part of the one county, the one state assembly, that they were not meeting in General Assembly, because these three or four coordinators, who was a part, separate, but still joined, you know, prepared.

distance tethered effort for the one and only state coordinator, because there is only one lead coordinator.

00:18:34 Speaker 1

But yes, you can have other co-coordinators who help across the remaining pillars.

00:18:40 Speaker 1

And that's what they were tasked to do for the North Carolina State Assembly by the Federation through the Military Affairs Liaison Office to focus on state or defense.

So there was

00:18:54 Speaker 1

That was their main focus.

00:18:56 Speaker 1

They were still together, one assembly, two separate meetings, catering to the General Assembly, which means these co-coordinators were supposed to be providing reports.

Again, they didn't feel comfortable or welcomed in the General Assembly under that coordinator's leadership, but the federation was not going to go and run the gauntlet to try to make some kind of decision to remove a coordinator because

Quite frankly, the federation is not in the business of removing anybody who are federation volunteers.

00:19:26 Speaker 1

They add to, they advocate, and that's what we do.

00:19:29 Speaker 1

We are never, you'll never find us in a business, and you'll never convince us to try to get any federation volunteer removed.

00:19:36 Speaker 1

It's not going to happen.

00:19:37 Speaker 1

It's just, it won't, it's not in the mix.

00:19:41 Speaker 1

But yes, augmenting services, volunteer for the federation on behalf of your state and your counties, by the way,

Yes, we are in the business of that.

00:19:51 Speaker 1

So that's what their role was.

00:19:52 Speaker 1

Now, to answer your question, to move you forward as a solution, you, even though you're working with your county, can pitch to the Nevada Assembly to say, you know what, I can help.

I can help as a state co-coordinator and do as you would need to do.

00:20:14 Speaker 1

to set yourself up for vetting and let your General Assembly know that you nominate yourself and that you will help with state board of defense.

So you would help.

And we can vet you, if that, or anybody, anybody who stepped up to assist at the state level on behalf of the state, regardless if you're focusing on counting, you can do your part for the state and be a state co-coordinator who is dedicated largely, significantly towards state board of defense.

Can I say something in the middle of that first?

00:20:44 Speaker 2

okay I've already been vetted for state coordinator and I've already been approved by Anna so I am a co-coordinator for the state okay?

Who who vetted you uh it?

00:20:56 Speaker 2

Went through Terry and uh the uh all the vetting stuff went through Terry we did my you know the clear check I did all that stuff right sure and then I have an e-mail that Anna says that she approves me as being a coordinator.

Okay

00:21:15 Speaker 1

Okay, now that, okay, if you could just share that with Luis, we can.

00:21:20 Speaker 2

I have sent it to Luis.

00:21:21 Speaker 2

He's seen it.

00:21:23 Speaker 1

Okay, now here's the, this helps your intent now to get it even more enticing.

I don't want to put too much on you.

00:21:32 Speaker 1

It's not that.

00:21:32 Speaker 1

It's really kind of, I don't know, adding, if you're trying to find a way to have people come back to the assembly, they need to be convinced that there are things that are more no-nonsense.

that are instead of more confusing.

00:21:46 Speaker 1

I mean, do people do like watching train wrecks take place, but it gets old after a while, I'm sure.

But yeah, so this is what you can do for the Nevada Assembly as now as a co-coordinator, not to try to manage or co-mingle the effort with Sue.

Sue may be having issues herself, but the Nevada Assembly, Nevadans will see a focused area for that.

through that pillar, and particularly for state border defense.

Anybody who's in their assembly right now is already, has already come to terms with correcting their status.

Now they're trying to find a place to fit in, to cast their ballots, you know, to see things happening, to participate when they can in committee, maybe even take an elected role.

The last thing they want to see, even though it may be a little bit intriguing, it is exhausting to see controversy or lack of progress or stalled progress.

What the assemblies would like to see, I'm sure across the board, is slow, steady, or steady progress, slow if it comes to that, but progress.

What we are offering is not only vetting, of course, and again, if Terry has vetted you, that was the traditional way of vetting.

And if Anna recognizes you as having been vetted by Terry, not in the process of being

or in the process of being vetted by the marshals, but actually having vetted.

There's a date, there's a time, you have it reported.

We also offer that, and we also offer a certificate of recommendation or recognition.

This is something Terry hasn't offered.

00:23:20 Speaker 1

That's okay.

00:23:21 Speaker 1

This is just something that we offer in addition to that, because we're offering vetting.

PKTF is offering vetting for state co-coordinators who will devote A portion of their time, significant portion of their time,

for their state assembly regarding their state assembly militia.

Probably, and I'll leave it with this, the Nevada Assembly probably hasn't touched anything regarding assembly militia beyond just talking about it or preparing to talk about it.

Diving into the committees regarding what it is to have your state guard, your assembly militia building.

You probably have, I mean.

00:24:14 Speaker 2

We have a militia commander and we have a militia.

00:24:18 Speaker 2

And we also have our sheriff in Clark and the sheriff, I think up north.

We do have, we've.

00:24:25 Speaker 1

Hold on, hold on, hold on, hold on, hold on, hold on, Rocky.

You're saying you have a militia commander on Clark County?

00:24:32 Speaker 2

No, state.

00:24:34 Speaker 2

He's a state one.

00:24:35 Speaker 1

Hey, well, that's we need to know that.

00:24:38 Speaker 1

Who is that?

00:24:39 Speaker 2

That's Shellen is his name.

00:24:41 Speaker 1

Just go ahead and put the e-mail in the chat.

00:24:43 Speaker 1

And what we're needing to find even more, again, I'll conclude with his e-mail.

We have two capitals, though, because all of our capital functions happen in Clark County, Nevada, except for the legislative season, which is about three months long.

You talking about the de facto have two county, 2 capitals?

Yeah, but basically everything in Clark is in Clark County.

Nevada, five-sixths of everything that happens in Nevada is in our county and where Rocky and I live.

And we have about 250 ASN.

So that's why you call Clark a state capital.

Yes, we are.

We have all the capital functions here.

And they only go up to Carson City for, I'll call it the legislative season, but pretty much everything's happening down here.

Okay, because we thought you didn't know what you're talking about, Denise, when you say Clark was a capital.

We know it was Carson City.

We have the state buildings here in Clark are actually much larger than what's in Carson.

So Rocky, you and Denise, the lead coordinator and outreach person, did not comprehend the union state strategy you were using?
