



## Written Testimony of Susan Hulsebus in the form of an Affidavit

*Regarding Allegations Against The Nevada Assembly on November 21, 2025*

I, a woman, Susan Beth Hulsebus, a creation of Nature's God, standing on the land and soil of the organic states as a beneficiary of the American Public Law, and naturally possessing sovereignty in my own right, present this Written Testimony in common American English. I have firsthand knowledge to declare as follows:

Recently, statements were made publicly about The Nevada Assembly Militia and our Militia Commander, Mike Wilson (hereinafter "Mike"), that are reckless and potentially harmful to the Nevada assembly and its members. This testimony, which is true and correct to the best of my knowledge, is written to formally rebut the false information, correct the public record, and request corrective action by the accuser.

On Friday, November 21<sup>st</sup>, a member of The Nevada Assembly forwarded an email they received from William "Rockie" Roper (hereinafter Rockie). This email was sent by Rockie as "Coordinator" to the Nevada Assembly. The full email is linked below.

In the email Rockie states: "I was also given information about that the **State of the Union Militia** is promoting getting firearms. The militia is not an army and has no reason to have firearms. This is one way for the de-facto to get people to stockpile firearms then they will come and arrest you all for being a terrorist group. We are peaceful men and women. The Pen is mightier than the sword. We have an army for that reason. The Militia is a peacekeeping task force that is ready to help when there are disasters, getting food and shelter to the needed. You can kind of relate them to FEMA, but the good guys are ready to help when needed. Do not fall into this de-facto trap."



Rockie fails to disclose where the "information" he was "given" came from and what specifically was said and fails to provide evidentiary support for his allegations.

Enumerated corrections to each of Rockie's statements:

1. Rockie's statement that "the **State of the Union Militia** is promoting getting firearms" is false. I communicate with our Militia Commander, regularly and have been present on all Nevada Assembly Militia calls. I have never known Mike or any member of our Militia, which is comprised of all members of the Nevada Assembly, to make any statement to "promote getting firearms". Rockie must provide evidentiary support for this allegation or publicly retract this statement immediately.

2. Rockie states “The militia is not an army and has no reason to have firearms.” As stated, our Militia is comprised of all of our men and women on Nevada. Rockie is quick to point the finger and accuse his fellow men and women on Nevada of being “defacto” but seems unaware of the de facto nature of his own statement. In Anna’s article “Though Still a Bit Confused.... Doing a Fine Job!”, she shares an article that explains the history, context, and importance of our State Assembly Militias within the American Government.   - a. In this article, The Tenth Amendment Center explains, “One of the primary reasons the founders wanted a strong militia system with a well-armed general public was to minimize or even eliminate the need for a large, permanent standing army, even in times of peace. Most people in the founding generation were extremely wary of standing armies. Noah Webster understood this danger well, saying, “Before a standing army can rule, the people must be disarmed.” Anna beautifully summarizes this article: “As noted in this article, the people are the militia; in fact, the Hebrew word ‘people’ means ‘militia’. We have no reason to be shy or fearful about standing up our own well-regulated State Militias, nor do we have to argue with our Federal Employees about our right to keep and bear arms --- which means a lot more than pistols and deer rifles”. Rockie is correct in stating that “The militia is not an army...” however he goes on to incorrectly state that “The militia ... has no reason to have firearms”. Does Rockie personally know every single member of our Assembly? Does he know all details of our personal lives.? If the answer to the above questions is “no” then it is irresponsible for him to determine that we have “no reason to have firearms”. Further, as living men and women on the land and soil, we have the right to keep and bear arms and, as the Second Amendment states, the right to keep and bear arms **shall not be infringed** by government. Rockie’s determination that we “have no reason to have firearms” and his accusation that in doing so we are at risk of being identified as “terrorists” is an infringement on our rights.
  - b. Our Nevada Assembly Militia, with the guidance of our Militia Commander, recognizes that with rights come responsibilities. Mike merely suggested that our Assembly members get training so that those of us wishing to exercise our right to keep and bear arms have the proper training to be safe and responsible gun owners. Rockie’s misrepresentation of our Militia statements is irresponsible and dangerous. He must immediately retract the statements made here or provide evidentiary support for them.
3. Rockie states “This is one way for the de-facto to get people to stockpile firearms then they will come and arrest you all for being a terrorist group.” Here Rockie appears to call


The Nevada Assembly Militia “defacto” and accuse us of getting people to “stockpile firearms” so that the “defacto” can come and arrest us. He doubles down on the inflammatory nature of this statement by adding that “they will come and arrest you all for being a terrorist group”. These statements are particularly concerning to me and should be concerning to anyone who cares about the safety and well-being of our men and women on The Nevada Assembly as we are all Militia members. Rockie promotes himself as County Coordinator, State of the Union Coordinator, and Union State Coordinator. Obviously, the accusation that our Assembly is “stockpiling” firearms and suggestion that we can be arrested “for being a terrorist group” made by someone presenting himself as speaking for us as “Coordinator” is extremely dangerous. We are all aware that the de facto government agencies are already prone to misidentifying our good men and women as “terrorists” and that “stockpiling firearms” is a hot-button term for the de facto. We are also aware of situations where the de facto agents have acted violently towards individuals they identify (or misidentify) as “stockpiling” firearms and engaging in “terrorist” activities. By making these statements about The Nevada Assembly while also claiming to speak for the Nevada Assembly, Rockie has not only harmed the reputations of our good men and women but has also put us at risk of unwarranted and unwanted action by the de facto “alphabet soup” agencies. As Coordinator of The Nevada Assembly and an American State National on Nevada, I wish to make it clear that our Nevada Assembly is NOT encouraging the “stockpiling” of firearms and we are NOT engaged in any terrorist activities. We are NOT at war with anyone. We are here to educate and inform. We promote peace and uphold the public law. Our good men and women treat others as they would like to be treated, and we constantly remind our members of these values on our Nevada Assembly meetings. Meeting recordings that support these facts are available on request. Rockie must provide evidentiary support for these allegations or publicly retract these statements immediately to mitigate the harm to our good names and reduce the risk of actions taken against us based on this false witness against us.

4. Rockie states, “We are peaceful men and women”. This statement is true for most of the men and women on Nevada but since December of 2024, Rockie and his supporters have been in a very public verbal war against many members of our Assembly. 

- b. Rockie's November 24, 2025, response to the attempts Mike Wilson and I have made to correct the record to protect our Assembly from potential harm again demonstrates his willingness to publicly fling inflammatory rhetoric without providing any substance or facts to support his generalized accusations. Instead of making any attempt to protect our men and women by retracting and correcting the inaccurate and inflammatory statements he made public on November 21, he makes numerous additional unsupported accusations. Anna has had the patience of a saint with him and has tried to educate him and help him based on his statements and questions on Michelle Ford's Thursday calls and Rockie takes advantage of that by making false or misleading statements to Anna about The Nevada Assembly. Rockie has provided false witness against me and The Nevada Assembly while claiming that Anna is fully onboard with his behavior. 5. The Nevada Assembly has made good faith efforts to address the problems Rockie is causing, according to Anna's guidance as provided in her articles, and Rockie has had many opportunities to course correct.

  - a. In February of 2025, two Clark County Assembly Members brought a motion to temporarily suspend Rockie's accomplice, Denise Mraz and Clark County until issues on Clark County could be resolved. This motion passed with a 2/3<sup>rd</sup> vote, but Rockie and his supporters ignored the motion and responded by verbally bashing and spreading gossip about the Assembly Members who brought the motion forward, and ramping up the accusations and attempts to bully me into stepping down as Coordinator. 

- b. On February 13, 2025, I contacted John Butruccio. John kindly agreed to help facilitate a solution to this conflict that benefits everyone involved. Unfortunately, Rockie's accomplice, Denise Mraz, posted inflammatory rhetoric about John on a public forum, and when John tried to have a conversation with her, she refused. This created a conflict, and unfortunately, John had to step aside.
- c. In late February of 2025, Rockie was informed that he didn't pass vetting but was given simple course correction opportunities. He refused to course correct and proceeded to again increase the verbal attacks against me and the vetting committee members. He shared his confidential vetting report with his followers in Clark County and then accused the vetting committee of slander. Link to Vetting report with course correction opportunities:

- d. In April of 2025, The Nevada Assembly Oversight Committee investigated allegations made by Rockie and Denise Mraz against our Marshal-at-Arms, Doug Hulsebus (hereinafter, Doug), and me. Rockie was given the opportunity to provide evidentiary support for the numerous and very serious accusations of crimes against Doug and me, including but not limited to human trafficking, racketeering, and extortion. The Oversight Committee used article # 3374 from Anna's website to address the accusations and lack of evidence supporting them. Since no evidence was provided, the Oversight Committee determined that Rockie was a false witness and used the directions in Anna's article to deal with him. Instead of making any attempt to provide evidence Rockie and his accomplices added Jill Horsley, our Oversight Committee Chairwoman, to their long list of fellow Assembly members whom they publicly make accusations against.
- e. In August of 2025 I responded to accusations coming from Rockie's crew in an effort to explain that the attacks are harming all Nevadans.

- f. In October and November of 2025, our Nevada Assembly Militia Commander sent a "Notice of Claims and Testimonial" to Rockie in an attempt to address some of the problems. Rockie failed to properly respond and stop the attacks against the Nevada Assembly. November 25, 2025, was the last day for Rockie to respond in kind. These unrebutted claims stand as truth under our common law.

From Anna's article "International Public Notice: Recognize Colonialism Now":

"Their modus operandi is always the same, whatever jurisdiction they are operating in. They pretend that they are helping when they are hurting. They pretend to benefit people (and entire countries) while they are in fact using them. They recklessly destroy, pillage and pollute for profit – their own profit, nobody else's. And when they can't buy the leadership of a targeted country off, they threaten and bully and try to get their way like two year-olds with a hammer."

The paragraph above summarizes exactly what Rockie is doing to our Nevada Assembly. The gossip and inflammatory rhetoric he and his accomplices have been flinging has caused many of our most active and productive members to step away. He has had multiple opportunities to course correct. As mentioned, Anna has been very patient with Rockie and has attempted to help our Nevada Assembly by working with him and educating him based on the belief that he is sincere in his desire to help The Nevada Assembly succeed. Unfortunately the facts demonstrate a pattern of destruction, gossip, and accusations that has spanned almost an entire year. Rockie uses Anna's attempts to help and educate him to thwart the efforts of The Nevada Assembly to course correct him and defend against the vicious verbal assaults coming from Rockie and his crew. The good men and women on Nevada have endured this disruption for almost a full year now. On calls with Anna, Rockie presents himself as someone who truly cares about the people on Nevada and who is single handedly rescuing our Assembly because the State is not doing our jobs. Facts and evidence clearly demonstrate that our Nevada Assembly is making progress despite the fact that Rockie has succeeded in causing division and slowing progress. His latest reckless public claims put our entire Assembly at risk of unwarranted action by the de facto. This situation must be remedied immediately to safeguard the safety and security of our Assembly. For these reasons, the following actions are essential:

1. Rockie must immediately retract the accusations enumerated above publicly to help mitigate the potential problems these allegations can cause for the safety and security of our men and women.
2. Rockie should resign from any role on the Nevada Assembly until he is ready to course correct and work with our Assembly as a productive member helping us build our pillars.

Anna has been very patient with Rockie and has attempted to help our Nevada Assembly by working with him and attempting to educate him based on the belief that he is sincere in his desire to help The Nevada Assembly succeed. Unfortunately the pattern of dishonesty and destructive behavior has now put the safety of our Assembly members at risk. Anna describes action she took in California to protect the Coordinator and Assembly from destructive behavior in her article "Wanted". Rockie has the opportunity to course correct but if he fails to do so, it is imperative that action is taken to protect the men and women of Nevada. Anna is incredibly busy and doesn't deserve this additional burden but if Rockie refuses to course correct and continues to claim that Anna has given him free reign to continue his pattern of destructive behavior, this is the only solution.
