

We call are people public officials not officers

Top six inches of the land (Soil Jurisdiction) is our national jurisdiction.

Land underlying it is our attached international land jurisdiction.

If we wish to operate our states as nations, we drop back to our soil jurisdiction and operate as member states of The United States.

If we operate our states as international entities, we operate as member States of The United States of America.

Joining the State Jural Assembly you agree to serve as a Juror and act in the capacity of a State Citizen. (Jury Duty)

Our States of the Union do not recognize any Dual Citizenship whatsoever.

As a State Jural Assembly Member you are also pre-qualified to function as a County Jural Assembly Member and vice-versa.

There is a State and County Grand Jury.

Our State/County Trail Jurors listen to the unique cases presented and decide the Law and Facts.

State/County Jural Assemblies enforce the Public and Organic Law.

Our State/County Jural Assembly Members acting as Jurors in actual Trials can throw out any law that they find repugnant to the Public Good or the Cause of Justice. (Jury Nullification)

It is the Jurors – The members of our jural assembly – who decide all matters in out state and county courts. The justices pronounce their sentences, and the Recorder records them, and the Sheriff enforce them.

Need to elect a recorder, Recording Secretary. Need a Recorder's Office.

Recording Secretaries and Public Notaries.

- a. Elected, trained, and confirmed in Office by the actual State Jural Assembly.

Judges, Justices, and Hired Jurists.

- a. The people inhabited in the court are the Hired Jurists.
- b. County level has “Justices of the Peace”.
- c. State level has “Justices” and “Justices of the Supreme Court”.
- d. International jurisdiction we have “Judges”

Coroners

- a. Need is someone who has reasonable training and experience to be able to certify that a man or woman is dead and to give an educated opinion of the cause of death.

Public Notary – Courts.

- a. Properly overseen Due Process Proceedings
- b. Cannot be reviewed or overturned by any private agency or “State of State” court.
- c. Stamp need a logo, says Nevada Notary, and In Office 1 September 2025 to 30 November 2029. Need to have the copyright C on the artwork.

Court Clerks

- a. Set the venue of the court cases. Determine where a case belongs, in which court and jurisdiction and they assign it to a specific judge, a Justice, or a Justice of the peace.
- b. First duty of a Court Clerk is to recognize the kind of action.
- c. Turn away people functioning as “foreign persons”
- d. Does it involve one of the People?
- e. Does it involve things that occurred within the boundaries of our State or at the County Level, Inside our County.
- f. Does the issue that pertains to the land and soil and to actual factual people and things? That is our jurisdiction.
- g. Not something intangible and theoretical. THEIR jurisdiction.
- h. Maintain meticulous record of all the paperwork involved in a case.
- i. Keeping track as more paperwork and evidence comes in and is added to the court record.
- j. Serve the “people” (State Nationals) and “People” (State Citizens) of our State.

Bondsmen

- a. Are the land counterparts to the Bailiffs (sea jurisdiction courts).
- b. Keep order in the courts.
- c. Serve in the capacity of “brother’s keeper”
- d. Take charge of prisoners.
- e. May assist Sheriffs and other Public Law Officials in performance of their duties.
- f. Maintain the security of the actual courtroom and direct traffic with it.

- g. Help seat those who are physically injured or disabled, distribute educational information to members of the Jural Assembly.
- h. Instruct people on how to post bonds.
- i. May serve as a Witness to official paperwork and confirms the Bond Roster for each day the Court is in session.
- j. Signs the list of Bonds set by the court and confirms receipt of bonding fee together with the Court Clerk at close of the Court.
- k. Secures and locks the safe containing the bond fees.
- l. Typically make a public affirmation declaring that he will serve the People of the State in Good Faith and Honor, to protect the Court and the Public, and to assist in providing and securing peace and justice for all. Copy of this Declaration is kept in the Court Clerk's Office. Similar Declarations of the Justices and other officials.

Keeping minutes, tape recordings of meetings, keep records related to the Jural Assembly and its members.

Creates and preserves the Public and Private Records of the Jural Assembly.

Need multiple copies and locations.

Created in triplicate at time of creation.

- a. Copy going to the Jural Assembly Members.
- b. Going to the jurisdiction county level organization.
- c. A copy remaining in the State. (?)

Member records are confidential for the most part.

- a. Only the names and addresses of the Jural Assembly Members are generally available.
- b. Not to become a member of the State Jural Assembly. Stay a ASN.
- c. Juror, Sheriffs and their Deputies typically serve in on and off duty shifts.
- d. Judges and Coroners serve pretty much 24 hours and seven days a week.
- e. Juror will get back a complete copy stamped by the recorder.

The recorder should stamp the package as complete, scan it, distribute the copies, and secure the copies left in his or her possession.

Record of times, dates, quorums, meeting minutes and similar documentary evidence of the activities.

We need to create Travel Cards not Driver Licenses

We need Regulation Z Stamps to identify private cars.

Definitions

Soil comprises the National Jurisdiction of the States and is managed by our unincorporated County Jural Assemblies. Is the supreme political jurisdiction in the American Government.

Land comprises the International Land Jurisdiction of the States and is managed by our unincorporated State Jural Assemblies.

Sheriff only acquires his god-like powers when there in an active, qualified State Jural Assembly. Jurors in his county who elect him.

State Militias are manned by State Citizens and Members of the State Jural Assembly.

- a. Their focus is community safety and preparedness on a statewide basis.
- b. Members are ~~taught firearms safety, marksmanship~~, first aid, and train in one or more specialties. The State Militia can call upon one or more County Militias for assistance.
- c. Responsible for outreach and education.

Peacekeeping order for the public

- a. County Sheriff
- b. State Marshal-at-Arms
- c. State Militia Commander
- d. State Troopers or Rangers
- e. LEO's Private Pinkertons
- f. Private Detectives, Bailiffs, etc
- g. Continental Marshals
- h. U.S. Marshals
- i. Agency Personal
- j. Provost Marsha

Marshal-at-Arms – Responsible for the security of the State Jural Assemblies records, its officers, and Members during meetings and Coordinating of the County Militias with the State Militia.

Public Notaries

- a. They use stamps and red ink.
- b. Members of our County and State Courts.
- c. Hold a position of trust similar to the of a State Justice or County Justice of the Peace.
- d. Process and witness and transfer the Public Records of the County, the State, and the People.
