My apologies again Anna for having you needing to address this again. Like I said, the harassment never stops from Sue and some of the people who are always in her meeting calls. My question is, when will they stop with their disruptive behavior? I wish they would just stop these attacks on me and get The Nevada Assembly up and running. The thing I'm confused about is, who is The Nevada Assembly? Is it North Nevada? All Nevada? The way she talks, it seems like it's always changing and she has many "accusations" and most people do not agree with her. Another topic Sue always brings up is, "Rockie and his group" Can we please have a clarification of who the group is? When we keep asking her who she's referring to, she never answers. That's not being transparent, that's an accusation. How can we correct a group of people if we have no idea who she is mentioning.

Sue keeps bringing up about honesty and transparency and that the people are working together, but how is that happening if we (Union State) don't even know who is in what position? We have asked multiple times for the Organizational Chart but have never gotten an answer. We have an old chart but our concern is, how can the same 5 or so people do all the positions??? I have asked many times so that we can help Sue with filling the positions and help the State stand up. This topic was also mentioned in our last meeting. What I'm highly confused and concerned about is how can the State still not have filled the positions in a 4/5 year time span?

Why does Sue keep bringing up that I am not vetted? How many times does Anna have to say I am a vetted Coordinator? Sue and The State of the Union DO NOT vet the coordinators! How many times does that have to be said? So, why is Sue spreading false information about me? Why has she not apologized to me yet? Can she please stop telling people that I need to step down because again, I am a vetted Coordinator by Anna. Anna is the only person who can hire or fire and vet a Coordinator. NOT Sue or The Nevada State of Assembly.

As you can see, in her response, it is all about stopping me and removing me from the Assemblies. Maybe she needs to stop wasting everyone's time and focus on standing up the State.

Here is my response to Sue's bullet points and your answers. My response is in orange.

1. Robert Hale was falsely accused of being fired by Anna. No, I never "fired" Robert. He offered to retire from work he was doing as SIA admin, we talked about it, and I left it entirely up to him, whether or not he wanted to continue. There have been rumors that this had happened, and I have learned that did not happen and told everyone that. Include any email you have to concur
2. Peter Grunfelder: Accused of lying on the December meeting and called "mentally ill" and "t-shirt Pete": One man's lie is often another man's truth, and the difference is usually just a misunderstanding and bad communication skills; if you had any idea how many really vicious salubrious ugly things I have been called in the course of forty years of this, you would hear me laughing. T-shirt Pete? Flannel-shirt Anna? Tell Pete he is in good company and ignore it. I did not know of any of this, and this is the first time I heard of it.
3. Kathi Kridler: Accused of spreading false information because she shared screenshots showing Rockie was posting inflammatory rhetoric in public forums. He also called Kathi a "zombie dead fish" and made additional accusations against her. Bad form, Rocky, but it happens; ditto ditto on name-calling. The best way is always to go to your "brother" in good faith and try to resolve differences. I have never called anyone "zombie dead fish" that came straight from Denise and I get accused of everything Denise has said and done. This is not right and needs to stop NOW, we're not siamese twins! We are two different people, and I do not condone anything Denise does. I have explained this multiple times and also apologized in The Union State meeting about what has been said.
4. John Butruccio: Denise posted inflammatory rhetoric on a public forum about John who had kindly offered to facilitate conflict resolution assistance on Nevada (screenshots on the Attached Witness Statement) That is most unfair, because John really is a good guy and a skilled arbiter --- and when it comes to professional skills, it doesn't matter that he comes from another State. You don't fall down an escalator and ask the doctor who rushes to your side what State he lives in, do you? Again, this came from Denise, and "somehow" now I'm being blamed for it. I did work with John, and I did inform John I had determined that he was biased, so I did not want to continue working with him.
5. Brian Vonarx was falsely accused of making threats on the December 2024 General Assembly meeting and accused of fraud. I don't know what "threats" or statements perceived as threats were made, so that's a wash, but if he was accused of "fraud" there has to be a basis that deserves examination, if only to reassure members of the Assembly. I agree with

you Anna on this topic and do not know what threats were made.

6. Mark Seilstad was verbally attacked and accused of fraud . Same as above. Again, same as above.

Shane Huston was falsely accused of being forced out of the Assembly because he was a firefighter. Was he forced out for any reason? That was what I was told, however my effort to correct things was to call Shane and ask questions about the accusations. Shane and I have spoken in person, he then explained why he has left. So I sent out an email to everyone to fix this rumor and to correct it. "Include the email quote here"

8. Doug Hulsebus was accused of numerous serious crimes in public forums and during meetings. He has been called a federal agent because he is a volunteer firefighter in addition to various other derogatory terms. Being a firefighter, school teacher, or even a real live FBI Agent doesn't keep a person from being a loyal American and doesn't preclude them from participating in their State Government. The only thing they can't do and that is in possible conflict of interest is this: they can't sit on the International Business Assembly or act as a State Citizen. Again, this kind of talk came from Denise. I did bring it up in the meeting that Sue and Doug were married and with Doug being a firefighter, he should not be the Marshal-at-Arms because this IS a conflict of interest as you (Anna) have just explained.

Sue Hulsebus: Accused of serious crimes in public forums and during meetings. Called a "dependant" and "de facto" agent in addition to numerous other derogatory terms. In addition, racist statements were made and publicly distributed. Also accused of having multiple LRO accounts, multiple bank accounts, and multiple aliases. Ditto above. Were there specific allegations? Were they investigated and explained? Does everyone have closure on this? Again, these are all allegations from Denise. The fact that Sue is married to Doug, means that she is a "dependent" and that there would be a conflict of interest to the Coordinator and Marshal-at-Arms position. This is my interpretation according to Anna's explanation in #8. The Union State has asked multiple times for explanation from Sue and Doug and we have not received anything yet.

10. Aaron Eller: Several allegations against him as shown in the attached. <https://link.storjshare.io/s/jxxdb5wgn6j5jpls6e26gp5ibpgg/coordinators/meetings%2FVetting%20Feb%202025%2F%20Facts%20and%20Witnesses/DreamHost%20Webmail%20%20Run%20away%20train.PDF> This appears to be part of a pattern of the State of the Union Assembly assuming it has a role disciplining and setting detailed standards and processes for the Counties and the Union State that will arise from the Counties -- what should be happening is that the people receive their basic training as members of the State of the Union Assembly, in this case, The Nevada Assembly, and then carry those processes and standards with them as they start their County Assemblies. Vetting, for example, has been established by The Nevada Assembly. Each County therefore has cause to know that vetting is required for elected public offices and should make sure that people can be affirmed as eligible to hold the county office prior to being placed on the ballot for election. The position of "County Facilitator" doesn't exist in our government so I assume this was an ad hoc description just "thought up" to put a name on a County Coordinator --- other than Coordinator. The confusion created by Craig's passing combined with no available specific instructions about development of County Assemblies appears to have created a Trifecta of cross-purposes, with the County trying to assert its independence from The Nevada Assembly and The Nevada Assembly trying to enforce uncertain standards and processes. All this is understandable, but at the end of the day --- each County is a world unto itself, and while standard "Good Business Practices" are customary and expected, the people of each County are responsible for establishing oversight and meeting The Prudent Man Standard. So -- counties do have standards to follow but enjoy a substantial freedom within commonly accepted norms for the conduct of any business and those activities are not the baileywick of The Nevada Assembly. What happened here and is not told is that Aaron Eller brought up this information in the Clark County meeting, and the Clark County Assembly voted him down. Then he took this to Sue so he could overturn what the people told him. His comment was that "he would never get his way in the County Assembly", so The Nevada Assembly needs to fix it. I explained to them that Sue and The Nevada Assembly have no jurisdiction over the Counties.

11. Jill Horsley: In addition to receiving phone calls and emails from Denise attempting to intimidate her, Jill has been called a "zombie dead fish" and has had numerous allegations made about her. Jill was accused of intentionally botching an LRO recording to intentionally deny a member status correction. Upon investigation it was discovered that Jill was never involved with recording this member. Was this openly discussed with the member making the accusation? Was the recording finished properly? Did Jill receive an apology? Again, this information came from Denise, and I've been blamed for it.

12. Carlos Guzman was publicly accused of writing an offer to "create a new Assembly with the de-facto". Was there any basis for this? Was the question resolved so everyone had closure? Carlos has sent an email to me that was geared to working/ joining with the de-facto and helping them govern. I have brought this topic up in our Union State meeting and afterwards I have also sat down with Carlos and explained my concerns with his recommendation. He understood and agreed with my explanation. When we speak to each other in our meetings, we do not accuse or attack each other. We civilly speak about any topic and do not take things personally. Please understand it is okay to say No, or when we

do not agree, that does not mean that we're attacking or accusing a person. After these conversations, the Union State Assembly has made Carlos the head of the Oversight committee. There are no problems with Carlos. Carlos has also expressed that he will be in charge of collecting information from our members to give to Anna to address her concerns/ questions of all these topics.

13. Aaron Lucey was accused of going "along with erasing meetings he runs as well and just erased a State committee meeting 2 weeks ago" and of committing election fraud. **Again? Were there incidents of deliberate non-recording, erasure, or failure to post meetings? What kind of election impropriety? Was it investigated? Was it resolved? Again, these accusations came from Denise, and Sue keeps accusing me for saying these things. Please stop involving me with Denise's accusations! These accusations were made in 2025 not recent, and not AGAIN. Aaron and I have great respect for each other and work well together.**
14. Jeannine Gardella: Accused of fraud. **Ditto --- same questions. Were the allegations substantive, factual, and specific? Were they investigated? Does the Assembly have closure? I have no idea who this person is. Never met them or heard of that name.**
15. Teri Sahm: In a recent report distributed to the entire Nevada Assembly and internationally Denise and Rockie stated "Teri used her position of authority in malfeasance and went outside her jurisdiction of vetting to deceitfully apply the terms District Assembly to actual authentic assemblies. Her friend Sue Hulsebus assisted her with an escalation of plagiarism and fraud". In addition, an email was distributed to the Assembly and internationally claiming that Teri is being investigated. **Well, Rocky and Denise are NOT part of any "district" and not part of any "district assembly". They are running an unincorporated County Assembly in Nevada. Not sure how that misunderstanding got started, but it shows a failure of communication that needs to be fixed for sure. She shouldn't have been attacked. She should have been corrected. Who there in Nevada took responsibility for giving her the facts? I agree with you here and Teri has no jurisdiction to step in and determine if Clark County is working as a District Assembly or not. Which obviously we're not.**
16. Anna: In addition to calling Anna's pen name the "Commander in Chief of the United States", Denise and Rockie have falsely stated and posted on public forums that Anna fired multiple people from the Nevada Assembly. Denise sent an email to Global Family Bank accusing Anna of collusion with me stating we have frequent conversations. **Name-calling and ignorance tend to go hand-in-hand; anyone who mistakes me for a naval officer is playing for laughs, although when it comes to that, I CAN enter that venue if need be, not as a corporation officer, but as an officer of state. I only recall "firing" one person from The Nevada Assembly and that was literally to protect her from getting shot in an FBI Sting operation that targeted her. As for having conversations (not frequently and apparently not frequent enough) it would be a strange thing if I didn't have conversations with Coordinators. Again, this type of communication came from Denise not me. I have never said any of those things, however there had been many rumors of this information.**
17. Paul James Brandl: An email was distributed to the Assembly and internationally claiming that Paul is being investigated. **Paul has some pretty "out there" standards of performance and tends to be suspicious, but he isn't under any investigation that I know of; he does his work faithfully and that's what we need. Here's another name I have never heard of. I know nothing of Paul.**
18. Jimmy Fulton: An email was distributed to the Assembly and internationally claiming that Jimmy is being investigated. **Ditto Jimmy Fulton, a name I don't even recognize. No investigation I know of. Same as above, I know nothing of this. I do not know this person.**
19. Paul Pappas: An email was distributed to the Assembly and internationally claiming that Paul is being investigated. **Nope. About to have his commission affirmation recorded on a national teleconference, not under any kind of suspicion or investigation. I have never sent an email out saying that I said that Paul was being investigated.**
20. Militia Commander in Big Lake Alaska: An email was distributed to the Assembly and internationally claiming that the Militia Commander in Big Lake Alaska is in a "passive compromised position". **We don't have any Militia Commanders in Big Lake, Alaska. I know nothing about that.**
21. The Nevada State Militia: The Nevada State Militia (all Nevada Assembly members) was accused of encouraging the Assembly to "Stockpile firearms" and implying that the militia and Assembly are putting members at risk to be identified as "terrorists". **Now, that is typically what FBI Snitches and Agents try to claim, so assuming that you were not advocating "stockpiling" --- whatever that means --- watch whoever tried to drag that one out and try to determine if they are just afraid of guns or trying to mess with us. The Supreme Court ruling telling everyone to back off the Second Amendment and that gun licenses are illegal should be enough to put an end to any of that. This is not what got said, I do not like people twisting my words. I said that if we talk about firearms in our meetings that it could look like to the de-facto that we are stockpiling firearms and then they could label us as terrorists. We need to be careful in talking about firearms in the Militia meeting, so it doesn't make us look bad.**

Mike Wilson, Militia Commander: Numerous allegations have been publicly made against Mike but the most heinous and dangerous is that he is encouraging the Assembly to "Stockpile firearms" and implying that he and the assembly are putting members at risk to be identified as "terrorists". **As the Supreme Court affirmed last week, we can own, carry, buy, sell, and do pretty much whatever we please with guns--- they are not considered "firearms" subject to Federal Regulation. "Firearms" as in "right to keep and bear firearms" refers to artillery, cannons, mortars, howitzers --- okay?**

It is not only okay for us to have rifles and pistols, we can have any kind of ordinance the regular military has. Again, same as above.

23. Nevada Assembly Banking Committee: Was accused of stealing money from The Nevada Assembly following a statewide vote approving a donation to Anna. What was the context? If a donation is approved and they simply lost the vote, they have no cause to complain or accuse anyone of stealing. My first question here is, who is the Nevada Assembly Banking Committee? Second question, Sue, you're stating that this was approved statewide. How can it be statewide if I have never received any emails from you. I keep asking to be involved in the State meetings but I never receive your emails and when I try to attend your meeting, I get my access rejected. My response about the money was to give it all to Anna. The comment I did make was "if Sue does not give everyone in the assembly a chance to vote on where the money goes then that is fraud and could be considered as stealing from the assembly". To this day, I can give you a list of people that never receive Sue's emails for State meetings. I was cut off 2 years ago.
24. All Assemblies: Denise made a public accusation on a PKTF call that there are "100 federal agents" serving in positions on the assemblies. Not that I know of, and as I said, as long as they are upfront about being Agents, or Federal Employees or State of State Employees, the only thing they can't do is --- they can't serve on the International Business Assembly and they can't serve as a State Citizen. Again, I had nothing to do with this topic but I still get blamed for it by Sue.

Anna, I will do as you ask and let the people tell you what they think of the whole problem and they can answer the questions for you. I will send out this information to them and let them respond if they want. I can assure you, that the Assembly members who are trying to do the work are fed up with all the attacks on the people in the assembly, but again I will let them tell you for themselves.

Thanks for all you do and taking the time to address what is going on in Nevada.

14. Jeannine Gardella: Accused of fraud. **Ditto --- same questions. Were the allegations substantive, factual, and specific? Were they investigated? Does the Assembly have closure?**
15. Teri Sahm: In a recent report distributed to the entire Nevada Assembly and internationally Denise and Rockie stated "Teri used her position of authority in malfeasance and went outside her jurisdiction of vetting to deceitfully apply the terms District Assembly to actual authentic assemblies. Her friend Sue Hulsebus assisted her with an escalation of plagiarism and fraud". In addition, an email was distributed to the Assembly and internationally claiming that Teri is being investigated. **Well, Rocky and Denise are NOT part of any "district" and not part of any "district assembly". They are running an unincorporated County Assembly in Nevada. Not sure how that misunderstanding got started, but it shows a failure of communication that needs to be fixed for sure. She shouldn't have been attacked. She should have been corrected. Who there in Nevada took responsibility for giving her the facts?**
16. Anna: In addition to calling Anna's pen name the "Commander in Chief of the United States", Denise and Rockie have falsely stated and posted on public forums that Anna fired multiple people from the Nevada Assembly. Denise

sent an email to Global Family Bank accusing Anna of collusion with me stating we have frequent conversations. **Name-calling and ignorance tend to go hand-in-hand; anyone who mistakes me for a naval officer is playing for laughs, although when it comes to that, I CAN enter that venue if need be, not as a corporation officer, but as an officer of state. I only recall "firing" one person from The Nevada Assembly and that was literally to protect her from getting shot in an FBI Sting operation that targeted her. As for having conversations (not frequently and apparently not frequent enough) it would be a strange thing if I didn't have conversations with Coordinators.**

17. Paul James Brandl: An email was distributed to the Assembly and internationally claiming that Paul is being investigated. **Paul has some pretty "out there" standards of performance and tends to be suspicious, but he isn't under any investigation that I know of; he does his work faithfully and that's what we need.**
18. Jimmy Fulton: An email was distributed to the Assembly and internationally claiming that Jimmy is being investigated. **Ditto Jimmy Fulton, a name I don't even recognize. No investigation I know of.**
19. Paul Pappas: An email was distributed to the Assembly and internationally claiming that Paul is being investigated. **Nope. About to have his commission affirmation recorded on a national teleconference, not under any kind of suspicion or investigation.**
20. Militia Commander in Big Lake Alaska: An email was distributed to the Assembly and internationally claiming that the Militia Commander in Big Lake Alaska is in a "passive compromised position". **We don't have any Militia Commanders in Big Lake, Alaska.**
21. The Nevada State Militia: The Nevada State Militia (all Nevada Assembly members) was accused of encouraging the Assembly to "Stockpile firearms" and implying that the militia and Assembly are putting members at risk to be identified as "terrorists". **Now, that is typically what FBI Snitches and Agents try to claim, so assuming that you were not advocating "stockpiling" --- whatever that means ---- watch whoever tried to drag that one out and try to determine if they are just afraid of guns or trying to mess with us. The Supreme Court ruling telling everyone to back off the Second Amendment and that gun licenses are illegal should be enough to put an end to any of that.**
22. Mike Wilson, Militia Commander: Numerous allegations have been publicly made against Mike but the most heinous and dangerous is that he is encouraging the Assembly to "Stockpile firearms" and implying that he and the assembly are putting members at risk to be identified as "terrorists". **As the Supreme Court affirmed last week, we can own, carry, buy, sell, and do pretty much whatever we please with guns--- they are not considered "firearms" subject to Federal Regulation. "Firearms" as in "right to keep and bear firearms" refers to artillery, cannons, mortars, howitzers --- okay? It is not only okay for us to have rifles and pistols, we can have any kind of ordinance the regular military has.**
23. Nevada Assembly Banking Committee: Was accused of stealing money from



The Nevada Assembly following a statewide vote approving a donation to Anna. **What was the context? If a donation is approved and they simply lost the vote, they have no cause to complain or accuse anyone of stealing.**

24. All Assemblies: Denise made a public accusation on a PKTF call that there are "100 federal agents" serving in positions on the assemblies. **Not that I know of, and as I said, as long as they are upfront about being Agents, or Federal Employees or State of State Employees, the only thing they can't do is --- they can't serve on the International Business Assembly and they can't serve as a State Citizen.**

Looking over all of this, it is overall apparent that this report is lacking crucial information. There are constant references to allegations impugning the honesty of the members of The Nevada Assembly, but no indication whether or not these allegations were just hand-waving, or if they had specific, detailed evidence and sworn testimony attached to them. There is no indication whether or not any effort was made to investigate or any conclusion made that would provide closure of the issue(s) raised. Noisome as it can be, we need to investigate if there is any reasonable substantive basis for the allegation.

We have seen at least one other situation where pernicious and unsubstantiated accusations of "fraud" and "lying" and "endangerment" resulted in the Federation wasting months looking into it, only to determine that "the boy was crying wolf" and there was no wolf, just one disgruntled and suspicious member raising dust. You may be seeing a similar thing here. Remember that our Assemblies attract a lot of broken, fragile, traumatized people who have suffered at the hands of their own public employees; some people become quite paranoid as a result of such experiences and make wild accusations.

From the sheer number of similar accusations of "fraud" one of two things is clearly indicated --- either actual substantive fraud is taking place, or, someone who is most likely committing fraud themselves is making these vacuous allegations in a concerted effort to draw attention away from what they are doing and keeping the honest people busy answering False Allegations and spending their time answering spurious claims that serve no good end for anyone. This could also be the work of one semi-unhinged paranoid personality seeing fraud artists behind every woodpile. But whatever else it is, it is "work" --- someone is actively, purposefully, with malice, impugning the honesty of a lot of people in The Nevada Assembly, and that does nothing positive or worthwhile.

When I get fraud allegations I look sharp at the allegation and the people it addresses, but I also snap back and look hard at the one making the allegation --- what are they doing that is fraudulent? Why are they

accusing everyone else of "fraud"? Or violence?

People need to be responsible when they make accusations and produce actual fact and actual signed testimony. Nothing else creates a valid complaint. When they do this, the organization owes them a prompt investigation, a prompt determination, and a prompt execution of settlement of any issues, so the Assembly has closure on the issues.

If they don't put their own name and reputation on the line and don't provide anything but their own imagination and "suspicions" and opinions, there is no reason to put Assembly time and effort into an investigation. It's put up or shut up. Either prove injury or not.

The harm of unsubstantiated accusations is similar to the damage caused by other kinds of gossip. It not only harms the targeted individual, it harms the whole organization by creating a miasma of doubt, suspicion, and uncertainty, at the same time it wastes resources chasing phantoms. So, whenever anyone makes an allegation, you want to immediately drill them for facts, physical evidence, and affirmed testimony --- and you want to make it very clear that they have crossed a line and are expected to produce actual facts, evidence, and testimony.

There is one other thing about this that bothers me: we hear all about the accusations against people in The Nevada Assembly, and nothing about what The Nevada Assembly has done in response. In my experience, it takes two to tango and two sides to a mud-slinging campaign, so I would like to hear what members of The Nevada Assembly have been saying and doing in response to all these insulting accusations of dishonesty, fraud, etc.,

Hello, Anna. Hopefully you had a peaceful holiday season and your new year is off to a great start. I intended to send you a letter and a summary of Nevada Assembly progress before the end of 2025 but I got sick on December 19<sup>th</sup> and didn't start feeling well until last weekend. Also, I respect your time, and I know you're very busy, but I feel it's imperative that I correct the misconceptions you may have from listening to Rockie and ask you to look at facts and evidence before reaching conclusions.

You spoke on last Thursday's "coordinator training" about words and the effect negative words have. You've also spoken on

many occasions, warning us not to listen to gossip and reminding us to always tell the truth. Throughout your articles, you speak about being lied about and gossiped about. You wrote an article describing the action you took to protect Michelle Ford and the California Assembly from people causing problems on California. You talk often about how we should treat others as we would like to be treated.

On Nevada, we are experiencing a situation like what you describe Michelle experienced on California. Rockie Roper and his group have spread extremely vicious and dangerous accusations against our Nevada Assembly and the good men and women who are quietly working to build our State pillars and get seated. I have provided documented evidence and witnesses to demonstrate what is happening. Early on, Teri gave me some very good advice. She suggested I continue to focus on building our pillars, be the positive light for the Assembly, and subtly correct the record. Although 2025 was extremely difficult, following Teri's advice the good men and women on Nevada still managed to make progress.

Rockie has continued to smash away at the Nevada Assembly, while lying to your face, smiling, and kissing your butt on the "coordinator training". Like you describe in your article where you talk about the common traits of infiltrators, Rockie is playing the victim and accusing others of what he's doing himself. Here I will correct the record and lay out the facts and evidence while trying to keep this as brief as possible because I respect your time.

About a year ago, I had some people from Clark County contact me with questions about things that were happening on Clark without input or approval from the people. You constantly remind us that the people are supposed to be the driver of the Assemblies so I suggested they speak with the county facilitator, but they were reluctant to do so because they believed that there would be retaliation for questioning what was being done. To help resolve the issues, I raised the questions in the December 2024 General Assembly meeting so people could seek peaceful solutions without persecution. One of the issues brought forward was a website which appeared online that the people on Clark never had a chance to review or approve. Our former Coordinator, Mark, reached out to the Clark County facilitator and asked if he knew anything about this website. As you are aware, there are multiple websites which fraudulently claim to be our Federation or Assemblies and are often used to mislead people and milk them for large amounts of money. The Clark County facilitator never responded, Mark assured me that this website was not a legitimate Clark County or Nevada Assembly website.

At the meeting, I talked about the website, informing people that it's not a legitimate Assembly website. Several minutes into the discussion our Clark County facilitator got upset and angry. It turns out that the website was his website. The recording of this meeting clearly demonstrates that I was operating under the impression that it was not. He was given ample opportunity to claim it and never did so. He was aware before the meeting that I was under the impression that it was not our website and he never made any attempt to contact me to correct the misunderstanding. Instead, he acted like I was intentionally attacking him. This meeting was the first meeting that Denise Mraz attended. She wanted to present a fluoride notice and was allowed to do so even though she didn't get the request submitted in time for it to be added to the agenda. I explained to her our process for getting notices approved by the Assembly. She did not want to allow time for notice approval or review by the assembly and got defensive and disruptive during the meeting. After the meeting, I received multiple pages of accusations from Denise. I asked her to clarify and provide evidentiary support for her accusations. Instead of providing evidence, she chose to play the victim and accuse me of what she was doing. In January of 2025 I was informed that a group in Clark County wanted to get rid of me by any means possible. The people involved in this plan were Rocky Roper, Denise Mraz, John Carzoo, Keith Love, Aaron Lucey, and Michelle Schmidt. This was very upsetting as our assembly had always been peaceful and we had always been able to discuss and even disagree with each other in a polite and respectful manner. I had always had very cooperative working relationships with all these people and thought some of them were my friends. There was never any attempt to talk to me to seek resolution. Instead, they proceeded to spread vicious rumors behind my back. Someone in this group gave Denise (who had never been vetted or elected to any position) full access to our Assembly records and our members' contact list. Denise proceeded to use this information to conduct a phone campaign to slander me. She later credited Rockie as the source of this information. Rockie and Denise have been the driving force in perpetuating lies and accusations and it has gotten progressively worse. I sent you documentary evidence and witnesses, but it seems you have not seen them so I'm attaching them below for your convenience.

This group made several attempts to bully me into stepping down. Our former Coordinator Mark stepped down because due to his health he could not handle the stress this drama created. When the bullying didn't work, Rockie and Denise began a very public smear campaign against me and anyone who dared to question the way they were behaving. They managed to stir up a hornet's nest of anger against me by claiming that other states were getting funding from GFG but Nevada was not because of something I did or failed to do. They used the desperation of people suffering difficult financial situations to rally them against me. It's been really shocking to see people who don't even know me lying and slandering me and other members of the Assembly and equally as shocking that people blindly believe and accept the nasty accusations without seeking facts and evidence. Summary of the attempts the people on Nevada made to resolve these issues and allow for course correction based on direction from your articles:

1. In February of 2025, two Clark County Assembly Members brought a motion to temporarily suspend Rockie's accomplice, Denise Mraz and Clark County until issues on Clark County could be resolved. This motion passed with a 2/3rd vote, but Rockie and his supporters ignored the motion and responded by verbally bashing and spreading gossip about the Assembly Members who brought the motion forward and ramping up the accusations and attempts to bully me into stepping down as Coordinator.
2. On February 13, 2025, I contacted John Butruccio. John kindly agreed to help facilitate a solution to this conflict that benefits everyone involved. Unfortunately, Rockie's accomplice, Denise Mraz, posted inflammatory rhetoric about John on a public forum and when John tried to have a conversation with her, she refused. This created a conflict of interest, and unfortunately, John had to step aside.
3. In late February of 2025, Rockie was informed that he didn't pass vetting but was given simple course correction opportunities. He refused to course correct and proceeded to increase the verbal attacks. He shared his confidential vetting report with his followers on Clark County and then accused the vetting committee of slander. 4. In April of 2025, The Nevada Assembly Oversight Committee investigated allegations made by Rockie and Denise Mraz against Doug, our Marshal-at-Arms, and me. Rockie was given the opportunity to provide evidentiary support for the numerous and very serious accusations of crimes but failed to present any evidence. The Oversight Committee used article # 3374 to address the accusations and lack of evidence supporting them. Since no evidence was provided, the Oversight Committee determined that Rockie is a false witness and used the directions in Anna's article to deal with him. Instead of making any attempt to provide evidence, Rockie and his accomplices added Jill Horsley, our Oversight Committee Chairwoman, to their long list of fellow Assembly members whom they publicly verbally attack.
5. 6. In October and November of 2025, our Nevada Assembly Militia Commander sent a "Notice of Claims and Testimonial" to Rockie in an attempt to address some of the problems. Rockie failed to properly respond and stop the attacks against the Nevada Assembly. November 25, 2025, was the last day for Rockie to respond in kind. These un rebutted claims stand as truth under common law.

Clarification of some additional misconceptions:

1. Rockie claims he is peacefully building a "Union State" and trying to work with me.
  1. Then why did he send a notice to the entire State Assembly and post publicly on his website that you fired me and replaced me with him as Coordinator? In cooperation with his partner Denise, he sent two additional follow up demands for me to step down and immediately transfer all State emails and websites to his control.
  2. Why did Rockie set a second State Assembly business meeting (NOT Union State) on the same exact day and time in May of 2025 as the regularly scheduled State of the Union Business meeting?
  3. Why did he send an email to the Assembly stating that he will NOT work with me last month and then tell you on "Coordinator Training" that he is "trying" to work with me?
  4. Why does he send emails to the entire Assembly as "Coordinator" with the email address Nevadaassembly.gov.land?
  5. Why has he convinced his followers that I am a "de facto dependent" along with accusing me of numerous crimes including human trafficking, extortion, embezzlement, racketeering, etc?
  6. Why did Rockie tell Joe Hayes on a recorded call he is trying to "run The Nevada Assembly" because the "State Coordinator isn't doing her job" and then distribute the recording of that call to the entire Assembly?
  7. Why is the state Coordinator email being replaced on the LRO by Rockie's group with Rockie's email so I do not get notification when a new member is recorded and can't add them to the State email distribution list?
2. In a recent text conversation, you stated that the only time you hear from me is complaining about Rockie. I know you're overwhelmed by emails, but I've contacted you numerous times over the past several years since around 2016 on a variety of topics. From my point of view, the emails I've sent to you regarding Rockie, just like this one, have been an attempt to defend against specific attacks and allegations coming from Rockie. If you save emails in your archives, you can confirm that over the years I've sent you many emails, letters, and text messages of condolences, good wishes, requests to meet with the Nevada Assembly, birthday goodies, and many donations. I also sent you an email offering to help with transportation and accommodation for Harold when he traveled to Nevada for the med-bed.
3. Rockie claims that Mike and I are trying to "undermine" Rockie by calling a Union State meeting. Rockie has hosted numerous "Union State Meetings". As far as I am aware, he has never reached out to our Washoe County facilitator or any other county facilitators to attend the "Union State" meetings, except for maybe Nye, even though we currently have facilitators on 5 other counties. Since the Union State consists of all counties in a patchwork state, it seems that this is an attempt by Rockie to undermine the other counties and make unilateral decisions for the "Union State". Most of Rockie's "Union State" meetings have been focused on gossiping and slandering me to the point where his followers actually started to complain. He even took a vote to remove Doug and me from holding any Assembly position during one of his "Union State" meetings. Mike and the rest of the vetted and approved county facilitators are hosting the first "Union State" meeting where all county facilitators are included. Mike will invite Rockie to participate even though Rockie did not pass vetting and is not in good standing with The Nevada Assembly. Mike will attempt to work cooperatively with Rockie even though Rockie has demonstrated that he has no intention or desire to work cooperatively with anyone who doesn't step in line with his program without question.
4. You stated on a recent "Coordinator Training" call that I have done many things wrong. What have I done wrong? I'm definitely making plenty of mistakes as I learn and grow as a coordinator but what specifically were you referring to? I'm not asking to challenge this statement. I'm seeking clarification and an opportunity to learn, grow, and if necessary course correct.

For the benefit of our men and women on Nevada I respectfully request the following:

1. Ask Rockie to immediately retract the accusations against our Militia Commander and Militia Assembly publicly to help mitigate the potential problems these allegations can cause for the safety and security of our men and women.
2. Rockie should resign from any role on the Nevada Assembly until he is ready to course correct. He should demonstrate an ability to peacefully and productively work with his fellow Assembly members before being reinstated.
3. If he refuses to course correct, please take appropriate action to protect The Nevada Assembly and our members from further harm as described in your article "Wanted".

Anna, I appreciate your patience with Rockie and your attempt to help our Nevada Assembly by working with him and educating him. Rockie should have the opportunity to course correct but if he fails to do so, it is imperative that action is taken to protect the men and women on Nevada. I know you are incredibly busy and don't deserve this additional burden but if Rockie refuses to course correct and continues to claim that you have given him free reign to continue his pattern of destructive behavior, this is the only solution.
